## DESCRIPTION

Team Victoria is a collaborative community group including Vancouver Island Health Authority (VIHA) – Victoria General Hospital (VGH); Victoria Women's Sexual Assault Centre (VWSAC); Crown Counsel; and Policing agencies. Since 1997, VGH and VWSAC partnered in providing a Sexual Assault Response Team (SART), using a SART Protocol, with policing agencies following this protocol to ensure a coordinated and effective response for victims of sexual assault, within the Capital Regional District.

SART is a 24/7 response that provides victims of sexual assault with support at any point where they disclose their assault, i.e., through a crisis line, at the hospital or at a police station. At this point the SART Protocol is enacted by the personnel speaking with the victim in order to facilitate medical intervention, emotional support and/or justice support.

Through the VWSAC Support Workers, victims are provided emotional support, informed about their options (e.g., medical, justice and counselling assistance) and supported with information about the trauma response. Research has shown that such support immediately after an assault helps to mitigate the effects of trauma. Through the Forensic Nurse Examiners (FNE) at VGH, victims may be provided the following medical care; medication only, medical exam and/or forensic exam (with or without police reporting). Policing agencies further provide assistance to victims who wish to report the perpetrator, while recognizing the needs of the victim for timely medical and emotional support.

Through the Team Victoria approach, victims are supported with recognition that they must be empowered to make the choices that are best for them. Research also demonstrates that the subsequent outcomes are greater engagement with the criminal justice system, reduced levels of post-traumatic effects and greater accessing of follow-up medical and counselling services. VWSAC further provides follow-up services through: crisis counselling, Victim Services support and, potentially, longer term therapy while working collaboratively with the police, Crown Counsel and medical personnel to provide a comprehensive and consistent support service.

Training for the SART Volunteers is provided twice a year. SART volunteers receive 60 hours of training and the program trains approximately 30 SART volunteers per year. This is an intensive training process that covers information on the local SART Protocol and procedures, the effects of sexual trauma, information on the medical and legal systems, child protection issues and suicidal ideation. The training also focuses on skill development particularly in the areas of active listening, emotional support and crisis intervention. Before SART volunteers are accepted into training they must go through a comprehensive selection process, which includes an application, interview and reference check. SART training is, primarily, facilitated by the Coordinator of Volunteers, who works throughout the year to supervise volunteers, including additional practice sessions, and updates the training manual as necessary.

Policing agencies provide Roll-call training and/or New Recruit training to acquaint members with the SART Protocol and procedures when attending a sexual assault call. This ensures that all members are aware of the services VSAC and VGH offer and how to respond to a sexual assault, minimizing delays or confusion for victims. This process also increases trust and gives an opportunity for police and support workers to build greater understanding of each other's roles.
