**PURPOSE**: For **INFORMATION** for Mark Sieben,

Deputy Solicitor General, Ministry of Public Safety and Solicitor General.

**ISSUE:** Update on police activities in response to ongoing BC Wildfire situation

### SUMMARY:

 RCMP have opened their Division Emergency Operations Center (DEOC) and have liaison embedded in the PREOC located in the Kamloops region in response to the ongoing BC Wildfire situation.

- RCMP continues to have an Emergency Operations Center (EOC) in place to address the command for the Lytton Fire and resulting devastation.
- The area in and around the village of Lytton, including the adjacent Lytton First
  Nations community continue to be in a state of lockdown. This is due to the ongoing
  unsafe nature of the landscape due to the fire devastation. There is no timeline as
  to when it may be safe to allow limited visits into the site by non-first responder
  personnel.
- Police services for the larger Lytton area continue to be based out of the Lillooet Detachment and additional resources have been brought in to address this demand.
- Repeated requests from Media for access continue, however there is currently no way to allow such access, due to safety concerns.

- Police Services is part of the twice daily operational RCMP DEOC briefings and will be so during this wildfire season. The way the RCMP has addressed the immediate and ongoing demands resulting from the fires to date has been nothing short of exceptional. Their level of coordination and engagement with impacted communities and other first responders has clearly demonstrated their hard-won experiences from past years.
- RCMP have brought in additional FNPP resources to the Lytton area to support the demands for service.

## **BACKGROUND:**

- The following is an update on various police activities that are monitored by Policing and Security Branch (PSB):
  - The RCMP has their Gold/Silver/Bronze command in place and operating. This
    model has now seen the opening of their DEOC and resources deployed to
    ensure consistent police services available in the Lytton/Lillooet area into the
    next few weeks.
  - Recent access into the Lytton village fire site have seen the following occur.
    - The remains of the 2 known deceased have been removed by the Coroner Service and their cause of death investigation continues with the support of the RCMP.

- The areas in and around the Lytton village site, including the Lytton First Nations community, remain under police enforced lockdown.
- There is now a Missing Person investigative capacity to address any outstanding cases, which are fire related, where the police have been informed. To date there are no outstanding cases reported to the RCMP.
- Fire activities across the province continue to draw upon police resources to support
  evacuation orders and related activities. These have all proceeded very well and
  there are no immediate concerns in these areas, however it is understood there will
  need to be a scheduling of additional staff as the fire season continues.

## **DISCUSSION:**

 RCMP Accommodations staff and related PSB staff have already begun discussions related to the short- and long-term establishment for a police presence in the community of Lytton.

ISSUE: Declaration of a Provincial State of Emergency Related to Public

Safety Concerns with Wildfires

## BACKGROUND:

- As of July 20, there are approximately 300 active wildfires, 34 of which are classified as interface fires largely focussed in the Cariboo and Okanagan regions of the province.
- At present approximately 2,800 properties are on evacuation order and close to 16,000 properties on evacuation alert.
- The situation continues to deteriorate as a result of very dry conditions, sustained drought and a combination of higher than normal temperatures, and unsettled weather leading to new fire starts from lightning strikes and fire growth due to high/gusty winds.
- The fire danger rating is high to extreme throughout all of central and southern BC, including the Kootenays, and a large area of eastern Vancouver Island.
- The situation is particularly concerning given the early and devastating start to the wildfire season in late June with the fire in and around the Village of Lytton and adjacent reserves, and current conditions expected to persist for the foreseeable future through the remainder of the summer.
- Fire smoke continues to impact much of the southern interior as well the far northeast areas of the province and a Smoky Skies Bulletin was issued July 19 for a 24-48 hr time period. Southern Alberta has experienced the impact of BC wildfire smoke and a number air quality statements have also been issued.

## DISCUSSION:

- BC Wildfire Service (BCWS) and Emergency Management BC (EMBC) operations
  and advanced planning staff are recommending the Minister declare a provincial
  state of emergency to provide the authority to address a number of potential issues
  related to the wildfire situation and to ready the province for worsening conditions.
- Advice from both BCWS and EMBC staff to date has been that all necessary actions in regard to the wildfire situation can be accomplished without the use of the extraordinary powers provided within under a provincial state of emergency declared under the *Emergency Program Act* (EPA).

However, advanced planning for various scenarios has revealed the potential need
to secure the accommodation spaces necessary in the event of mass evacuations,
control/prohibit travel into impacted areas, and to have authority to establish a
provincial fire department that can draw on resources from any part of BC if needed.

### INDIGENOUS PEOPLES CONSIDERATIONS:

- First Nations leaders have expressed support for the Province declaring a state of emergency.
- The Province will continue to work with First Nations leadership and communities to address any needs related to the wildfire situation.

## **OPTIONS:**

Option 1: Declare a Provincial State of Emergency (Recommended)

- Declare a provincial State of Emergency by Ministerial Order under the authority of s. 9(1) of the EPA to apply to the whole of the province.
- Include authority for employees of EMBC, RCMP "E" Division and "local authorities" within the province as defined in the EPA, their employees, servants and agents, to be empowered pursuant to Section 10(1) of the EPA, to do all acts and implement all procedures that are considered necessary to prevent, respond to or alleviate the effects of the emergency.
- Make the effective date of the order to be 12:01AM July 21.
- The order largely mirrors similar declarations made in 2017 and 2018 related to wildfires.

**TO**: Mike Farnworth, Minister of Public Safety and Solicitor General

ISSUE: Financial Support for Lytton Fire Evacuees and Households Under Evacuation Order Delivered by the Canadian Red Cross

## **BACKGROUND:**

Emergency Management BC (EMBC) is proposing to have the Canadian Red Cross (CRC) provide one-time \$1,000 payments to each household impacted by the Lytton fire given its extraordinary impact.

Further, recognizing the possibility for evacuation orders over the remainder of the 2021 wildfire season the Province could consider engaging the CRC to provide payments to households displaced due to any evacuation orders lasting longer than 10 days.

## DISCUSSION:

- As of July 20<sup>th</sup>, there are approximately 300 active wildfires, 34 of which are classified as interface fires largely focussed in the Cariboo and Okanagan regions of the province. Approximately 2,800 properties are on evacuation order and close to 16,000 properties are on evacuation alert.
- A Provincial State of Emergency was declared effective July 21, 2021, based on the
  risks associated with the deteriorating conditions as a result of very dry conditions,
  sustained drought and a combination of higher than normal temperatures, and
  unsettled weather leading to new fire starts from lightning strikes and fire growth due
  to high/gusty winds.
- The Lytton fire and a related evacuation order is estimated to have impacted over 1,000 individuals. The Evacuee Registration Assistance tool indicates there are 488 individuals from the Lytton First Nation and 798 individuals from Lytton who registered for supports.
- The \$1,000 payment per household proposed for Lytton Fire Evacuees is intended as an immediate support while longer term plans are developed in collaboration with impacted communities. The payment will not impact recipient's eligibility for supports provided through the Emergency Support Services program.
- There were initial discussions with Canada about the potential to collaborate on the \$1,000 payments to households impacted by the Lytton fire. Canada has confirmed it does not intended to partner on this initiative.
- The purpose of the proposed \$600 payment is to provide rapid financial assistance to those who have had to evacuate their residence due to the evacuation orders to help alleviate the situation. This funding is not meant to cover all costs (such as gas,

food, lodging) incurred by people who had to evacuate their residence but is meant to help alleviate the impact and is in addition to the support provided through the Emergency Support Services program.

- EMBC notes, unlike the \$600 payments provided during the 2017 fire season, people who have evacuated while <u>not</u> under evacuation order will not be provided with a \$600 payment. This will ensure support is targeted towards those most significantly impacted by evacuation orders (i.e. for 10 days or more).
- The CRC will require recipients to register to receive these proposed payments.
   Recognizing the priority factors of speed and equity, financial assistance will be given at the household level (not individual) to all those who had to evacuate.
- To receive payment the primary registrant will need to both pass the CRC's identity authentication process and be evacuated from their primary place of residence due to an eligible evacuation order.
- Generally, a disaster relief payment that an individual receives from a government, municipality, or public authority for personal losses and expenses is not taxable and is not included in the recipient's income for income tax purposes.
- The CRC recommends making the \$600 one-time payment rather than being renewed every 14 days as was the case in 2017 as it was administratively challenging to administer. Further, for both programs, clearly communicating a time limited application window is also recommended (i.e. 30 days).
- The CRC has the capacity to provide these support payments in a culturally safe manner for impacted First Nations households.
- These payments are proposed to be funded through the approximately \$5.3 million in residual funding the CRC has from the Provincial funding provided to address the impacts of 2018 wildfires.
- The table below provides an estimate of the number of households projected to received support through the proposed payments recognizing administration costs incurred by the CRC to deliver the program would reduce this amount.

- Based on this analysis EMBC expects the residual funding from 2018 is sufficient to facilitate \$600 payments to household under evacuation order for longer than 10 days. In the event of significant additional wildfire activity, the Province could look to directing donation matching contributions towards support payment or provide additional contributions for this purpose.
- At this point, it is not clear to what extent the Province will rely on the CRC to support other emergent needs of evacuees during evacuations or their eventual return home or to what extent the CRC will apply donation funding from the public and the federal government towards such needs. Table 3 below provides a summary of programs the CRC has delivered in previous years.

 The funding agreement for the provincial donation match contribution will aim to direct funds towards the highest priority needs identified through engagement with impacted communities with the intent of addressing needs not met through provincial programs and those delivered by partners including the CRC and other organizations.

## **INDIGENOUS PEOPLES CONSIDERATIONS:**

- The Province committed to providing immediate funding for initial support directly to impacted households in its joint letter with the Government of Canada to First Nations impacted by the Lytton fire.
- EMBC has consulted with the Lytton First Nation and confirmed support for payments to eligible households. Further EMBC and the CRC will ensure the needs of vulnerable members of the population are addressed.
- This may include payments being provided to the First Nation Government for distribution where appropriate and providing the CRC with flexibility in the definition of a household as needed.
- Programming delivered by the CRC on behalf of the Province supports all impacted individuals including First Nations.

## **Issue:**

Tk'emlups RCMP Rural Detachment responded to a report of an uncontained 250 hector fire requiring nine tactical evacuations.

## **Background:**

- On June 29, 2021 Local Natural Resource Officers reported a 250 Hector file near Sparks Lake B.C.
- Fire fighters on the ground, helicopters and several fix wing planes are engaged fighting the fire.
- The source of the fire is believed to be from a vehicle parked on a private property (Unconfirmed).
- Inquiries are currently underway to determine the cause of the fire.
- TRND requested the assistance of the Tk'emlups Rural Detachment to attend Sparks Lake and issue nine evacuation notices.
- No structural damage, no injuries and no immediate risk to property at this time.

## **Current Status:**

- Tk'emlups has carriage of the file with Kamloops Detachment support.
- Evacuation notice are being served by three members.

## **Strategic Consideration:**

- TNRD EOC activated and engaged with Detachment providing evacuation orders.
- Kamloops SMT and Tk'emlups Detachment completed a briefing to identify evacuation plans and response.
- Preliminary Briefing with City of Kamloops Fire Chief and SMT due to under 50 km from Kamloops for necessary contingency planning but no EOC activation at this time.
- Security plans being established for evacuated properties and protection of property given 1.5 hours from Kamloops.

## **Strategic Communications:**

-Kamloops MRO is engaged for necessary support.

- -TNRD EOC activated and pending engagement with SAR for additional evacuation assistance.
- -One necessary checkpoint and communication being assessed.

## Members/Employee Wellness:

- Both members who attended the scene have been debriefed.
- Detachment Commander to monitor both members.

## **Conduct/Civil Risk Assessment:**

- No concerns at this time.

## **Detachment Commander Comments:**

- Investigation is well in hand with excellent response from members
- This investigation will remain with Tk'emlups Rural Detachment with oversight of NCO i/c, S/Sgt WALLACE and Ops/OIC engagement.
- Kamloops SMT has been engaged since onset and during briefing providing support.

Here is the morning update from the Kamloops – Sparks Lake Fire

- Fire grown over night to 2300 Hectares.
- High of 43 c and winds this afternoon
- Very small chance of shower, with the showers comes the risk of lightening.
- Due to heat, fire behaviour is unknown at this time
- Further evacuation orders are forthcoming. Due to the fire growth over night a total of 150 properties are now affected.
- BC wildfires are increasing their personnel
- One piece of heavy equipment was lost by BC wildfire personnel due fire behaviour as a result of winds changing directions late last evening.
- Concerns with air quality until which time fire is under control
- TRND will have an update with evacuation orders by 08:30 hrs today.
- TRND has no issues placing a member within their command center
- Skeetchestn FN is likely going to be affected.

## First Nation Response

- Skeetchestn First Nation is aware of the wildfire and have taken step to protect themselves.
- Tk'emlups IPS will be engaged with Skeetchestn leadership later this morning.
- Skeetchestn first nation population is approximately 270 living on reserve.

### Good afternoon;

At the request of ADM Wayne Rideout, I have been asked to lead a information dissemination process on behalf of PSSG, in relation to the BC wild fire activities and any actions by the police in response to the evolving situation. I wanted to inform you of the steps being taken to achieve a timely and accurate account of such activities and the development of a communications strategy that will allow for its sharing across a number of ministries at the determination of our Deputy Minister Mark Sieben, as required.

As there is already an approved and accepted process underway as it relates to the ongoing "civil unrest and protests" current being seen within BC, I will be mirroring this process and engaging with a number of the same information contact points to develop the information sharing process. This has been discussed with that PSSG lead, Exec. Director Brian Sims, and we agree this will provide the information is a manner already understood and accepted by multiple ministries. This process will see;

- My direct connection with RCMP staff leading and working on any police wildfire responses;
- My direct connection with the existing Critical Incident Secretariat at their weekly Monday morning sessions;
- Connection to the work of Norm McPhail as it relates to police actions and intelligence that may be related to possible fire related and protest concerns/intelligence;
- The use of the same IBN format used for the Police Direct Actions across the province.
- The use of a Contracts Team Analyst to create regular IBNs for our DM (as currently being done for the Protests), which will be reviewed and vetted by myself to ensure any police sensitive information is removed prior to advancement of material.
- My direct engagement with the RCMP Division Emergency Operations Center (DEOC) if "stood up" along with my connection to any Provincial Emergency Operations Center (PREOC) in the event one is also stood up.

\*\*\* I should note that in the event DEOC/PREOC is established, the connection with EMBC will be made to ensure there is no inconsistency with messaging and if required, a review of the proposed communications process will take place.

I have identified an analyst to assist me in this work and they will be returning to work Monday, as such time as the plan will be discussed and the work will begin. Until that time I will be preparing for the weeks ahead.

### 1. Provincial Summary

An unseasonably dry June and multiple days of record-breaking temperatures have resulted in an increase in wildfire activity in the Southern Interior and the northeast regions. There are currently 42 active fires, 30 of which were discovered in the past 24 hours. There are three fires of note, all within the Kamloops Fire Centre. Two Incident Management Teams are deployed. The majority of the province is exhibiting high to extreme Fire Danger Ratings. Fuels are very susceptible to ignition and new starts are challenging initial attack success due to ease of spread.

### 2. Weather (Current and Forecast)

Yesterday, 2,400 lightning strikes were detected, most of which occurred offshore. The ridge that has inflicted this unprecedented heatwave has shifted eastward with two lows developing in its wake, causing instability, and increasing the risk of thunder and lightning. Today, dry lightning is expected to begin north island and spread northeast towards Fort Nelson. Temperatures are expected to reach low 40s in the south and around 30 in the north. Relative humidity values are in the single digits, persisting into the evening for 100 Mile, Kamloops and much of the southeast. Thursday, up to 70km/hr winds will accompany thunderstorms, and the risk of dry lightning increases. Some widespread cooling will affect all regions excluding the southeast. Relative humidity values expected to increase. Come Friday and into the weekend, temperatures moderate to seasonal, averaging low to mid 30s. The drying trend continues across the province.

- Resource capacity is supplemented with staff from Wildfire TEAMS, other Ministries, the forest sector, Fire Departments, and type 2/3 resources

### Fire Stages of Control

**Out of Control:** A wildfire that is not responding – or only responding on a limited basis – to suppression action, such that the perimeter spread is not being contained.

**Being Held:** With the resources currently committed to the fire, sufficient suppression action has been taken so that the fire is not likely to spread beyond existing or predetermined boundaries under the prevailing and forecasted conditions.

Under Control: The fire has received enough suppression action to ensure no further spread of the fire.

Out: The fire has been extinguished.

### Fire Danger Rating


Low: Fires may start easily and spread quickly but there will be minimal involvement of deeper fuel layers or larger fuels.

Moderate: Forest fuels are drying and there is an increased risk of surface fires starting. Carry out any forest activities with caution.

**High:** Forest fuels are very dry and the fire risk is serious. New fires may start easily, burn vigorously, and challenge fire suppression efforts. Extreme caution must be used in any forest activities. Open burning and industrial activities may be restricted.

**Extreme:** Extremely dry forest fuels and the fire risk is very serious. New fires will start easily, spread rapidly, and challenge fire suppression efforts. General forest activities may be restricted, including open burning, industrial activities and campfires.

### Issue:

Tk'emlups RCMP Rural Detachment conducted multiple evacuation orders for 145 properties. TAC/Kamloops members deployed and additional support for alerts in Clinton Detachment area.

## **Background:**

- On June 29, 2021 Local Natural Resource Officers reported a wildfire near Sparks Lake B.C.
- The source of the fire is believed to be from a vehicle parked on a private property (Unconfirmed).
- On July 1<sup>st</sup>, 2020, the wildfire has expanded to approximately 20,000 hectares.
- -Wildfire currently has a deployment of 93 firefighters, 13 helicopters and 16 heavy equipment.

#### **Current Status:**

- -145 residences have been issued evacuation orders (2) and a region for an alert within Clinton Detachment area;
- -Support to Clinton Detachment by Kamloops SMT on facilitating evacuation alerts with the Acting Commander, Marika Masters.
- -Alert has occurred for Skeetchestn Reserve with IPS and S/Sgt Wallace engaged within this community EOC/Chief;
- -41 Elders have been tactically evacuated from Skeetchestn due to air quality.

#### **Strategic Considerations:**

- -Investigation is still underway and believed to be human cause from a vehicle;
- -MOTI has managed some check point alerts coming into remote areas;
- -Roving patrols for property protection and security aspects are being assessed with additional support due to police resourcing;
- -Approximately 25 properties still being canvassed on an order with access routes being assessed.

## **Strategic Communications:**

- -Briefing with TAC members and IPS members deployed to evacuation areas;
- -SMT engaged with EOC and receiving orders/alerts for dissemination and engagement of evacuation team;
- -SED EOC point of contact for additional resources given GD/TAC deployments to Lytton township wildfire.
- -Support from additional agencies sought where required.

## Member/Employee Wellness-Occupational Safety:

- -Monitored by Tk'emlups and Kamloops SMT with necessary equipment supplies;
- -Appropriate rest and debriefing with evacuation/GD/IPS members as required.

## Conduct/Civil Risk Assessment:

-One region was being assessed as it could not be accessed but alternate routes being engaged that do not compromise evacuation team safety.

## **Detachment/Unit Commander Comments:**

SMT from Kamloops engaged on this wildfire, deployment of evacuations and check point assessments due to District priority and fires in other areas. Further support form SED and DEOC will be sought as required but is being managed locally in partnership with Clinton Detachment.

**PURPOSE**: For **INFORMATION** for Mark Sieben,

Deputy Solicitor General, Ministry of Public Safety and Solicitor General.

**ISSUE:** Update on police activities in response to ongoing BC Wildfire situation

#### SUMMARY:

 RCMP continues to establish their Emergency Operation Centers (EOCs) in the Lytton/Lillooet areas.

- Police services for the larger Lytton area are currently being based out of the Lillooet Detachment, additional resources are being established to provide additional support.
- The current situation on the ground remains unsafe and there is currently no timeline regarding when access to the town may be available.
- Repeated requests from Media for access are unable to be accommodated at this time, due to safety concerns.
- RCMP Commanding Officer is preparing a written request for assistance and use of additional police resources, under PPSA Article 9 'Emergencies and Events'.
- Primary police activities remain focussed on the Lytton fire area with additional responses across other fire locations of Castlegar, Clinton/Logan Lake and Kamloops/Juniper areas.
- RCMP have direct contact with all 6 First Nation Communities around Lytton area as
  of last night. Additionally, Stl'atl'imx Tribal Police Service is engaged and supporting
  those communities and evacuees who are landing within their jurisdiction.

## **BACKGROUND:**

- The following is an update on various police activities that are monitored by Policing and Security Branch (PSB):
  - RCMP has established a local Emergency Operations Center in response to the Lytton area fires and those located in the Kamloops/Kelowna District.
     Additionally, they have implemented their internal Gold/Silver/Bronze Command model.
  - RCMP Divisional Emergency Operations Center (DEOC) has been stood up and liaisons established within the PREOC.
  - Two RCMP Fire Operations meetings are now occurring daily at 0900 and 1500 hours and Police Services Branch representatives are attending these going forward.

Date Prepared: July 2, 2021

 It is clear the RCMP has built on the experiences of past BC Wildfires from 2017 onward and have demonstrated an extremely professional and comprehensive response to the ongoing situation.

## Lytton Fire area

- This remains the primary concern for police activities at this time.
- Roadblocks continue and plans are being made to have Private security and officers working at these, in support of Ministry of Transportation and Infrastructure (MOTI), as the safety concerns diminish in the future. Use of Commissionaires is being prepared for.
- Police and Fire personnel conducted a very preliminary access into the Village of Lytton and it is was confirmed that it is still too unsafe to allow any access outside of first responders at this time.
- The repeated requests from media outlets are continuing but cannot be accommodated. It is understood that access by the displaced residents will need to be considered in advance of any media, and a plan for such access beyond first responders is being developed.
- Cellular service was returned to the Lytton area last night.
- Police mobile radio repeaters were brought in overnight and police communications have been re-established.
- Police resources/staff remain in good condition and plans for scheduled rotation of officers is well underway.
- There are plans to have a broader search of the impacted Lytton area, similar to the plans developed after the "Fort Mac" fires, to assess damages and determine any unknown fatalities. These will be implemented once the area is safe to access.
- There has been visual confirmation of two (2) two fatalities in the Lytton area, but
  due to safety concerns the identification of these persons cannot be determined at
  this time. The Coroners Service will be conducting the investigations regarding
  cause.
- RCMP have had direct contact with the six First Nation Communities in and around Lytton and are working to confirm the status of the residents who may be missing and/or evacuated and the damages to their communities.

 Investigational capacity to respond to missing person cases and related matters are being established.

- RCMP staff have all been accounted for and have supports established.
- It should be noted at a Lytton Detachment civilian employee, Lillian Graie, is the current interim Mayor of Lytton.

## Other police activities across BC

- Fire activities in the areas of Lillooet, Castlegar, Clinton/Logan Lake and Kamloops/Juniper have all required the use of RCMP officers to assist local fire resources in the evacuation or areas under order/evacuation. These have all proceeded very well and there are no immediate concerns in these areas.
- It is felt that this fire season is going to be protracted and the demands placed upon police to respond will be impacted across the province as a result.
- A planned protest caravan with took place on Canada Day in the Salmon Arm area failed to result in any serious police related demands.

## **DISCUSSION:**

 RCMP Accommodations staff and related PSB staff have already begun discussions related to the short- and long-term establishment for a police presence in the community of Lytton.

- The six First Nations communities in the Lytton area are; Cooks Ferry Indian Band, Kanaka Bar Indian Band, Lytton First Nation, Nicomen Indian Band, Siska Indian Band and the Skuppah Indian Band
- Many of these communities have developed response plans after the 2017 Wildfire season and are better prepared since that time.
- The RCMP has been very active in ensuring these communities and their demands are being considered along with all requests for police action.



#### **UPDATE #1:**

- Currently the Lytton fire (21-416) is properly resourced and have the supplies they need. The fire is still
  out of control and moving aggressively north along Highway 12 toward Lillooet. Two shifts have been
  established; with 16 day shift members and 10 members for night shift.
- Private security companies have been secured to assist with scene security and traffic control.
- IPS is fully engaged with Lytton First Nation leadership, and assisting where needed.

<sup>\*\*</sup>Still Unfolding Event – Preliminary information and is subject to change\*\*

- Evacuated members are being supported by member wellness teams, NPF and will be contacted by EDIV
   Staffing to discuss next steps regarding their postings.
- LMD TAC attended the Lytton Detachment to determine the feasibility of obtaining the detachment firearms. It was determined that the structure is unsafe for entry, due to hazards.

## STRATEGIC CONSIDERATIONS:

• According to the BC Wildfire Service, there are currently 146 active fires in the province and a total of 12 "wildfires of note" in the province:

## • Cariboo Fire Centre:

- Churn Creek (700 hectares) Discovered 21-07-02, caused by lightning. Interfaced with Thompson-Nicola Regional District. Evacuation alerts are in effect.
- North of Big Stick Lake (85 hectares), cause is under investigation. Interfaced with Cariboo Regional District. Evacuation alerts are in effect.
- South of Canim Lake (300 hectares) Discovered June 30, 2021, caused by lightning. Interfaced with Cariboo Regional District and Canim Lake First Nation. Evacuation alerts are in effect.
- SW of Deka Lake (300 hectares) Discovered June 30, 2021, caused by lightning. Interfaced with the Cariboo Regional District and 693 properties in the Deka Lake and 153 properties on Sulphurous Lake area have been issued an evacuation order.

## Prince George Fire Centre:

- o Chilako (700 hectares) Discovered July 1, 2021, caused by lighting and is not an interface fire.
- o Kennedy Siding (30 hectares) Discovered July 4, 2021, cause us unknown and is not an interface fire.
- o Murray FSR (700 hectares) Discovered July 1, 2021, caused by lightning and is not an interface fire.

## Kamloops Fire Centre:

- Durand Lake (120 hectares) Discovered July 1, 2021, caused by lightning. This fire is interfaced with Thompson- Nicola Regional District, and an evacuation order has been issued for several properties in the Copper Desert Country area.
- George Road (350 hectares) Discovered June 16, 2021, and is suspected to be human-caused, but is under investigation. This fire is 7km, south of Lytton, and is out of control. Previous evacuations have been rescinded.
- Lytton Creek (7,600 hectares) Discovered June 30, 2021, No known cause at this time. Interfaced with The Village of Lytton who has a full evacuation order, and the fire remains classified as out of control.
- McKay Creek (26,301 hectares) Discovered June 29, 2021, and is suspected to be human-caused, but is under investigation. This fire is interfaced with the Squamish-Lillooet Regional District, and is 23km north of Lillooet.
- Sparks Lake (36,300 hectares) Discovered on June 28, 2021, and the cause is under investigation. It is 15km north of Kamloops Lake and is classified as out of control. Evacuation orders are in effect for over 1000 properties, including the Skeetchestn Indian Band, which have implemented internal evacuations of their community.

### ISSUE:

A fast-moving wildfire, fuelled by high winds and Canada's highest historical recorded temperature (49.5 degrees), has destroyed the town of Lytton, BC, and with it the community's RCMP detachment and Ambulance Station.

#### **BACKGROUND:**

On 2021-06-30 at approx. 1530 hrs, a wildfire began in the town of Lytton. By 1652 hrs, multiple structures
and vehicles were on fire and residents began to evacuate. A large number of members from the
surrounding detachments and SED immediately attended the area to support the evacuation process, along
with resources from BC Conservation and CP Police. Initial reports are that 90 per cent of the town has been
consumed by fire.

#### **CURRENT STATUS:**

- The Lytton First Nations Klickkumcheen Reserve, which includes the Band Office, has been completely destroyed. The Klahkamich Reserve has suffered 20% damage. The former Lytton Detachment Commander remains in close contact with Chief MINNEBARRIET (Spences Bridge/Cooks Ferry) and Chief WEBSTER (Lytton First Nation). The Kanaka Bar, Siska and Skuppah reserves remain unevacuated.
- All RCMP employees that lived and worked in the community and their families are safe, and they are
  currently being housed at the Pacific Regional Training Centre. Their welfare, along with the ongoing
  wellbeing of the many members from SED, LMD and E Div HQ stood up to address the calamity, is a Division
  priority.
- On the morning of 21-07-03, SED investigative assets, including an Unmanned Aerial Vehicle, and in concert
  with the BC Coroners Service, will perform reconnaissance of the Lytton burn site with the specific goal of
  locating the bodies of two individuals reported deceased by a their son. This will be followed up with onground investigation, if the site is safe to approach. The cause of origin investigation will occur in parallel
  once the area becomes substantively safe for such an inquiry.
- DEOC has been activated to coordinate resource requests, logistics, deployments, and support services including employee wellness.

#### STRATEGIC CONSIDERATIONS:

- Numerous hazards are still preventing officers, and other from accessing the area en masse.
- Wireless (cellular) communications have been restored, and, through installation of a portable transmitter, police radio communications have been restored as well.
- A formal request for emergency funding under Article 9 of the PPSA is in its final drafting stages.
- The RCMP continues to work with a number of partners agency, including local First Nations, Emergency Management BC, the Red Cross and the Coroners Service.
- There are currently 152 active fires in the province with 68 new fires in the last 24 hours. According to the BC Wildfire Service, there are a total of 9 "wildfires of note" in the province:
  - **Sparks Lake** (30,000 hectares), northeast of Kamloops, northwest of Ashcroft; evacuation order is in effect.
  - McKay Creek (22,000 hectares), 23 kilometres north of Lillooet; evacuation order is in effect.
  - Lytton Creek (6,800 hectares), including the village of Lytton; evacuation order is in effect. Many members involved in this effort.
  - **Pink Mountain** (6,000 hectares), south of Fort Nelson; no interface with communities. The detachment is short staffed at this time, but several members are expected back from leave by the start of the week

- **Beatton River** (3,400 hectares), northwest of Fort St John; no interface with communities.
- **G91020** (3,000 hectares), north of Pink Mountain fire; no interface with communities.
- George Road (350 hectares), 7 kilometres south of Lytton; evacuation orders rescinded.
- **Deka Lake** (200 hectares), near 100 Mile House; evacuation order is in effect. 100 Mile House RCMP have transitioned to 24 hour coverage, with 2 NCOs on shift at any given time.
- Merry Creek (15 hectares), 8 kilometres southwest of Castlegar; some areas under evacuation alert.

#### STRATEGIC COMMUNICATIONS:

- The Lytton fire has been widely reported in national and international media.
- Communication coordination is being handled by E Division Communications, who is working EMBC, BC
   Wildfire Service and BC Coroners Service. An external statement was issued by the Commanding Officer on 2021-07-01. Media calls about RCMP actions and impacts are being handled by E Division Communications.

DEOC lead call at 0900 hrs provided the following updates.

- DEOC continues to develop a rotating schedule of resources to address the Lytton fire needs as well as those across the province. Releaseability continues to challenge these efforts.
- Generally the fire behaviour continues to change and currently the RCMP has been able to manage their demands across the province.
- There was a 1600 hrs call yesterday involving the CN/CP and the Lytton area FN communities, which by the RCMP position went well. The communities had opportunity to raise their concerns.
- Trains have begun moving through the Lytton area again, on the lines across the river, and not along the line currently being examined as a possible site of fire origin.
- Fire cause/origin investigation continues and it is anticipated the current RCMP investigational status will be discussed at tomorrows weekly RCMP/PSB Crops call.
- A/Insp. Patti Cook, Advisory NCO in SED will be attending the Lytton area in person today to ensure strong communications with the impacted FN communities continues going forward.


#### Good afternoon Wayne/Glen;

- Little in the way of any significant fire activity resulting in police pressures today.
- IPS engaged with Lytton area FN Communities as referenced in this morning's update. A meeting is taking place today at 1600 hrs.
- There was an update mentioning that there may be protest activities as a result of the return to train traffic within the area but no specifics to date.
- PSB received information that Stl'atl'imx Tribal Police Service (STPS) may be seeking police support to
  address their limited capacity to address the multiple fire and flood related situations within their
  jurisdiction. Such situations allow, under the BC Police Act, for assistance to be sought from other services.
   PSB working to provide STPS with options for consideration. RCMP DEOC was informed that such a request
  of the RCMP may be coming in the near future.
- The Lytton Village fire cause investigation continues.

#### **BACKGROUND:**

- On July 08, 2021 at approximately 15:23 hours, Elk Valley RCMPolice responded to a grass wildfire on Hwy 3/Hwy 93 near the Caithness Trailer Park in the Elko area, threatening the trailer park and surrounding area. An evacuation order was put into place by the Regional District of East Kootenay (RDEK).
- Approximately 53 trailers and 100 residents in the mobile home park.
- The Regional District of East Kootenay's South Country Fire Services (Elk and Jaffray Fire Departments) were already on scene and had set up a Command Post. Majority of the residences of the home park were swiftly and safely evacuated and sent to the Elko Community Hall,
- Elk Valley RCMPolice were on scene assisting with the evacuation of the mobile park and traffic control off Hwy 3
- BC Wildfire air and ground support on scene to control the fire behaviour. The initial attack crew were two helicopters bucketing and an air tanker making retardant drops.
- BC Ambulance on site to assist with those individuals requiring medical attention and or transport to the recreation centre/also set up a hydration site.
- Additional resources on site were Conservation and Natural Resources Officers

- BC Wildfire will be investigating the cause of the fire. Right now the fire danger in the South Country is very high.
- CP Rail Police on scene and assisted with scene control.
- At approximately 2100 hours, residences were allowed back into their homes at the mobile park.
- RDEK Information Officer was present to field any community concerns and by 21:00 hours, the evacuation order had been lifted as the fire was classified as being held.




Updates regarding police actions in response to BC Wild Fire activities as of 2021-07-13 @ 1330 hrs

- BC Wild Fire activities continue across the province with a number of Alerts and Evacuation Orders
  continuing. None of the current activities are exceeding the ability of the RCMP to respond to requests at
  this time. The concern continues to be the expected increase in fire activities in the coming weeks and the
  strain it will place on police resources. RCMP continues to develop schedules to ensure coverage and
  response for service can be continued going forward, across the province.
- Environmental Report continues to be developed and RCMP are being told it will be completed for Friday.
   This report will determine when general access to the Lytton and area site will be allowed. An example of issues they are addressing is propane tanks. These cannot be left in the area, and there are a number which remain intact throughout the site and may pose a hazard.
- TNRD is looking into the reduction of the perimeter they require to be maintained for their needs.
   Discussions as to what their expectations are on policing are taking place. There are concerns that the community may see police off the perimeter check points as leaving the area and this is not the case, rather a return to police responsibilities and allowing local government and TNRD to address their responsibilities.
   A communications strategy is being developed to address this concern.
  - o It is felt that the police requirements at these perimeter points will not be required as of Friday, but yet to be finalized.
- RCMP IPS continues to address FN Community concerns in the Lytton and surrounding area at this time.
- It was clarified to the RCMP that they have the approval to move on accessing additional resources under PPSA Article 9.1 and the follow up letter will be sent soon. The verbal approval already exists.
- Only current challenge facing police is related to establishing rotating schedule of resources and accommodation going forward to address the long term demands expected during the future fire season.

Throughout the night, 100 Mile House detachment was called into action by BC Wildfire to respond to significant developments with two fires in the 100 Mile House area.

The Flat Lake fire burning south of 100 Mile House was rapidly moving towards residence between 83 Mile and 70 Mile along Hwy 97 and is suspected to compromised vehicle traffic on Hwy 97 in that area. The fire moved 10 klm in 6 hours. Members have conducted tactical evacuations in the area since very early this morning. Hwy 97 expected to be closed down later this morning. MOTI engaged. Evacuation Orders expected this morning. Clinton detachment (SED) supporting efforts from the south side of fire.

The Canim Lake fire also moving toward residences south of Canim Lake and required tactical evacuations through the night. MOTI and Dawson Road service in the area shutting down the roads in the area, SAR engaged and assisting with evacuations. Evacuation Orders expected this morning.

Sufficient resources currently engaged, ND EOC engaged during the night and continue to monitor and support detachment. Other wildfire growth in the Anahim Lake area (Hwy 20) and Ft St James area in the past 24 hours will put significant pressure on ND resources as the week continues.

Advanced for situational awareness of pending Hwy closure and district pressures as these files continue to grow.

#### **ISSUE:**

-An interface fire deemed out of control (Tremont Crk. K21849) has grown to 780 hectares and is now only 8.5 kilometres from Ashcroft. Evacuation alerts have been issued to 50 residences in the Barnes Lake area to the SE of Ashcroft, but those are expected to turn to evacuation orders shortly, and the evacuation alerts to be significantly expanded.

#### **BACKGROUND:**

- On July 12<sup>th</sup>, 2021 a wildfire was spotted on Glossy Mountain. The fire was approximately 4.0 kms from Barnes Lake, BC, and 10 kms (adjusted since initial BN) from Ashcroft, BC. Wildfire BC advised the fire was less than a hectare in size and police assistance was not required.
- The fire is believed to have been caused by a lightning strike, quickly spreading due to the recent heat wave.
- On July 13, 2021 the wildfire had grown to 80 hectares. Fire was slowly moving NW toward YD Ranch Rd.

- A local state of emergency has been declared and TNRD requested the Ashcroft RCMP to issue evacuation alerts to 50 residences in the YD Ranch Rd. area to the Southeast of Ashcroft, BC.
- Ashcroft RCMP completed the evacuation alerts.
- Flames were visible from Ashcroft and local residents were gathering to watch as the flames spread across the mountain top. It is now approximately 8.5 kms SE of Ashcroft.
- The Tremont Creek fire has been consolidated with the Lytton Creek and George Road fires and BC Wildfire are referring to them as the Lytton Creek Complex sharing resources for fire response.

# **CURRENT STATUS:**

- The fire is currently classified as out of control and has crested the mountain and is heading down toward the Barnes Lake Rd. (approximately 2 kilometres away)
- -Winds are expected to pick up and the fire is in a continuous fuel zone.
- -The Tremont Fire Information Officer has just contacted the Ashcroft RCMP to provide a heads up that they will soon be recommending that the residences currently under evacuation alert be upgraded to an evacuation order, and they also will be recommending that TNRD expand the evacuation alert zone.

# STRATEGIC CONSIDERATIONS:

- -Clinton RCMP is currently taxed with their own evacuation orders and alerts and Ashcroft RCMP is currently covering priority calls for their area.
- Ashcroft RCMP do not have enough resources to complete the expected evacuation order/alerts in a timely manner as only five members are available which includes having to cover Ashcroft/Clinton for priority calls.
- SAR will be contacted to determine if they can assist with expected upcoming evacuation order.
- Ashcroft RCMP are also working with BC Highway Patrol to determine if they have available units to assist in an emergency situation. An unknown amount of IRSU members are apparently making their was toward Ashcroft to be in a position to assist if/when the order is issued.

# STRATEGIC COMMUNICATIONS:

- -Ashcroft RCMP has made attempts to contact Chief/Council for Oregon Jack IR who are in the area, but not part of the TNRD evacuation alert, however have been unable to contact anyone. TNRD has also made attempts to contact the Chief of Oregon Jack IR but have been unsuccessful as well.
- -Some media interest can be expected.

# **DETACHMENT COMMANDER COMMENTS:**

- -SAR was not utilized for evacuation alert notifications yesterday as there is no local SAR. Kamloops-based SAR likely already engaged and Ashcroft RCMP was able to complete the notifications in an timely manner, however they will be asked to assist with expected evacuation order as Ashcroft RCMP don't have enough resources on their own.
- -The majority of people affected were preparing to leave, and are using the Voyent Alert App, and monitoring the BC Wildfires website. A handful of people seem determined to stay if an order is issued. No mobility issues or significant challenges identified during alert notifications.


- BC wild fires continue to spread across SED and ND areas, with a number of known fires expanding due to weather and wind conditions.

- RCMP continue to respond to calls in support of Evacuation Alerts and Orders across the North District and South East District.
- Fire activity is described as unprecedented, with an extreme lack of moisture in the regions, the fire is actually creating its own weather and winds, resulting in an extremely unpredictable situation.

# **Southeast District Update**

- Merritt evacuation alert issued for White Rock Lake area; 5 homes in total;
- Lytton 9,200 hectares Opened Hwy 1 part of the time. Challenging part of fire is near the Nicomen First Nations Community;
- Ashcroft (Tremont Creek) substantial winds affecting fire, evacuation still in effect for 50 properties and evacuation alert expanded to 670 properties in Ashcroft and Cache Creek. Adequate resources in place from the detachment until Sunday;
- Okanagan Falls Thomas Creek Fire 5500 hectares evacuation alert issued for 704 properties.

### **North District Update**

- The entire town of 100 Mile House has been issued an evacuation alert, Hwy 97 has reopened;
- Flat Lake and Young Lake fires have grown together 10,000 hectares, 4.3km from Hwy 97, evacuation orders for 117 homes with additional 170 issued an evacuation alert, the fire was good last night, however the wind forecast tonight could create worsening conditions;
- Vanderhoof (Cutoff Creek) an evacuation order issued which includes the Saik'uz First Nation;
- Prince George (Grizzly Lake) evacuation order was issued for the area of Grizzly Lake and expanded to the Bobtail Connector, this includes the Umlisle 4

- Anahim Lake The use of the military Chinook went smooth and a "thank you" was received from the Band. Hwy 20 is officially opened with the use of a pilot car;
- Manson Creek evacuation order issued, two members attended to conduct door to door notifications.

**Indigenous Police Services (IPS):** IPS continues to liaise and assist with First Nations communities in the area.

**STRATEGIC CONSIDERATIONS:** There are currently 308 active wildfires in BC; 17 started in the past 24 hours. Div Comms continues to coordinate or lead Wildfire communications efforts for the Division.

RESOURCES: DEOC continues to liaise with LMD, TSG and to BCHP for the following resources:

- Clinton 4 resources are arriving today to begin deployment tomorrow;
- Lytton 8 resources arriving today;

# ISSUE:

A wildfire on Osoyoos Indian Band, Oliver, B.C.

# **BACKGROUND:**

On 2021-07-19 at 1550 hrs OIB advised of a grass fire on Nkmip Rd on OIB;

- Oliver Volunteer Fire Dept responded and fire located at South end of Nkmip Rd where approximately 30 residences and a campground were tactically evacuated due to proximity;
- BC Wildifire Services on scene immediately with ground crew and air support;
- Nkmip Rd at the south end is blocked to traffic at Road 22 by Osoyoos members;
- A suspicious vehicle was reported in area and checked by Osoyoos members and info obtained, not suspicious at this time;
- Orders and Alerts prepared by RDOS (Electoral Area C), OIB and the Town of Oliver
- SAR assisted RCMP with evacuations orders and alerts
- SMT member in EOC, Oliver NCO in IC with SAR

### **CURRENT STATUS**

- -Fire was very visible, with dense smoke covering the Valley after a tire fence several hundred metres long has caught and billowing black smoke, this has since dissipated;
- Winds have been and will continue to be very strong in area and fire is growing in size and out of control;

- Fortis BC has cut power to thousands of homes in Oliver and Osoyoos at the outset of the fire but have advised power has since been restored;
- -Area Commander has been engaged with OIB Chief for ongoing support
- -OIB is almost entirely on Order (approximately 170 properties)
- Evacuation Alert have been issued by the RDOS in Electoral Area C, D and the Town of Oliver for lands within the boundary of the town.
- Evacuation Orders have been issued by the RDOS in Electoral Area C, and H; SAR will continue to support issuing orders and alerts today;
- -Size as of 2130 hrs on 20210719 assessed at 700 ha, out of control
- NCO in Oliver staying on site in to early morning hours will be notified by EOC should further evacuation orders be put in place; grounds crews stayed overnight to support fire suppression
- SMT connected to EOC for real time information and updates;
- Emergency Reception set up at Oliver Legion
- Cause unknown at this time

#### STRATEGIC CONSIDERATIONS

- South Okanagan General Hospital adjacent to but not in the Evacuation Alert Area;
- South Okanagan Correctional Centre is approximately 7 Km north of the fire and is aware of the situation; SOCC advised the EOC last night they were considering pre-emptive movement of prisoners but this has not occurred as of yet

#### STRATEGIC COMMUNICATIONS

-This fire has garnered significant media attention most of which are being addressed through RDOS, Town of Oliver and OIB media

- RCMP continues to ramp up for extended wild fire season.
- CAF is within the SED area providing evac and fire fighting support.
- Lytton Evacuation Order has been amended and Hwy# 12 will be re-opened. Hwy #1 in the area remains closed but recommendation to open exists.
- As time of this writing MMF Office announced a BC wide State of Emergency effective at midnight tonight, as it relates to the wild fire threat.
- 100 Mile House continues under an Alert, however if the fire activities continue as predicted, this could change to an Order later today.

# **BACKGROUND:**

- July 18<sup>th</sup>, at 2130 the TNRD issued an evacuation order for the properties between 7820 8640 Douglas
   Lake Road from the EOC in Kamloops.
- · VNOD Rural members requested to assist with evacuation notices/orders.
- TNRD has a manned traffic barrier with personnel set at the Douglas Lake Rd / Hwy 97.
- TNRD also has a manned traffic at Back Rd / Hwy 97.
- · Fire continues in a North Western direction, toward Monte Lake Area.

# **CURRENT STATUS:**

Order has been expanded to include an additional 32 homes (45 total) in the Douglas Lake Rd and Back Rd area (within ~500 m of highway);

- Alert area has been expanded to include and additional 162 home (Monte Lake Area, Paxton Valley Area, and all remaining TNRD area to the East);
- · Wildfire had no suppression crews on site as of this afternoon and only a small crew of Structure Protection Personnel;
- Members held over from day shift are distributing new orders and alerts with additional help from 3 BCHP Falkland members assisting.
