Section 42 Liquor Control and Licensing Act Inspections

- 42 (1) For the purpose of the administration of this Act or the regulations, the general manager
- (a) require a licensee or permittee to produce records that are required under this Act or by the terms and conditions of a licence or permit to be kept by the licensee or permittee,
- (b) require a person to produce records that may contain information relating to goods or liquor transported or received for transport in British Columbia,
- (c) inspect one or more of the following:
- (i) records referred to in paragraphs (a) and (b);
- (ii) an establishment or event site and the operations carried on there;
- (iii) a person's premises that are used for the storage of liquor or ethyl alcohol and the operations carried on there:
- (iv) records found in an establishment, at an event site or on the premises referred to in subparagraph (iii), which records are associated with the operation of the establishment, event site or premises or are otherwise related to the inspection,
- (d) require a licensee or permittee to provide information relating to the inspection, and
- (e) require an employee or patron of, or a person retained by, a licensee or permittee to produce identification.
- (2) The general manager may remove the records referred to in subsection (1) for the purposes of inspection or making copies or extracts.
- (3) In conducting an inspection under subsection (1), the general manager
- (a) may
- (i) take samples of liquor for testing or analysis, or
- (ii) inspect and remove for inspection, or for the purposes of testing and analysis, other things found in an establishment, at an event site or on the premises referred to in subsection (1) (c) (iii), which other things are associated with the operation of the establishment, event site or premises or are otherwise related to the inspection,
- (b) must carry, and present on request, identification in a form the general manager establishes, and
- (c) may request and receive the assistance of a peace officer.
- (4) If the general manager retains records, removes records or things or takes a liquor sample, the general manager must
- (a) give a receipt for the records or things removed or the liquor samples taken, and
- (b) return the records or things removed within a reasonable time.



Dear Complainant,

The Liquor Control and Licensing Act and the Cannabis Control and Licensing Act allows the General Manager of the Liquor and Cannabis Regulation Branch (LCRB) to delegate responsibility for the regulation of compliance and enforcement matters to the Deputy General Manager (DGM) of the Compliance and Enforcement Division (C&E). In turn, the DGM delegates responsibility to manage complaints related to anything on the following list to a Regional Manager of C&E:

- liquor manufacturing in B.C. (including manufacturer onsite stores and service areas)
- private liquor retail sales (liquor stores, wine stores)
- hospitality liquor sales (bars, pubs, nightclubs, restaurants)
- liquor sales at special events held under a special event permit, and
- · private non-medical cannabis retail sales

I acknowledge your complaint against Joey Burnaby Grill Lounge (212968) at 107 - 1899 Rosser Ave BURNABY V5C3Z1 received on May 20, 2022. Within your complaint you allege contraventions against the following:

• The service of liquor to minors.

Your complaint has been assigned to a Liquor and Cannabis Inspector who may contact you for further information. Regarding your complaint, the LCRB will determine either that:

- There is not enough evidence to prove a contravention
- A contravention has occurred, but it is appropriate to deal with through compliance meetings with the licensee or permittee, and recording details in the establishment's file at the LCRB; or
- A contravention has occurred and the LCRB will take enforcement action against the licensee or permittee in which case they have the right to sign a waiver accepting responsibility or dispute the alleged contravention at a hearing.

The LCRB operates under administrative law and can only release information related to investigations or enforcement action if a waiver is signed or a decision is made at a hearing. This ensures privacy of those involved, administrative fairness to the licensee or permittee, and the integrity of the compliance and enforcement process. Either way, you will be informed when the investigation into your complaint has concluded.
