### Discovery – Accommodation Subsidy Form

The BC Responsible and Problem Gambling Program (RPGP) is committed to ensuring that any eligible client in the RPGP program can attend Discovery without distance or financial obstacles. While Discovery is offered free of charge, participants are expected to arrange their own transportation, accommodation, and meals. The intake counsellor may negotiate an accommodation subsidy for out-of-town participants with financial barriers, taking into account the participant's financial situation.

#### Accommodation Subsidy Request:

Room and taxes for one person only is covered. The client is responsible for all incidental room charges including phone charges, long distance calls, mini bar, pay per view movies, and room service charges. The client must pay all extra charges, such as room cleaning or repairs. Clients may not bring pets.

In order to be reimbursed, clients must provide contact information, and be willing to confirm reimbursement if contacted by auditors. All information provided is confidential, and may only be used by professional auditors contracted by the Program to conduct quality assurance audits. Clients may contact RPGP management with any concerns.

### Discovery – Client Expense Subsidy Agreement

The BC Responsible and Problem Gambling Program (RPGP) is committed to ensuring that any eligible client in the RPGP program can attend Discovery without distance or financial obstacles. If the client occurs room service charges, the client agrees to settle these charges upon checkout.
