Frontline officers attended and were able to assist in getting the fire under control.

We received an inquiry from a Fraser Valley ICBC customer who says her stolen vehicle insurance claim was denied because ICBC has accused her of engaging in fraud.

Hilary 'Kat' Patterson claims her 2015 Jeep Cherokee was stolen from her building parkade in Hope, BC at 6am on April 22, 2022, in a theft captured on several surveillance cameras. Patterson reported the theft to RCMP(Police file #2022-13752) and filed a claim with ICBC (ICBC claim number BZ68586-4). Patterson's vehicle was recovered a week later at a homeless camp in Hope. Patterson says the jeep's muffler had been damaged by cutting and she suspects someone mistook it for the catalytic converter. Her catalytic converter is up inside the engine block, and she says the engine was significantly damaged. Patterson says ICBC kept her vehicle for two months before returning it to her parkade on a flatbed truck. The vehicle is no longer driveable.

ICBC she says, denied her claim, stating her jeep was not in good working order at the time of the theft. Patterson disputes this, claiming her jeep was reliable. She says it never stalled and never broke down while driving, there were no loud sounds, smells, and no oil or fluid leaks in her parking spot. Patterson relied on the vehicle to care for her two daughters and her aging mother, who was diagnosed with leukemia at the start of the pandemic. Patterson regularly transports her mother to oncology appointments in Burnaby.

Patterson says ICBC alleged she committed fraudulent acts prior to the theft, which she denies, claiming she loved her jeep and would never put her family at risk by driving a vehicle that was not in good mechanical condition. She says she is being denied coverage because she has been wrongfully accused of fraud. Patterson says she is still forced to pay insurance on a vehicle that cannot be driven and has not been sent a \$3,000 bill for the ICBC investigation with no breakdown of costs. She has also been notified that she will not be able to have comprehensive insurance coverage for three years.

We would like to hear ICBC's side of this – what happened and is there evidence fraud was committed by Patterson? Or has she been wrongfully accused? Please let us know. Patterson's contact details are below and I can send you the surveillance videos she has sent us but I assume you already have them.
