CLAYTON Dear Mr. Pecknold:

I am writing to update you on a recent decision on the methodology to be used to allocate new Cadets from Depot to Divisions. When demand exceeds Cadet production, a review will occur and new Cadets will be posted to Divisions based on operational requirements. The review will also consider vacancies, affordability, officer safety and PSA requirements.

The immediate objective is to address the greatest need first, balanced with equitable cadet distribution amongst all Divisions. A target of 5% vacancy has been used for the initial assessment which shows that based on affordability, the majority of new Cadets will be posted to BC, Alberta and Saskatchewan for the remainder of this fiscal year. To meet future cadet needs, we have directed an increase to our recruiting and intake at Depot.

#### Dear Deputy Commissioner Strachan:

I am writing to you in response to the latest Divisional RM Demand Attestation for "E" Division. This reiterates many of the issues outlined in my correspondence from January 23, 2020. As the Commanding Officer I recognize that you are expected to validate and attest to the accuracy of the RM Demand numbers for "E" Division after consulting with your contracting partners. I am unable to support the numbers as presented and have grave concerns with not only the numbers provided to attest to, but the data and methodology that continues to be used to calculate these numbers.

I understand the revised methodology is using three sources of finance-based data. This new methodology does not accurately account for the positions the Province has funded and how vacancies in the Division are reported. This RCMP National versus E Division discrepancy highlights the disconnect in accurately reporting RM Demand. The numbers shown for E Division indicate zero growth despite the fact this is known to be inaccurate. These inaccuracies are magnified in determining cadet allocations given the current Deport production is known to be below the demand.

In addition to the methodology issues, in order for the province to fully comprehend the numbers and participate in a meaningful way in the attestation process, the Contract Policing numbers need to be separated out by Municipal and Provincial business line. Furthermore, the RM Demand model needs to account for the administrative ("soft") vacancies that continue to cause significant pressure on front line resources.

I am disappointed the Working Group (WG), originally established under the Governance and Strategic Issues Standing Committee, tasked with collaborating on RM Demand models was not involved in the development of the revised methodology. I understand the WG is being resurrected in an effort to advance discussions and develop a mutually agreeable and reliable model for resource planning.

I look forward to hearing the results of the discussions of the WG in the coming months.

Premier Eby takes action to keep people, communities safe

VANCOUVER - The Province is making changes to help keep British Columbians safe, launching a new Safer Communities Action Plan with immediate steps that will strengthen enforcement to keep those who commit repeat violent offences off our streets, and strengthen services to build safe, healthy communities for everyone.

The new measures respond to a rise in repeat violent offending linked to unintended impacts of federal law changes and subsequent Supreme Court decisions, and increased mental-health and addiction challenges brought on by the COVID-19 pandemic and the toxic drug crisis.

"Being compassionate, concerned and taking action on mental-health and addiction issues does not mean that we have to accept repeated criminal behaviour or violence," said Premier David Eby. "Everyone deserves to feel safe in their community. We are making changes to bring key groups together to keep people and communities safe - ensuring those who commit violent acts face consequences, and creating as many opportunities as possible for them to address mental-health and addiction issues to break the cycle of a life in and out of jail."

The Safer Communities Action Plan lays out concrete steps at the provincial level to make communities safer under two tracks: enforcement, and intervention services. Each initiative is structured to improve co-ordination between law enforcement, community service organizations, justice system actors, health providers and people who are recovering from addiction and mental-health challenges in a collaborative, co-ordinated approach to address the issues people are seeing in their communities.

New measures announced include:

- \* launching new repeat violent offender co-ordinated response teams, made up of police, and dedicated prosecutors and probation officers;
- \* expanding mental-health crisis response teams into more communities so police can focus on crime, and people in crisis are met early on by health-care workers and community members;
- \* taking the next steps in creating a new model of addictions care at St. Paul's Hospital so people can seamlessly move from crisis response in the emergency room, to detox, to treatment services, in partnership with Vancouver Coastal Health and Providence Health Care, with plans to expand this model in the future;
- \* opening 10 new Indigenous Justice Centres to provide culturally appropriate support for Indigenous Peoples involved in the justice system to address the root causes of their involvement in the system and help them break the cycle;
- \* going after the houses, cars and luxury goods of high-level organized criminals who profit on misery by introducing "unexplained wealth order" legislation in spring 2023; and
- \* building public confidence in the prosecution system with new direction from the attorney general to prosecutors to implement a clear and understandable approach to bail for repeat violent offenders within the existing federal law. The new policy will take effect on Nov. 22, 2022.

The plan includes other co-ordination measures, such as better support for people with acquired brain injuries through overdose or other injury - with a focus on those involved in the criminal justice system - through increased funding for the Brain Injury Alliance, more integrated information sharing between justice and community partners to strengthen case management and expanding the use of technology to guide police in gathering, and sharing information with doctors and nurses during mental-health crisis situations.

These actions align with recommendations from a number of reports on community safety, including the Special Committee on Reforming the Police Act, the First Nations Justice Strategy and the Investigation into Repeat Offending and Random Stranger Violence.

The Safer Communities Action Plan complements the B.C.-led action with other provinces and territories to pressure the federal government to address the consequences of changes to the federal bail system that have made it more difficult to hold people who commit repeat, violent offences in custody while they are waiting for trial.

The action plan also builds on work already underway by the provincial government to help break the cycle of repeat offending and build safe and healthy communities, including complex-care housing, new and expanded community transition teams to better support people who are leaving correctional facilities, and funding to support work by the BC First Nations Justice Council to develop better, culturally appropriate supports for Indigenous people in the legal system.

Since 2017, the government has taken steps to make B.C. communities safer by taking action to stop the money laundering and organized crime that fuels the toxic drug crisis, providing resources to police, reversing cuts to sexual assault centres, increasing crime prevention and victim support services funding, and record investments in housing, mental health and poverty reduction.

- \* The LePard-Butler investigation into repeat offending and violent stranger attacks' 28 recommendations were released on Sept. 21, 2022, and the full report was made public on Oct. 1, 2022.
- \* The recommendations cover several areas, including:
- \* improving the system of care for people in the criminal justice system with mental-health and substance-use challenges;
- \* creating more opportunities to divert people from the criminal justice system;
- \* improving services for Indigenous Peoples;
- \* improving collaboration between partners, including community services, law enforcement, and all levels of government; and
- \* addressing repeat offending and improving public confidence in the justice system.

#### **BACKGROUNDER 2**

New measures to strengthen enforcement and keep people safe

New repeat violent offender response teams

The Province is standing up new co-ordinated multi-agency regional teams that will work together to stop violent crime before it starts. Comprised of police officers, as well as 21 dedicated prosecutors, 21 probation officers, 21 support personnel and nine correctional supervisors, the teams will:

- \* monitor high-risk repeat offender cases through the criminal justice system;
- \* conduct investigations;
- \* share information to keep repeat violent offenders in custody before trial;
- \* use that information for sentencing once a conviction has been entered;
- \* promote rehabilitation through referrals to appropriate services;
- \* identify crime trends; and
- \* ensure information sharing across regions to help prevent repeat offending.

These collaborative teams are a new and improved version of B.C.'s Prolific Offender Management program. The former program, which ran from 2008 until 2012, and until it was defunded, had some success bringing together community partners such as police, mental-health and community support service providers to monitor and help offenders break the cycle of repeat offending.

#### HealthIM

HealthIM is a digital public safety system designed to improve emergency police response in mental-health and substance-use situations. It is a tool that increases safety for both the first responder and the person in crisis. The app guides police officers, who are first to respond, through questions to help them understand the behaviour of the person in crisis. It can help to facilitate better assessments and faster emergency room admissions because police and clinicians are using the same language and police have the information doctors and nurses need at hand immediately.

Crown prosecutor training and enhanced bail briefs

Training for Crown counsel on bail practices related to repeat violent offending is already underway and additional training will continue to cover new initiatives and reforms. In addition, Crown counsel and police will work together to ensure bail briefs are complete and prepared in accordance with best practices. This means that Crown counsel will always have the best information from police to present to the court, maximizing the ability of the court to make decisions that protect the public.

#### Virtual bail

To support timely, effective bail hearings that will protect the public and meet constitutional obligations, the Province is investing more than \$3 million per year to expand virtual bail hearings throughout B.C. By reducing the need for accused people to travel to larger centres, virtual bail hearings minimize the risk that alleged offenders will be transported hundreds of kilometres from

home and get stuck, homeless, in a hub city like Terrace, Trail, Prince George, Williams Lake, Nanaimo, Kelowna, Kamloops or Campbell River. Instead, they can stay in their home communities and access existing supports, family and friends.

# Information-sharing agreement

Co-ordination of information is key in responding to people who re-offend regularly, regardless of the nature of the crime. A new information-sharing agreement within existing privacy rules will remove barriers that can prevent prosecutors, police and social service providers from sharing information that is helpful to the work each is doing. Allowing different agencies to disclose information will reduce the duplication of resources and provide more efficient and effective case management and justice outcomes.

A steering committee will be set up to guide this work. Membership includes:

- \* BC Corrections;
- \* BC Prosecution Service;
- \* Correctional Service of Canada;
- \* Vancouver Police Department;
- \* RCMP;
- \* Ministry of Social Development and Poverty Reduction;
- \* the Community Safety and Crime Prevention Branch of Public Safety and Solicitor General (PSSG); and
- \* the Policing and Security Branch of PSSG.

# Unexplained wealth orders

Young people are attracted to gang life by images of fast cars, fancy homes and luxury goods. By seizing this property from high-level, predatory criminal organizations and individuals, the Province can take away this incentive and send a clear message to organized crime. One of the key recommendations of the Cullen Commission of Inquiry into Money Laundering in British Columbia supported by an opinion from a former Justice of the Supreme Court of Canada, "unexplained wealth order" laws will break new ground nationally in Canada and build on lessons learned from other jurisdictions like the United Kingdom.

Legislation on unexplained wealth orders will be introduced during the spring 2023 legislative session.

Clear and understandable approach to prosecution policy for repeat violent offenders

On Nov. 16, 2022, Attorney General Murray Rankin issued a directive to the BC Prosecution Service (BCPS) to amend their bail policy to help improve public confidence in the justice system in communities throughout B.C. through amendments to bail policy that are clear and understandable in the situation of repeat violent offenders. The revised policy will give the public

confidence that prosecutors will always address, to the full extent possible under the law, the risk that repeat violent offenders pose to public safety in British Columbia, especially in relation to the decision to seek pre-trial detention of people who commit repeat violent offences. It will be implemented on Tuesday, Nov. 22, 2022.

#### BACKGROUNDER 3

Strengthening services to build safe, healthy communities for everyone

Peer Assisted Care Teams (PACTs)

As a key action of the Safer Communities Action Plan and strengthening supports for people, the Province will be expanding civilian-led teams of trained peers and mental-health professionals, like social workers and psychiatric nurses, to provide trauma informed, culturally safe support for people in crisis. A total of 12 PACTs will be created, including some that are Indigenous-led teams.

Care teams made up of mental-health professionals and peer workers respond to calls related to feelings of hopelessness or despair, social isolation, loneliness, fear, anxiety, thoughts of self-harm and suicide, substance use or other mental-health challenges.

Responses range from crisis counselling and de-escalation to advocating for the person in distress and connecting them to appropriate resources and services. The teams can respond instead of police, but can also work alongside police and other responders depending on the situation.

# Expanding car programs

In every region of the province, there are specialized mobile crisis-response units that partner an officer with a health-care worker to respond to mental-health calls.

These units, or Cars, are partnerships between local law enforcement or RCMP and the regional health authorities. To expand this program, the Province is establishing a new \$3-million fund for integrated mobile community crisis response by police and health-care workers in communities throughout B.C. An application process will be established for communities to apply for funding.

# Current Car programs include:

- \* Vancouver Coastal Health (VCH): Car 87/88 (Vancouver), Car 22 (North Shore), Fox 80 (Richmond)
- \* Fraser Health: Car 67 (Surrey)
- \* Interior Health: Car 40 (Kamloops), Police and Crisis Response Team (PACT) (Kelowna)

- \* Northern Health: Car 60 (Prince George and Fort St. John), Northwest Specialized Response Team (Terrace)
- \* Island Health: Integrated Mobile Crisis Response Team (Capital region)
- \* Car 22 is a new partnership between VCH and the RCMP, Integrated First Nations Unit (IFNU) of the RCMP and the West Vancouver Police Department.

# More Indigenous justice centres

Indigenous justice centres are operated by the BC First Nations Justice Council and support the shared commitment to addressing the over-representation of Indigenous Peoples in the criminal justice system, which has its roots in long-standing systemic racism and the impacts of intergenerational trauma. The centres offer culturally appropriate information, advice, support, and representation for Indigenous Peoples, and are focused on intervening to stop the risk of repeated interactions with the legal system for Indigenous people in the province.

There are currently three in-person Indigenous justice centres open in Merritt, Prince George and Prince Rupert, and one virtual Indigenous justice centre. The services help to identify and address the root causes of the actions of individuals in the criminal justice system to help prevent future negative interactions with police and the justice system.

To further improve access to culturally appropriate legal services for Indigenous Peoples, the Province is funding 10 additional centres. Five are set to open next year. To better support Indigenous Peoples in urban areas, the first five centres will open in metropolitan areas.

# Increasing addictions treatment care

To help streamline access and fill gaps between services for people living with addiction challenges, the Province is working with St. Paul's Clinical Addiction Program, along with Providence Health Care and Vancouver Coastal Health to develop a model of addiction care that will improve access for British Columbians to treatment services. St. Paul's Hospital houses the largest interdepartmental Division of Addiction in the country and is internationally recognized.

The LePard-Butler report emphasized the need to improve access to addictions treatment services. Since 2017, the government has been working to transform mental-health and substance-use services in B.C. through historic investments across the full spectrum of treatment and recovery. Over the past five years, the Province has added 340 new substance-use beds throughout B.C., for a total of 3,272 publicly funded adult and youth community substance use beds.

# Expanded funding for brain injury services

A dramatic increase in brain injuries due to the overdose crisis has led to reports from across the province of increased disorder and repeat hospitalizations and arrests of people living with acquired brain injuries. Regardless of the cause, but with a focus on people at risk of or actively involved in the criminal justice system, new funding will ensure British Columbians living with brain injuries will have increased access to important services, including life skills, behaviour coaching, support

groups, and more. The Province is investing \$4.5 million over three years to the Brain Injury Alliance to support delivery of these services in 13 communities throughout B.C.

The Alliance, a non-profit organization comprised of 13 community brain-injury societies in B.C., helps more than 4,000 people each year learn how to live with the changes and challenges they face after injury, including those resulting from toxic drug poisoning. Alliance members are community associations that run rehabilitative programs and services, including in BC Corrections facilities, individual support such as life-skills assistance, and homelessness prevention and group services, such as drop-in sessions.

BACKGROUNDER 4 Building on B.C.'s progress

These new initiatives build on the programs, services and initiatives the Province has undertaken or implemented to strengthen enforcement to break the cycle of violence and crime, and to strengthen services to keep communities safe and healthy.

# Civil forfeiture proceeds

Since 2017-18, government has provided over \$38 million in grant funding to organizations in B.C. to prevent and reduce crime through the Civil Forfeiture Crime Prevention and Remediation Grant Program.

The Civil Forfeiture Grant Program undermines the profit motive behind criminal activity by taking away tools and proceeds of crime and putting them back into programs that support community safety and crime prevention. The program provides annual, one-time funding to organizations throughout B.C. for the implementation of crime prevention and remediation projects.

#### Situation Tables

To improve information sharing between health care, justice and Indigenous partners, government is currently funding 17 Situation Tables in communities around the province. Situation Tables bring together front-line staff from the public safety, health and social service sectors to identify high-risk individuals and collaboratively and rapidly connect them to services and supports they need, before they experience a negative or traumatic event (e.g., victimization, overdose, incarceration, eviction, etc.). Situation Tables empower agencies to work together to provide holistic supports to people and lower the risk of potential violence or re-offending.

# Combating gang activites

The Province has a multi-pronged, comprehensive gun and gang strategy that involves focused and sustained initiatives over several years. In addition to standard and ongoing base-budget funding for

dedicated investigative and enforcement teams, the Province has provided dedicated funding for a suite of innovative initiatives, including, but not limited to:

- \* creating a provincial witness security program (WSP);
- \* establishing a B.C. crime gun intelligence and investigation group (CGIIG);
- \* enhancing/expanding the B.C. Combined Forces Special Enforcement Unit's (CFSEU-BC) Gang Intervention and Exiting Program (GIEP);
- \* enhancing forensic firearms laboratory analysis and certification capabilities; and
- \* providing dedicated funding to law enforcement operations focused on disrupting priority targets involved in trafficking in illegal firearms and harmful drugs (i.e., PTEP).

The newly created BC Witness Security Unit has resulted in 419 charges laid, including 134 murder charges (including attempt and accessory) and 77 firearm-related charges. Convictions of 32 accused has resulted in a cumulative total of 276 years in prison. These convictions have amounted to an estimated cost savings of over \$74 million to the province.

In addition to targeted enforcement, the Province funds the Gang Exiting and Outreach Program, which helps high-risk, gang-entrenched youth and adults leave a life of crime.

Supporting victims, preventing violence and discrimination

Government supports a range of services to support victims of domestic violence and sexual violence. This includes over 160 community and police-based victim service programs, which provide emotional support, information, referrals and practical assistance to victims of crime and trauma throughout B.C. In addition, this year more than \$4.1 million is being awarded to projects that prevent human trafficking, gender-based violence, and violence against children and youth.

Government is also taking action to meet the ongoing demand for services such as counselling, outreach and crisis support for women and children who experience domestic violence, sexual assault and other crimes, investing \$5 million starting in 2018-19 with an additional increase of \$3 million in 2020-21, for a total increase of \$8 million annually.

The Victim Court Support Program assists victims through the justice process by co-ordinating between victim service and justice system personnel (e.g., Crown).

The Crime Victim Assistance Program (CVAP) provides financial benefits to assist victims, immediate family members, and witnesses in dealing with the effects of violent crime. CVAP helps to offset financial loss and aid recovery from the impacts of crime.

VictimLink BC also provides information and referral services for all victims of crime and immediate crisis support to victims of family and sexual violence.

Complex care housing

Complex care housing supports people living with complex mental-health and substance-use challenges who are at risk of homelessness. The program works to address the needs of people who have overlapping mental-health and substance-use issues, trauma or acquired brain injuries that are often left to experience homelessness or at risk of eviction. Government is investing \$164 million in this program to provide 500 new spaces.

# Community transition teams

More people are getting mental-health and substance-use support when leaving correctional centres as B.C. creates new and expanded services for those at risk.

The Province has created Community Transition Teams to offer support services for people leaving all 10 provincial correctional centres. The teams help people with a safe and successful transition back into the community during a very vulnerable period in their life to break the cycle of reoffending. The teams connect people to lifesaving services, including mental-health and substance-use supports, for up to 90 days following their release.

The teams include social workers, nurses, peer support workers and Indigenous patient navigators, and a centralized hub to support specialized clinical and co-ordination needs throughout the province.

Funding for a restorative justice pilot program at the Prince George Indigenous Justice Centre

One of the recommendations from "A Rapid Investigation into Repeat Offending and Random Stranger Violence in British Columbia" was to fund a restorative justice pilot program in Prince George. This recommendation was put forward by the BC First Nations Justice Council and endorsed by LePard and Butler, co-authors of the report.

The Province has provided \$100,000 to the Prince George Indigenous Justice Centre for this program which aims to reduce criminal recidivism amongst Indigenous Peoples.

Restorative processes are voluntary and provide opportunities to victims, offenders and communities affected by a crime to communicate about the causes, circumstances and impact of the crime. The program will include a path to care and treatment while providing supports to reverse the current outcomes by promoting diversion and will utilize restorative justice approaches.

- In May 2019, to continue momentum from discussion at the December CMC meeting, RCMP Divisional and National Headquarters (NHQ) staff, B.C. provincial Ministry staff and PSC met in an effort to gain a mutual understanding of terminology/definitions and discuss how to advance the methodology to reflect the reality and resourcing needs in contract jurisdictions.
- As of 2021, the RCMP is piloting a new methodology to calculate RM demand to address vacancy rates and resource allocation across all jurisdictions.
- While B.C. continues to work with the RCMP to determine accurate vacancy data to inform national recruiting and cadet allocation, the Province continues to disagree with current reporting of vacancy data by RCMP NHQ as is it does not accurately reflect the reality at the divisional, detachment level, and resourcing needs in B.C., both in provincial and municipal contract jurisdictions.

#### MAJOR CORPORATE ISSUE NOTE

Ministry/Ministries: Public Safety and Solicitor General

Issue: Cullen Commission recommendations under purview of the Policing and Security Branch (PSB)

#### Background:

On June 3rd, 2022, Commissioner Austin Cullen submitted the Cullen Commission's final report
to the Province with 101 recommendations. PSB has identified 11 recommendations that fall
within its mandate. The most significant of these recommendations calls for the creation of an
AML team within the Organized Crime Agency of BC (OCABC).

#### Issue/Opportunity:

- Addressing Money Laundering effectively will require dedicated staff resources, funding for a
  new enforcement unit and training related to AML. Detailed planning and extensive consultation
  with partners and stakeholders will be needed to implement these changes.
- Three themes have been identified with regards to law enforcement in the Cullen recommendations: (1) Law Enforcement Resources, (2) Policy, Standards and Training and (3) Performance and Evaluation / Return on Investment.

#### Law Enforcement Resources

- The Cullen report recommended the creation of a dedicated provincial money laundering intelligence and investigation unit ("the Unit") to lead the law enforcement response to money laundering in BC that is fully funded by the Province.
- Critical to this recommendation is the establishment of the Unit within OCABC funded at 100 percent by the Province as opposed to through the 70/30 cost sharing agreement under the Provincial Police Services Agreement (PPSA). The Commissioner reviewed the checkered history of AML/proceeds of crime units within the RCMP including a 2018 business case that suggested locating a new unit within the RCMP, noted the failure of the federal government to properly resource these areas and concluded that the RCMP should not be given sole control of the Unit.
- Instead, the Commissioner recommended that the Province assume a greater degree of responsibility and control by placing the Unit within OCABC as opposed to the RCMP for the following reasons:
  - It provides PSB greater visibility into the Unit's operations because the CFSEU/OCABC Board of Governance reports to the BC Solicitor General;
  - It avoids compounding the ongoing vacancy issues within the RCMP Provincial Force; and provides the Province greater flexibility to hire and retain police and civilian experts in the AML field.

#### Policies, Standards and Training

Enhanced training and policies for law enforcement are recommended to encourage
consideration of money laundering and proceeds of crime issues at the outset of an
investigation. This includes implementing policies and training requiring all officers involved in in
the investigation of profit-oriented crime to consider money laundering, proceeds of crime and
asset forfeiture issues at the outset of a file.

#### Performance and Evaluation

 Three recommendations related to law enforcement relate to overseeing the return on investment and performance management. PSB is currently engaged with E Division – Federal, Investigative Services and Organized Crime (FISOC) to determine appropriate metrics.

#### Province invests in specialized, rural police services

VICTORIA – The Province is taking action to deliver stronger public safety services to protect people in urban, rural, and remote communities across B.C. through new funding that will help specialized units and rural police forces staff up and help keep streets safer for everyone.

As part of the Safer Communities Action Plan, the Province is enhancing investments in core police funding that will sustain and strengthen enforcement and crime prevention capacity throughout British Columbia.

The funding will ensure adequate and effective levels of policing and law enforcement, particularly in rural, remote and Indigenous communities, and in a wide variety of specialized teams that investigate and prevent complex, violent and organized crimes. The funding will also provide support to prosecutors and probation officers with respect to violent, high-risk offenders.

"Everyone deserves to feel safe, and my government is working on every front to protect our communities and make them stronger," said Premier David Eby. "As part of our Safer Communities Action Plan, we will help ensure that the RCMP can operate to its full capability to keep people safe. The actions today will help stabilize policing and provide our provincial police force with the staff resources they need to address public safety concerns head on."

Through an investment of \$230 million over three years, the Province will tackle key public safety issues, including:

- filling long-standing vacancies in rural police detachments in communities of less than 5,000 people;
- allowing provincially funded regional RCMP units to reach their fully authorized staffing levels of 2,602 officers;
- hiring additional officers in specialized units, such as the major crimes section, the sexual
  exploitation of children unit, and the BC Highway Patrol. These units serve rural and
  urban communities throughout the province and can help alleviate some work of
  municipal police forces, freeing them up to focus on other crime; and
- creating a strong foundation to address anti-money-laundering recommendations from the Cullen Commission.

Staffing up these units will improve public safety by increasing the overall capacity of homicide and missing persons investigations where foul play is suspected, and deterring the causes of motor vehicle fatalities, such as speeding, distracted driving and impairment.

"This historic commitment to invest in core RCMP police funding is a massive undertaking that took two years to achieve," said Mike Farnworth, Minister of Public Safety and Solicitor

General. "Sustained core funding will provide a strong foundation for police resources, enabling the police to focus on violent crimes and other pressing public safety issues, while also actioning the implementation of the Safer Communities Action Plan and other public safety initiatives."

Since 2017, government has taken steps to prevent money laundering and organized crime that fuels the toxic drug crisis by providing resources to police, reversing cuts to sexual assault centres, increasing crime prevention and victim support services funding, and making record investments in housing, mental health and poverty reduction.

#### **Quick Facts:**

- The Safer Communities Action Plan lays out concrete steps at the provincial level to make communities safer under two tracks; enforcement and intervention services.
- The plan improves co-ordination between law enforcement, community service
  organizations, justice system actors, health providers and people who are recovering
  from addiction and mental-health challenges in a collaborative, co-ordinated approach to
  address the issues people are seeing in their communities.
- The Safer Communities Action Plan also includes:
  - launching new repeat violent offender co-ordinated response teams, made up of police, dedicated prosecutors and probation officers;
  - expanding mental-health crisis response teams into more communities, so police can focus on crime and people in crisis are met early by health-care workers and community members; and
  - building public confidence in the prosecution system with new direction from the attorney general to prosecutors to implement a clear and understandable approach to bail for repeat violent offenders within the existing federal law.

## **Key Messages:**

#### QA:

## 1. How will this funding enhance public safety?

- We're working to make sure the police have all the resources they need to uphold public safety and protect communities from repeat violent offenders.
- This historic investment of \$230 million over three years will help the BC RCMP hire more officers, fill gaps in staffing and reach its full capacity of 2,602 officers.
- This funding will be the bedrock for sustaining and expanding police capacity for years to come.
- The new hires will help sustain and expand current enforcement and prevention capacity and help ensure people who commit violent offences face consequences for their crimes.
- Filling current job vacancies, and adding more police officers to B.C. communities, will improve public safety, now and in the future.
- More police officers will make a real difference on the ground:
  - o the public will benefit from safer communities; and
  - police will be able to maximize their effectiveness, enhance public safety, and reduce risks to officer safety.

## 2. How will this funding help advance the Safer Communities Action Plan?

- The Safer Communities Action Plan bolsters enforcement to keep those who commit repeat violent offences off our streets, and strengthens services to build safe, healthy communities for everyone.
- Core funding of the BC RCMP will support police officers serving on specialized teams that investigate and liaise with Crown and probation officers on violent high-risk offenders.
- With this funding for more police hires, and the Safer Communities Action Plan's
  measures that help connect violent repeat offenders with the supports they need,
  police will be able to focus more effectively on violent crimes and other pressing
  public safety issues.

### 3. How will the funding be broken down?

- We are investing \$230 million over three years:
  - \$194 million for core BC RCMP funding
  - \$36 million to lead a consistent, integrated and impartially administered police response to unlawful protests and public order events across the province.

## 4. Why is the Province only taking action now to hire more police?

- The Ministry of Public Safety and Solicitor General (PSSG) is aware of the frontline resourcing pressures on the BC RCMP, and has been working for years with the RCMP to address these issues.
- PSSG has undertaken a thorough analysis on the current state of policing and how we can increase the budget to ensure the provincial police will be capable of operating to its full capability.
- This historic commitment to invest in core RCMP police funding is a significant undertaking that took two years to achieve.
- In 2019, PSSG invested funds to enable the RCMP to augment resources (by 40 Regular Member [RM] positions) at highest-needs Provincial Detachment Units.
- In 2021, PSSG again invested funds to enable the RCMP to create new positions (10 RM positions and 3.5 support staff) at highest-needs Provincial Detachment Units.
- Today's funding builds on those previous investments, providing a foundation for developing and expanding police capacity throughout B.C. now and for years to come.
- PSSG continues to work with the RCMP, and internally to government, to address front-line resourcing.

## 5. This funding supports the BC RCMP. Will communities with municipal police forces also benefit?

- Absolutely. This enhanced funding will allow more RCMP officers to be hired and serve with specialized units that benefit municipalities, such as the Major Crimes Section and the BC Highway Patrol.
- Staffing up these units will improve public safety by increasing the overall capacity of homicide and missing persons investigations where foul play is suspected, and deterring the causes of motor vehicle fatalities, including speeding, distracted driving and impairment.
- Municipal and Indigenous governments in BC have consistently raised concerns regarding provincial policing resourcing levels.

## 6. How are you addressing concerns of over-policing of Indigenous and racialized communities?

- It is critical that we continuously and actively work to combat racism in all its forms especially within our institutions that are expected to keep people safe.
- The Special Committee on Reforming the Police Act heard from many communities about how to best ensure public safety for everyone.
- This includes submissions from Indigenous leaders highlighting the need for adequate, stable policing services in their communities.
- By better supporting specialized units and filling vacancies in rural areas, we are alleviating pressure across the system to help law enforcement be more responsive to the people they serve.

## 7. How will this funding help support the Integrated Homicide Investigation Team (IHIT) and gang-related investigations?

- Over the past five years, the Province has provided unprecedented funding and program support to combat gangs and organized crime – on average approximately \$90M/year in federal and provincial funding.
- One area we know can help to disrupt and quell the violence we see on the streets is to put the shooters behind bars for years.
- We have developed a made in BC Witness Security Program, our own firearms lab which provide much needed support to investigations and prosecutions.
- Gang homicides by their very nature are complex and challenging files to bring charges on.
- IHIT is the gold standard of homicide investigation in Canada. It is an RCMP led integrated unit with top notch investigators from our Lower Mainland police forces.
- This funding will help support IHIT to tackle its issues.

# 8. Surrey City Council voted to halt the transition to Surrey Police Services and keep the RCMP as its police force. What happens now?

- It's the responsibility of the Ministry of Public Safety and Solicitor General to
  ensure the City of Surrey's policing plan meets the requirements of the Police
  Act, and that it continues to provide safe and effective policing.
- The City of Surrey must now put forward a transition plan that deals with all the components of reversing the transition, including addressing human resources issues, the capital plan, and the financial cost of the reversal.
- We also expect that the plan would be made public for the citizens of Surrey, so that they are aware of how the process will unfold.
- We understand that the City is working to have its plan to the Province by the
  end of the month. Any plan would be reviewed by the Director of Police Services
  and Minister Farnworth to ensure adequate and effective policing is maintained in
  Surrey, and across the province.
- As always, public safety continues to be the core driving principle for all decisions and timelines related to policing in Surrey, and throughout the province.

# 9. Does this significant increase to RCMP budgets mean the government is supportive of Surrey's "de-transition" away from the Surrey Police Service?

- These two issues are completely unrelated.
- A city the size of Surrey has the responsibility to pay for its own policing services, whether that be through a municipal police force or through a contract with the RCMP.
- This investment supported the rural and regional provincial-funded RCMP detachments for unincorporated areas and communities with populations of under 5,000.

- The jurisdictions served by the Provincial Police Service include the vast majority of First Nations lands and Indigenous communities in British Columbia, many in rural and remote areas.
- In recent years, the Ministry has consistently heard concerns about the level of provincial police resources and the impact of vacancies on RCMP service delivery from local governments and Indigenous governments in correspondence, and at the Union of British Columbia Municipalities, and the First Nations Leadership Gathering.

EB43 Rural Policing Salmon Arm

Whereas public safety is of equal concern to both municipal and regional district residents; And whereas rural populations are growing steadily;

And whereas provincial policing compliments have not been increased at the same rate as municipally funded positions;

And whereas lack of police resources affects rural safety and is putting a strain on municipal budgets:

Therefore be it resolved that UBCM request that the province increase the provincially funded positions immediately;

And be it further resolved that future resource allocations accurately reflect the rural demands for policing services.

## **RESPONSE: Ministry of Public Safety and Solicitor General**

The ministry has heard the concerns from local governments and is aware of the pressures facing front-line Provincial Service resources. In both 2019 and 2021, the ministry worked to secure new additional funds to the BC RCMP to augment provincial front-line resources. With limited funding available, the Province and RCMP prioritized Provincial Detachment Units identified as the highest risk and highest needs based on assessment of a variety of considerations including police workload, crime statistics, and contextual factors. Both initiatives also saw creation and augmentation of the Provincial Support Team which provides mobile, short-term relief to Provincial Detachment Units experiencing temporary resourcing pressures such as those resulting from vacancies, emergent incidents or events.

The ministry also continues to work with the RCMP, and internally to government, to address resource pressures across all areas of provincial policing responsibility in the province. This work includes addressing equity and accountability issues across municipal and provincial policing responsibilities, at integrated RCMP municipal/provincial detachments in particular, adequately accounting for Provincial Police Service resources that provide service to multiple jurisdictions and ensuring that provincial resources level is commensurate with the workload generated by provincial areas.

On April 28, 2022, the Special Committee on Reforming the *Police Act* released its report and recommendations. Creating a fair and equitable shared funding model for municipalities is recommendation #6 in the report. The report recommends reviewing the funding model and considering local needs and geography of the service delivery area. The ministry has carefully reviewed and analysed the report and will take a phased approach in responding to the recommendations and will also undertake broader engagement to meaningfully address the Special Committee's recommendations.
