I have attached a final report that was released without fanfare last March into accusations from an RCMP officer that were not dealt with in 2006 when she made them. Her allegations that her husband, also a Mountie and other officers were like convicted, imprisoned and now dead provincial court judge David Ramsay,

- I'd like to know if the government received the report and if iso what was its response? If not, same question what was the reaction?
- I'd like to know the minister's response to reading the report and the length of time and the RCMP's foot-dragging to avoid scrutiny?
- What role did the government play after the reports from First Nations teens they were being preyed upon by members of the Prince George legal community, including law enforcement?
- Did the criminal justice branch advise the Mounties at any point or do its own review of these concerns at the time or in the intervening years.
- Did the government express concern, take any specific actions to address or determine why the force took so long
   — three years conducting the initial investigation of complaints from young women in the city of sexual
   offences committed against them through 1992-2001, the conflict-of-interest the force had investigating itself
   given the gravity of the charges against its members? The failure of the force to bring any criminal charges against
   anyone else except Ramsay?
- Was there any or will there be any action taken against the senior RCMP officers who seemingly referred to a non-existent legal opinion, were willfully blind for over a decade to the need for a proper investigation into both the crimes and RCMP members?

- How does the government intend or how did it address the failure of the civilian review system both the force's internal discipline mechanisms for dealing with officer misconduct as well as the obfuscation and procrastination that occurred handicapping the civilian complaints procedures and oversight?

We acknowledge that due to the criminal investigation, internal Codes of Conduct, civil litigations and our response to the CRCC recommendations, the RCMP has not been in a position to publically disclose the scope and complexity of work that has taken place to address these very concerning allegations. However, we have recently reviewed our investigation to determine what further actions could be taken and if the information being publicly reported aligns with previous investigative findings and reviews.

Notwithstanding our internal review, in order to ensure transparency, accountability and public confidence in the RCMP response, Deputy Commissioner Dwayne McDonald, Commanding Officer of the BC RCMP, s.13

The RCMP is committed to fully cooperate in this endeavour and will provide the independent agency with complete access to investigative holdings, the findings of the Special Prosecutor, and any subsequent reviews and assessments dating back to June 2004, when the investigation was undertaken by the E Division Major Crimes Unit, and designated Project E-Prevails.

## Minister's statement on independent Investigation into Prince George RCMP

VICTORIA – Mike Farnworth, Minister of Public Safety and Solicitor General, has released the following statement about the independent investigation into Prince George RCMP:

"The allegations of historic misconduct of members in Prince George are disturbing, and our government takes these allegations very seriously.

"The Civilian Review and Complaints Commission (CRCC) issued an interim report to the RCMP Commissioner outlining the failure of the RCMP to take action to address these complaints. The RCMP Commissioner agreed with the CRCC's findings and recommendations.

"While this report is directed at the RCMP, I have spoken to my federal counterpart, Minister Mendicino about these serious allegations and BC's Director of Police Services has ordered an independent investigation by an external agency into these allegations. [5.13]

"Prior to announcing the investigation, the Director of Police Services undertook direct conversations with family members who have called for reforms and to the Assembly of First Nations Regional Chief to inform them of his decision.

"Our government is resolute in its commitment to ending systemic violence against Indigenous women, girls, 2SLGBTQ+ people, particularly in Northern BC, and | the cases which involve the police. I recognize the wisdom, advocacy and ongoing action of family members, survivors, community leaders and partners. Their ongoing dedication to identifying and acting to prevent, protect and respond to violence against Indigenous women, girls and 2SLGBTQ+ peoples has had an immeasurable impact on all British Columbians.

"The lead agency for this independent investigation is the Alberta Serious Incident Response Team (ASIRT)."

"As this is now an active investigation, no further comment will be made"
