Trainer, s.22 upon receipt of a report from Bureau Veritas Canada (2019) Inc. (Official Chemists), that a blood sample taken from the horse, s.22, which finished third in the first race on August 29, 2022 at Hastings Racecourse, Vancouver, B.C., tested positive for s.22

The Stewards find that:

1. Trainer, s.22 had care and control of the horse s.22
2. A search of s.22 stable area, tack rooms, feed rooms, and vehicle, was conducted and nothing out of the ordinary was found during the search.
3. s.22 testified and stated that he has no explanation or evidence as to why the horse s.22 tested positive for s.22
4. s.22 as Trainer, is held responsible for the condition of the horses under his care.
5. As a result of these findings and pursuant to Rule 15a(3)(a)(b), the horse s.22 is disqualified and the purse money re-distributed as follows:


First – s.22
Second – s.22
Third – s.22
Fourth – s.22
Fifth –
6. This disqualification in no way affects the pari-mutuel payout.
7. Having concluded this investigation, s.22 is held liable under Rule 71(1) of the Rules of Thoroughbred Horse Racing in British Columbia.


Pursuant to Rule 16(1)(c) of the Rules of Thoroughbred Horse Racing in British Columbia and having considered the circumstances involved, Trainer, s.22 is fined the sum of One Thousand Two Hundred Fifty (\$1,250.00) Dollars.






