Survivors are encouraged to contact the sexual assault program, crisis lines or general victim services programs, for support as well as to seek medical attention, whether or not they want to report to police. The decision to report to the police or not may be made at a later date.

Both the sexual assault programs and the new policing standards will be guided by victim-centred, trauma-informed, inclusive, and culturally safe approaches. They will be key components of B.C.'s Action Plan to address gender-based violence, which is being developed in partnership with Indigenous organizations, an advisory committee, experts, and advocates.

The funding for sexual assault services programs will begin in July 2023, and the new policing standards will take effect in 2024 to allow time for police to implement the requirements.

- Provincial standards set requirements for all British Columbia's police agencies to promote best practices, accountability, and consistency.
- Between March 2020 and March 2021, the Province provided \$20 million for the multiyear Emergency Sexual Assault Services grant program to support the delivery of emergency sexual assault services throughout B.C until March 2023.

#### KMs:

- Sexualized violence is deeply traumatic and has devastating effects on survivors, families, and communities.
- Sexual assaults predominately affect women, girls and gender diverse people.
- Indigenous and other racialized women and girls, 2SLGBTQIA+ people, sex workers, people with disabilities, and individuals experiencing poverty or homelessness have higher rates of victimization.
- Furthermore, many survivors experience barriers to reporting sexual assaults, including not being believed, victim-blaming or distrust of the criminal justice system.
- That's why the Province is providing stable funding for sexual assault services and implementing new policing standards on responding to sexual assaults that will respect and support the diverse needs of survivors and make investigations more effective.
- A total of \$10 million will be distributed across the province for the delivery of coordinated, community-based Sexual Assault Services (SAS) programs.
- Survivors are encouraged to contact the sexual assault program, crisis lines or general victim services programs, for support as well as to seek medical attention, whether or not they want to report to police. The decision to report to the police or not may be made at a later date.
- Both the specialized sexual assault services and the new policing standards will be guided by victim-centred, trauma-informed, inclusive, and culturally safe approaches.
- It is crucial that the public has confidence that policing throughout British
  Columbia is high-quality and unbiased, and that there is consistent guidance for
  police agencies to respond to the needs of vulnerable and marginalized groups.
- Everyone deserves to be treated fairly by the justice system, and these new standards will complement existing government work and other standards and training required to improve police responses and ensure unbiased policing. This includes police training on trauma-informed practice, investigations of intimate partner violence, fair and impartial policing, and Indigenous cultural safety.

#### QAs:

#### SAS Funding/Procurement

#### 1. Who will benefit from the funding?

 This initial procurement establishes 68 SAS programs operated by 56 organizations in all regions of the province.

- Stable, annual funding will help ensure service providers are able to focus on providing care people need without having to reapply each year.
- Ending violence, supporting safety, and creating security are central to our work as government.
- It's essential that people who have been sexually assaulted have immediate access to program services, counselling, and support.

#### 2. How many organizations will receive funding?

- 56 organizations will receive funding for the delivery of 68 new SAS programs. Contracts are effective July 1, 2023.
- There are 68 individual contracts.
- There are a total of 56 service providers (agencies) that are receiving contracts, with some receiving more than one contract.
- On a regional basis (listed below) there are 58 service providers because some service providers have a contract in more than one region.

#### 3. How was it determined who would receive the funding?

- Throughout the past year, the Ministry of Public Safety and Solicitor General (Ministry) initiated a rigorous engagement and a fair, open, and transparent procurement process via BC Bid.
- The successful organizations were chosen based on demonstrated ability to meet the local needs of survivors in their community and establish and deliver a SAS program that is coordinated, culturally safe, client centred, and trauma informed through either direct support, counselling services or both.

## 4. Why were some organizations that previously received funding not successful this time?

- Some organizations that previously received ESAS grants did not submit an application for the SAS program or the respondents were not the highest scoring for their service area.
- Five organizations that received an ESAS grant did not receive a SAS contract.
- 5. What about programs that are not successful in getting this new, stable funding? What if a program received funding via the Emergency Sexual Assault Services grant program administered by Ending Violence Association of BC (EVA BC) and then was not successful in the procurement process? Won't that create a disruption of services in the community?
  - The majority (46 of 53) of ESAS grant program recipients were successful in the procurement process and have been invited to enter into a SAS contract.
  - The Ministry has worked with EVA BC to ensure a smooth transition between the end of the ESAS grant projects and the completion of the procurement process to award contracts for the new ongoing SAS Program. Bridge funding has been provided to all ESAS grant agencies that requested it.
  - Further, ESAS grant recipients who did not apply for ongoing SAS
    program funding, or who were not successful in the procurement, will have
    the ability to use any surplus ESAS grant funds, or apply to the Ministry for
    funding to wind-down their projects and transition any clients to the new
    ongoing SAS programs in a trauma-informed way.
  - With the addition of the \$10M in new funding, we will now be providing over \$54 million annually in funding to support over 470 victim service, violence against women and sexual assault program services across the province.

#### 6. How will this funding help Indigenous survivors of sexual assaults?

- All sexual assault program services will be culturally appropriate.
- In areas with high Indigenous populations, the ministry sought to procure Indigenous focused programs. In total, 17 Indigenous focused programs were successful in the SAS procurement process and have been invited to enter into a SAS contract.

#### 7. How does this funding support B.C.'s Gender Based Violence Action Plan?

 We are committed to preventing and ending gender-based violence, and to supporting survivors, families and communities impacted by its devastating effects.

- A provincial action plan to help end gender-based violence, support survivors and promote healing, community awareness and prevention is being developed by the Ministry and the Parliamentary Secretary for Gender Equity.
- We are also partnering with Indigenous organizations, an advisory committee, experts and advocates to create the plan.
- Both the specialized sexual assault services and the new policing standards will be key components of the plan.

#### 8. What is the total funding amount for gender-based violence services

- Budget 2022 allocated stable annual funding of \$10 million for communitybased sexual assault services to support victims of sexual and genderbased violence starting in 2023/24.
- The Province now provides over \$54 million annually in stable funding for services and programs to support victims of crime, including over 470 victim service, violence against women and sexual assault programs operating in communities across BC.
- Between March 2020 and March 2021, \$20 million was provided for a multi-year ESAS grant program, administered by EVA BC, to support the delivery of coordinated, community-based sexual assault response services throughout the province until March 2023.

## 9. Why was no funding for sexual assault service providers provided in 2022/23?

- Sexual assault service providers currently have funding via the ESAS grant program that runs until the end of March 2023.
- This new stable, annual SAS funding will start July 1, 2023. The Ministry
  has worked with EVA BC to ensure a smooth transition between the end of
  the ESAS grant projects and the completion of the procurement process to
  award contracts for the new ongoing SAS Program. Bridge funding has
  been provided to all ESAS grant agencies that requested it.

## 10. Existing victim service and violence against women programs have waitlists and need to fundraise to provide needed services. Why is there no additional funding for them?

- We recognize the devastating impacts of violence on survivors, families, and communities, which is why we are choosing to provide stable, annual funding for SAS programs.
- Stable funding will improve supports for survivors and help ensure they have immediate access to medical services, counselling, and support.
- The Province now provides over \$54 million annually in stable funding for services and programs to support victims of crime, including over 470 victim service, violence against women and sexual assault programs operating in communities across BC.

- All existing victim service and violence against women programs will receive funding lifts as part of government's Shared Recovery Mandate (SRM).
- Under the <u>Shared Recovery Mandate</u>, existing programs will also receive a compensation funding lift totaling 17.04% over the agreement term (April 1, 2022 to March 31, 2025).

#### Policing standards on responding to sexual assaults

#### 1. Who will benefit from the new standards?

- Everyone deserves to be treated equally and empathetically by the justice system, but too many survivors of sexual assault do not report the crimes committed against them. This is often due to fear they will not be believed, victim-blaming, and/or distrust of the criminal justice system.
- It's crucial that police have the guidance and training required to respond to the needs of victims, including vulnerable and marginalized groups.
- These new standards, guided by victim-centred, trauma-informed, inclusive and culturally safe approaches will lead to more empathetic, respectful and effective investigations.
- The standards will increase public trust and help to ensure that everyone has consistent access to high-quality, unbiased policing throughout British Columbia.

## 2. How will the standards shape survivors' experience with the police during the reporting and investigation of sexual assaults?

- The new standards will empower survivors with information to help them
  decide how they want their case to proceed, avoid further harm throughout
  the investigation, and connect survivors to appropriate services.
- During the intake process, when the sexual assault is first reported, survivors
  will meet with police officers with the option to be further supported by victim
  services workers. They will consider the survivor's unique needs as they
  inform them of their rights, options, and the services available to them.
- The standards will also require supervisory oversight throughout sexual assault investigations to make sure they are responsive and impartial, and a review process for closed cases to inform training needs and future investigations.
- As well, the new standards will promote police coordination with local health services and other community-based supports. Survivors may do a third-party report, through a community-based victim services to provide information to police if they would otherwise not report to police.

## 3. Are all police departments operating in B.C. required to implement these standards?

- Yes. Like all policing standards, the standards on responding to sexual assaults apply to police boards and police agencies operating in B.C. The BC RCMP will also harmonize its policies and procedures with the provincial policing standards.
- Each police department is responsible for putting in place internal policies to ensure compliance and alignment with the standards.

#### 4. How much will it cost to put the standards in place?

 Police agencies will put in place processes in alignment with the standards to support police officers during investigation. Some police agencies already have these processes in place and so cost may vary across police agencies.

#### 5. When will the standards come into effect?

- The standards will take effect in 12 months to allow time for police boards and police agencies to implement internal policies that support the standards. The effective date is noted in the standards on our website.
- The standards apply to all police agencies operating in B.C., in municipal police and First Nations departments, as well as the BC RCMP.
- Each police department is responsible for putting in place internal policies to align with the standards.

#### 6. Whom did the Province engage during the development of the standards?

- Throughout the process, the Province engaged with various community groups and with service providers who represent the interests of and who support survivors of sexual assaults. For example, there were discussions at various stages of the project with:
  - Ending Violence Association of BC;
  - BC Society of Transition Houses;
  - Disability Alliance BC;
  - Police-Based Victim Services of BC;
  - West Coast Leaf; and
  - Sexual assault centers (Kamloops Sexual Assault Counselling Centre; Victoria Sexual Assault Centre; Prince George Sexual Assault Center; and Oak Centre Vernon).
- The Province also engaged with Indigenous organizations including the BC First Nations Justice Council, the Minister's Advisory Council on Indigenous Women, Union of B.C. Indian Chiefs, Native Courtworker and Counselling Association of BC.
- These are in addition to a standing committee engaged as a matter of course during the development of all standards, as well as a working group of police representatives with subject matter expertise in sexual assault investigations.

#### 7. How will these standards help Indigenous survivors of sexual assaults?

- Indigenous survivors face unique barriers to reporting crime to police and accessing justice.
- With the new and existing standards, as well as police training requirements, survivors will be met with culturally appropriate procedures and practices that address racial discrimination, bias and intergenerational trauma.
- Indigenous survivors will also be connected to cultural and Indigenousspecific services and programs.
- The Ministry considered the United Nations Declaration on the Rights of Indigenous Peoples as well as alignment with the:
  - National Inquiry into Missing and Murdered Indigenous Women and Girls;
  - o BC First Nations Justice Strategy; and,
  - Métis Justice Strategy.

## 8. The standards are focused on adult survivors – will they also help youth who have been sexually assaulted?

- While the standards were developed for responding to adults who have been sexually assaulted, younger persons will also benefit from trauma-informed and victim-centered approaches that will ensure investigations are respectful, empathetic and effective.
- Standards in place already require police agencies to have procedures in place governing investigations likely to involve persons in vulnerable circumstances, including youth.

## 9. Are these standards being developed in response to the historical allegations of sexual abuse of First Nations women and girls by members of the Prince George RCMP?

- The allegations of historic misconduct of members in Prince George are disturbing and our government takes them very seriously.
- The Director of Police Services appointed the Alberta Serious Incident Response Team (ASIRT) to conduct the investigation as it is an independent, external, civilian-led organization that investigates serious and sensitive allegations of police misconduct.
- ASIRT is working with Indigenous communities, and consulting with the Assembly of First Nations and other Indigenous organizations.
- As this is an active investigation, further comment will be made when it is deemed appropriate.

## 10. How do these standards build on other initiatives that promote unbiased policing?

- Everyone deserves to be treated fairly by the police, and it's crucial that the
  public have confidence that policing and community safety services
  throughout British Columbia are high-quality and unbiased.
- The policing standards on responding to sexual assault complement a set of provincial policing standards to promote unbiased policing established in 2021 (they are effective now) to improve police responses to marginalized and vulnerable people.
- This includes standards requiring police training to improve police responses and ensure unbiased policing such as trauma-informed practice, investigations of intimate partner violence, and Indigenous cultural safety, as well as other requirements for police to engage with community-based groups when creating or amending certain policies or procedures.
- The sexual assault standards are also consistent with the Special Committee on Reforming the Police Act's recommendations on enhancing and standardizing police education and training and ensuring communities everywhere in B.C. can access high quality policing and public safety services.

## 11. If a survivor does not feel appropriately treated by the police, where can they go for help?

- Survivors can contact the BC Office of the Police Complaint Commissioner if they have concerns about the conduct of any municipal or designated police officer or department.
- Survivors can reach out to the Civilian Review and Complaints Commission for the RCMP if they have complaints about the conduct of RCMP members.
- Survivors are encouraged to file a complaint with their police of jurisdiction or contact the Officer in Charge.

#### New programs, police standards support sexual assault survivors

VANCOUVER – Stable funding for sexual assault programs, as well as the establishment of new policing standards for responding to sexual assaults, will respect and support the diverse needs of survivors and ensure more effective investigations.

Sexual assaults predominately affect women, girls and gender-diverse people. Indigenous and other racialized women and girls, members of the 2SLGBTQIA+ community, sex workers, people with disabilities, and individuals experiencing poverty or homelessness are most at risk of being targeted with violence. Many survivors are hesitant to report sexual assault due to a distrust of the criminal justice system and the fear that they will not be believed.

To support the recovery of survivors, the Province is providing stable, annual funding for 68 new sexual assault programs that will deliver co-ordinated, community-based services throughout British Columbia. The ministry will add more new programs and supports this year, including five regional sexual assault centres that will provide dedicated co-located spaces to deliver wraparound services for survivors of sexual assault.

"Sexualized violence is deeply traumatic and has devastating effects on survivors, families and communities," said Kelli Paddon, Parliamentary Secretary for Gender Equity. "Too many people face gender-based violence in communities across B.C., with women, girls, and gender-diverse people being disproportionately affected. Stable, reliable funding to support dedicated sexual assault programs, as well as these new police standards build on other life-saving work to support survivors across the province, including counselling, outreach and crisis support, and victim-service programs."

The sexual assault programs and the new policing standards will be guided by victim-centred, trauma-informed, inclusive and culturally safe approaches. The services are a key component of B.C.'s action plan to address gender-based violence, which is being developed in partnership with Indigenous organizations, an advisory committee, experts and advocates. The new standards also align with the plan.

Under the new policing standards, police officers will work in collaboration with victim-services workers to consider the survivor's unique needs when they first report the sexual assault.

There will be supervisory oversight during investigations to make sure they are responsive, trauma-informed and impartial, as well as a review of closed cases to improve training and future investigations. The new standards promote police co-ordination with local health services and other community-based supports, and will apply to all police officers in B.C.

"All survivors deserve fair and empathetic treatment after they have experienced the trauma of sexual assault," said Mike Farnworth, Minister of Public Safety and Solicitor General. "New

policing standards and investments in sexual assault programs will empower survivors to decide how they want their case to proceed, shield them from further harm and connect them with services for a pathway to healing. Our government is building a safer, healthier and more just province for all of us by promoting high-quality and unbiased policing and providing stable funding for crucial services that support survivors."

The funding for sexual assault services programs begins in July 2023. The new policing standards will take effect in 2024 to allow time for police and police boards to implement the requirements.

#### **Quick Facts:**

- Provincial standards set requirements for all British Columbia's police agencies and police boards to promote best practices, accountability and consistency.
- Policing standards to promote unbiased policing, which were approved in 2021, advance
  equitable policing throughout the province by requiring policies and procedures, training,
  audit activity and community engagement.
- The Province has provided \$20 million for the multi-year Emergency Sexual Assault Services grant program to support the delivery of emergency sexual assault services throughout B.C. from March 2020 until March 2023.
- The Province now provides over \$54 million annually in stable funding for services and programs to support victims of crime, including ore than 470 victim-service, violenceagainst-women and sexual assault programs operating in communities throughout BC.
  - This includes \$10 million annually, beginning in April 2023, to support the delivery of sexual assault programs that are victim-centred, trauma-informed, and coordinated, depending on client needs.

VICTORIA – Stable funding for sexual assault programs, as well as the establishment of new policing standards on responding to sexual assaults, will respect and support the diverse needs of survivors and ensure more effective investigations.

Sexual assaults predominately affect women and girls. Indigenous and other racialized women and girls, members of the 2SLGBTQIA+ community, sex workers, people with disabilities, and individuals experiencing poverty or homelessness are most at risk of being targeted with violence. The sexual assault programs and the new policing standards will be guided by victim-centred, trauma-informed, inclusive and culturally safe approaches. The services are a key component of B.C.'s action plan to address gender-based violence, which is being developed in partnership with Indigenous organizations, an advisory committee, experts and advocates. The new standards also align with the plan.

Under the new policing standards, police officers will work in collaboration with victim services workers to consider the survivor's unique needs when they first report the sexual assault.

The funding for sexual assault services programs will begin in July 2023, and the new policing standards will take effect in 2024 to allow time for police and police boards to implement the requirements.

#### New programs and police standards support sexual assault survivors

VICTORIA – Stable funding for sexual assault programs and new policing standards on responding to sexual assaults will respect and support the diverse needs of sexual assault survivors and ensure more effective investigations.

Sexual assaults predominately affect women and girls. Indigenous or racialized women and girls, members of the 2SLGBTQ+ community, sex workers, people with disabilities, and individuals experiencing poverty or homelessness have higher rates of victimization. Many survivors are hesitant about reporting sexual assault due to a distrust of the criminal justice system and the fear that they will not be believed.

To support the recovery of survivors, the Province is announcing sixty-eight new sexual assault programs that will deliver co-ordinated, community-based sexual assault services in communities throughout British Columbia. The Ministry plans to continue to add more new programs and supports later this year including five Sexual Assault Centres that will provide dedicated co-located spaces that will deliver wrap around services for survivors of sexual assault.

- While the standards were developed for responding to adults who have been sexually assaulted, girls will also benefit from victim-centred guidelines that will make investigations more respectful, empathetic, and effective.
- 9. Are these standards being developed in response to the historical allegations of sexual abuse of First Nations women and girls by members of the Prince George RCMP?
  - The allegations of historic misconduct of members in Prince George are disturbing and our government takes them very seriously.
  - The Director of Police Services appointed the Alberta Serious Incident Response Team (ASIRT) to conduct the investigation as it is an independent, external, civilian-led organization that investigates serious and sensitive allegations of police misconduct.
  - ASIRT is working with Indigenous communities, and consulting with the Assembly of First Nations and other Indigenous organizations.

 As this is an active investigation, further comment will be made when it is deemed appropriate.

# 10. How do these standards build on other initiatives that promote unbiased policing?

- Everyone deserves to be treated fairly by the police, and it's crucial that the
  public have confidence policing and community safety services throughout
  British Columbia are high-quality and unbiased.
- The policing standards on responding to sexual assault complement existing work to improve police responses to marginalized and vulnerable people.
- This includes standards on police stops and required police training on intimate partner violence, trauma-informed practice, and Indigenous cultural safety.
- The sexual assault standards are also consistent with the Special Committee

Our government is building a safer, healthier and more just province for all of us by promoting high-quality and unbiased policing and providing stable funding for crucial services that support survivors." NOT APPROVED

The funding for sexual assault services programs will begin in July 2023 and the new policing standards will take effect in 2024.

Quick Facts:

- Provincial standards set requirements for all British Columbia's police agencies to promote best practices, accountability and consistency.
- Policing standards banning arbitrary police stops or stops based on race came into effect in 2020.
- Between March 2020 and March 2021, the Province also provided \$20 million for the multi-year Emergency Sexual Assault Services grant program to support the delivery of emergency sexual assault services throughout B.C. until March 2023.
- The Province provides over \$54 million annually in stable funding for services and programs to support victims of crime, including over 400 victim service and violence against women programs operating in communities across BC.
- This includes, \$10 million annually provided in Budget 2022, beginning in April 2023, to support the delivery of sexual assault programs that are victim-centred, traumainformed, and coordinated depending on client needs.

## **BACKGROUNDER**

#### Sexual Assault Services receiving stable funding

To support the recovery of survivors, the Province is announcing 68 new sexual assault programs who will deliver co-ordinated, community-based sexual assault services in communities throughout British Columbia. The Ministry plans to continue to add more new programs and supports later this year including five Sexual Assault Centres that will provide dedicated co-located spaces that will deliver wrap around services for survivors of sexual assault.

- Sexual violence is deeply traumatic and has devastating effects on women, families and communities.
- Indigenous or racialized women and girls, members of the 2SLGBTQ+ community, sex workers, people with disabilities, and individuals experiencing poverty or homelessness have higher rates of victimization.
- Furthermore, many survivors are hesitant about reporting sexual assaults, due to distrust of the criminal justice system and the fear they will not be believed.

- Both the SAS programs and the new policing standards will be guided by victimcentred, trauma-informed, inclusive and culturally safe approaches.
- It is crucial that the public has confidence that policing throughout British
  Columbia is high-quality and unbiased, and that police have the policies,
  guidance and training in place that's required to respond to the needs of
  vulnerable and marginalized groups.
- Everyone deserves to be treated fairly by the justice system, and these new standards will complement existing government work to ensure unbiased policing for everyone, including police training on intimate partner violence and standards on police stops.

#### QAs:

### SAS Funding/Procurement

#### 1. Who will benefit from the funding?

- The initial procurement will establish 68 SAS contracts with 56 organizations across the province, increasing the total number of SAS programs by 15 compared to the Emergency Sexual Assault Services (ESAS) grant program.
- Stable, annual funding will help ensure service providers are able to focus on providing care people need without having to reapply each year.
- Ending violence, supporting safety, and creating security are central to our work as government.

 It's essential that people who have been sexually assaulted have immediate access to program services, counselling, and support.

#### 2. How many organizations will receive funding?

 Presently, 56 organizations across the province will be receiving the SAS contract funding effective July 1, 2023.

#### 3. How was it determined who would receive the funding?

- Throughout the past year, the Ministry of Public Safety and Solicitor General (Ministry) initiated a rigorous engagement and a fair, open, and transparent procurement process via BC Bid.
- The successful organizations were chosen based on demonstrated ability to meet the local needs of survivors in their community and establish and deliver a SAS program that is coordinated, culturally safe, client centred, and trauma informed through either direct support, counselling services or both.

# 4. Why were some organizations who previously received funding not successful this time?

- Some organizations that previously received ESAS grants, did not submit an application for the SAS program or the respondents were not the highest scoring for their service area.
- 5 organizations that received an ESAS grant were not successful recipients of the SAS contract.
- 5. What about programs that aren't successful in getting this new, stable funding? / What if a program received funding via the Emergency Sexual Assault Services grant program administered by Ending Violence Association of BC (EVA BC) and then is not successful in the procurement process? Won't that create a disruption of services in the community?
  - The Ministry has worked with EVA BC to ensure a smooth transition between the end of the ESAS grant projects and the completion of the procurement process to award contracts for the new ongoing SAS Program. Bridge funding has been provided to all ESAS grant agencies that requested it.
  - Further, ESAS grant recipients who did not apply for ongoing SAS
    program funding, or who were not successful in the procurement, will have
    the ability to use any surplus ESAS grant funds, or apply to the Ministry for
    funding to wind-down their projects and transition any clients to the new
    ongoing SAS programs in a trauma-informed way.

#### 7. How does this funding support B.C.'s Gender Based Violence Action Plan?

- We are committed to preventing and ending gender-based violence, and to supporting survivors, families and communities impacted by its devastating effects.
- A provincial action plan to help end gender-based violence, support survivors and promote healing, community awareness and prevention is being developed by the Ministry and the Parliamentary Secretary for Gender Equity.
- We are also partnering with Indigenous organizations, an advisory committee, experts and advocates to create the plan.
- Both the specialized sexual assault services and the new policing standards will be key components of the plan.

#### 8. What is the total funding amount from 2022-2023

- Budget 2022 allocated stable annual funding of \$10 million for communitybased SAS programs to support victims of sexual and gender-based violence starting in 2023/24.
- Between March 2020 and March 2021, \$20 million was provided for a multi-year ESAS grant program, administered by EVA BC, to support the delivery of coordinated, community-based sexual assault response services throughout the province until March 2023.

#### Why was no funding for sexual assault service providers provided in 2022/23?

- Sexual assault service providers currently have funding via the ESAS grant program that runs until the end of March 2023.
- This new stable, annual SAS funding will start July 1, 2023. The Ministry
  has worked with EVA BC to ensure a smooth transition between the end of
  the ESAS grant projects and the completion of the procurement process to
  award contracts for the new ongoing SAS Program. Bridge funding has
  been provided to all ESAS grant agencies that requested it.

### 10. Existing victim service and violence against women programs have waitlists and need to fundraise to provide needed services. Why is there no additional funding for them?

- We recognize the devastating impacts of violence on survivors, families, and communities, which is why we are choosing to provide stable, annual funding for SAS programs.
- Stable funding will improve supports for survivors and help ensure they
  have immediate access to medical services, counselling and support.

#### Policing standards on responding to sexual assaults

#### 1. Who will benefit from the new standards?

- Everyone deserves to be treated equally and empathetically by the justice system, but too many survivors of sexual assault do not report the crimes committed against them due to distrust of the criminal justice system and the fear they will not be believed.
- It's crucial that police have the guidance and training required to respond to the needs of vulnerable and marginalized groups.

- These new standards, guided by victim-centred, trauma-informed, inclusive and culturally safe approaches, will lead to more empathetic, respectful and effective investigations.
- It's crucial that police have the guidance and training required to respond to the needs of vulnerable and marginalized groups.
- The standards will increase public trust, and help ensure everyone has access to high-quality, unbiased policing throughout British Columbia.

# 2. How will the standards shape survivors' experience with the police during the reporting and investigation of sexual assaults?

- The new standards will empower survivors with information to help them
  decide how they want their case to proceed, prevent further harm and
  connect survivors to appropriate services.
- During the intake process, when the sexual assault is first reported, survivors
  will meet with police officers supported by victim services workers. They will
  consider the survivor's unique needs as they inform them of their rights, and
  the services available to them.
- The standards will also require supervisory oversight throughout sexual assault investigations to make sure they are responsive and impartial, and a review of closed cases to improve training and future investigations.
- As well, the new standards will promote police coordination with local health services and other community-based supports.

# 3. Are all police departments operating in B.C. required to implement these standards?

- Yes. Like all policing standards, the standards on responding to sexual assaults apply to all police officers operating in B.C., in municipal and First Nations police departments as well as the BC RCMP.
- Each police department is responsible for putting in place internal policies to align with the standards.

#### 4. How much will it cost to put the standards in place?

### 5. When will the standards come into effect?

- The standards will take effect in 2024/12 months to allow time for police boards and police agencies to implement internal policies that support the standards.
- The standards apply to all police officers operating in B.C., in municipal police and First Nations departments, as well as the BC RCMP.

#### 6. Whom did the Province consult about developing the standards?

- The Province engaged with service providers who support survivors of sexual assaults and other community groups including:
  - o Ending Violence Association of BC;
  - o BC Society of Transition Houses;
  - o Disability Alliance BC;
  - o Police-Based Victim Services of BC; and
  - West Coast Leaf.
- The Province also consulted Indigenous stakeholders including the BC Minister's Advisory Council on Indigenous Women, and the First Nations Justice Council.

#### 7. How will these standards help Indigenous survivors of sexual assaults?

# 8. The standards are focused on adult survivors – will they also help<sup>s.13</sup> who have been sexually assaulted?

 While the standards were developed for responding to adults who have been sexually assaulted,s.13 will also benefit from victim-centred guidelines that will make investigations more respectful, empathetic and effective.

#### 9. Are these standards being developed in response to the historical allegations of sexual abuse of First Nations women and girls by members of the Prince George RCMP?

- The allegations of historic misconduct of members in Prince George are disturbing and our government takes them very seriously.
- The Director of Police Services appointed the Alberta Serious Incident Response Team (ASIRT) to conduct the investigation as it is an independent, external, civilian-led organization that investigates serious and sensitive allegations of police misconduct.
- ASIRT is working with Indigenous communities, and consulting with the Assembly of First Nations and other Indigenous organizations.
- As this is an active investigation, further comment will be made when it is deemed appropriate.

# 10. How do these standards build on other initiatives that that promote unbiased policing?

- Everyone deserves to be treated fairly by the police, and it's crucial that the
  public have confidence policing and community safety services throughout
  British Columbia are high-quality and unbiased.
- The policing standards on responding to sexual assault complement existing work to improve police responses to marginalized and vulnerable people.
- This includes standards on police stops and required police training on intimate partner violence, trauma-informed practice, and Indigenous cultural safety.
- The sexual assault standards are also consistent with the Special Committee
  on Reforming the Police Act's recommendations on enhancing and
  standardizing police education and training, and ensuring communities
  everywhere in B.C. can access high quality policing and public safety
  services.
