Remarks:

THIS FIRE WAS DETERMINED SUSPICIOUS BY THE RCMP. THIS WAS DUE TO SEVERAL FACTORS INCLUDING WITNESS STATEMENTS AND PROBABLE ORIGIN OF THE FIRE. RCMP THAN TOOK OVER THE FIRE INVESTIGATION. PORT COOUITLAM FIRE DEPT. INVESTIGATORS ASSISTED THE RCMP WITH THE INVESTIGATION. THE INVESTIGATION DETERMINED THE AREA OF ORIGIN WAS THE MID CHARLIE SIDE EXTERIOR WALL. PRIOR TO RCMP MAKING THE SUSPICIOUS DETERMINATION FIRE DEPARTMENT INVESTIGATORS INTERVIEWED ON FIRE SCENE FIRE DEPARTMENT PERSONAL, WITNESSES AND FIRST ON SCENE RCMP. DUE TO ON GOING ACTIVE FIRE CONDITIONS AND ON GOING FIRE SUPPRESSION ACTIVITIES THE FIRE INVESTIGATION WAS AT THIS TIME LIMITED TO INTERVIEWS, SCENE ASSESSMENT AND PHOTO'S OF THE EXTERIOR OF THE BUILDING. DUE TO FIRE DAMAGE AND STRUCTURAL INTEGRITY OF THE BUILDING, FIRE AND RCMP INVESTIGATORS COULD NOT ENTER THE BUILDING. ENGINE 2 CAPTAIN REMARKS: 23-101402STRUCTUREFIRE/RILEY E2 CREWS TO CHARLIE SIDE. INITIALLY A 2 1/2" LINE ONTO FIRE MID CHARLIE WITH O1 INITIAL ATTACK CREW. O1 ATTACK CREW ESTABLISHED THEIR OWN 1 3/4'. WATER VOLUME HAD NO EFFECT. A GATED 4' WAS THEN DEPLOYED TO THE CHARLIE SIDE. 2 1/2' HANDLINE DEFENSIVE ATTACK MID CHARLIE AND A GROUND MONITOR SUPPLIED BY A 2 1/2' OFF THE OTHER SIDE OF THE 4 'GATE. ALSO MID ALPHA DEFENSIVE ATTACK. E2 MADE CHARLIE DIVISION. 4' GROUND MONITOR THEN DEPLOYED DOWN THE HALLWAY AND INTO THE CEILING NEXT TO THE GYM. A PIERCING NOZZLE WAS DRIVEN INTO THE ROOF ATTIC VOID, NEXT TO THE GYM, FROM THE TOP OF A 24' LADDER. CAPT. DIMSDALE TAKES OVER CHARLIE DIVISION WITH NEW FIRE FIGHTERS. E2 TO ALPHA FOR REHAB THEN SOME HOSE HANDLING.
