Good morning Luella,

Thank you for your email, we appreciate MLA Morris' interest in the matter. As you know, Canada has been moving towards decriminalization of simple possession. This is important work and our branch has been doing a considerable amount of work on decriminalization nationally and in our province.

From 2015 to 2019, total drug possession rates trended upwards in BC, from 1.36 to 2.03 police-reported drug possession incidents per 1,000 population. However, during the same period, total drug possession charge rates (cleared by charge) had a different pattern. Though there was an increase between 2015 and 2016 (from 0.41 to 0.48), total drug possession charge rates in BC trended downwards from 2016 to 2019 (from 0.48 to 0.38).

"No case" seizures may be available through PRIME-BC. My team will reach out to our policing partners and make the request, subject to their capacity to pull this data. Please also be aware that due to retention periods this information may not reflect all the instances within the date range you've requested.

My team will be in touch after we've connected with the appropriate policing stakeholders with further details pertaining to your request.

REQUEST:

MLA Mike Morris is seeking statistics for 'no case' drug seizures for the past 5 years (10 if available).

Overall Context

- We have discussed with PRIME-BC who confirm that to provide data for all police of jurisdiction would require us to obtain permission from each of them as the owners of the data.

No case seizure data request context (from RCMP E-Div):

- Data on no case seizures is both not readily available through electronic searches and may be of limited value, depending on the intended use for the data
- RCMP advise that 'No case' (or "prosecution not viable" cases) no cases can involve all of the following incidents:
 - o a drug seizure from a person in possession;
 - a drug seizure from a person who was trafficking but charges not forwarded due to another issue:
 - found/abandon drugs;
 - drugs turned over to police by a federal/provincial prison;
 - drugs intercepted by Canada Post;
 - o drugs found during a vehicle stop for a motor vehicle infraction;
 - drug paraphernalia with residue found by a concerned parent and turned in;
 - o drugs found on a person during an arrest for another offence and the drugs are no cased instead (done to simplify the court case related to the original arrest).
 - drugs found by the Canada Border Services Agency (i.e. hidden in a tractor trailer unit), and is then reported to RCMP (if RCMP cannot subsequently link the drugs to the driver/importer it becomes a no case).

Best Available Data - RCMP E-Div:

- Statistics are available on reported illicit drug seizures and approved drug-related charges and conviction occurrences in British Columbia, 2019 2020, for RCMP jurisdictions in BC. This specific data was compiled to support the Ministry of Mental Health and Addictions' request to Health Canada for an exemption from the Controlled Drugs and Substances Act (CDSA) to effectively decriminalize personal possession of illicit substances in British Columbia.
- Limitations on the existing data: The aforementioned statistical data on illegal drug seizures was
 collected using Uniform Crime Reporting (UCR) coded indicators for drug seizures on PRIME-BC
 General Occurrences (GO) for BC RCMP jurisdictions. 'Private and Invisible' files were not included.
 The occurrences were isolated to instances where drug possession and seizure were listed as the
 first or only line of UCR scoring summaries, then filtered to include only those illicit street and

pharmaceutical drugs consistent with the City of Vancouver's proposal. Records deemed to be lost and found, held for safe keeping, agency assistance files, as well as those which lacked usable data relative to drug type/quantity were also removed from the data set. Due to time constraints, a fully comprehensive manual review was not undertaken to verify and confirm the data.

RCMP E-Div Data/Findings:

Over 2019 and 2020 there were 40,302 occurrence records in BC RCMP jurisdictions in which there
were founded CDSA violations on any line of scoring. A very small fraction of total CDSA-related
violation records resulted in a conviction for drug possession alone.

- Opioids, amphetamines and cocaine comprise the overwhelming majority of the illicit street drug occurrences, both in terms of the numbers of seizures and the weight/quantity seized.
- A small fraction of total CDSA violation records resulted in a conviction for drug possession alone.
- 77% of occurrences involving illicit drug seizure are less than or equal to proposed thresholds.

Best Available Data – City of Vancouver Data/Findings:

- Municipality of Vancouver data is also available through the City's document entitled 'City of Vancouver Request for an exemption from the Controlled Drugs and Substances Act (CDSA) pursuant to section 56(1) that would decriminalize personal possession of illicit substances within the City of Vancouver Final Submission to Health Canada'. - The Vancouver Police Department's (VPD) approach has moved toward de facto decriminalization of simple possession. Per the table below, this has resulted in a decrease in the number of simple possession charges over the last number of years:
