Remarks:

THE HOME OCCUPANT WAS COMING OUT OF THE SHOWER WHEN SHE HEARD THE FIRE ALARM GOING OFF. SHE WENT DOWN STAIRS TO THE BASEMENT TO CHECK IT OUT AND SMELLED SMOKE AS SHE WALKING. SHE FOUND A FIRE IN THE STORAGE ROOM BELOW THE STAIRS AS WELL AS HEAVY SMOKE. SHE CLOSED THE DOOR TO THE STORAGE ROOM AND WENT UPSTAIRS TO HER BEDROOM. PUT ON SOME CLOTHS, RAN OUTSIDE TO CALL 911. THE FIRE DEPARTMENT ARRIVED TO FIND HEAVY SMOKE COMING OUT OF THE HOME. THE FIRE CREWS DEPLOYED TWO 1.5' HOSE LINES AND EXTINGUISHED THE FIRE. THE FIRE HAD MADE ITS WAY OUT OF THE STORAGE ROOM IN THE BASEMENT LAUNDRY ROOM ON THE MAIN FLOOR. HEAVY FIRE DAMAGE TO THE FLOOR JOIST BELOW LAUNDRY ROOM, STORAGE ROOM, LAUNDRY ROOM EXTENDING INTO THE KITCHEN. SIGNIFICANT SMOKE DAMAGE THROUGHOUT THE HOUSE.
