Doug can speak for himself, but I am comfortable as you were in noting that both of us regard the preservation of the Morden Colliery and its unique significance in our Province's history as an important priority. That is my message to the Premier, as well as the Ministers who will have some interest and or some responsibility for the Morden Colliery Historic Provincial Park.

It would be and incredible loss if the head frame and other aspects of Morden collapsed without appropriate restoration, which is the only way to preserve one of the most symbolic reminders of the historic and significant role that coal mining played on Vancouver Island and British Columbia. I am therefore urging my colleagues to ensure its preservation and enhancement of this wonderful historic site.

Hi Greg,

Attached is the story for the monument unveiling ceremony along with two photo images.

The story was written for the VI Free Daily but feel free to run it yourself as I realize that Black Press stories get shared around the company's newspapers. In fact I hope you do run it as Morden now has another opportunity to be repaired with a new government in place. Both local MLA's are on record via speeches in the Legislature as favouring restoration and in fact both have indicated to the premier that they see it as a high priority. For his part, Premier Horgan expressed interest in the Morden situation when contacted back in 2013 on the occasion of a FOMM delegation meeting with then NDP Env. critic Rob Fleming at the Legislature. The premier could not attend that meeting due to a prior commitment but an extensive briefing book was left with him at the time. The premier was also a supporter of the Kinsol Trestle restoration project, a heritage restoration job akin to Morden, and one supported by a number of prominent people who also have supported Morden – e.g., former CVRD chair Jack Peake, heritage and history journalist Tom Paterson, and the chief restoration contractor for the Kinsol project, John Knappett of Knappett Projects, who joined an earlier Morden delegation that met with then Env. Minister Terry Lake in 2012.

I say all this because it would be good to have as much coverage as possible to rekindle the public's interest in the Morden situation. You might also consider doing a story involving some or all of the above-named parties since their views are not touched upon in the attached article.

The two photos provide complementary images of the monument site, one showing the monument just after the surrounding garden was planted and mulched in March of this year, and the other showing the monument itself just after it was unveiled by Stephanie Govier of BC Parks and John Hofman, a former co-president of FOMM. Farther to the right if it shows on the image is yours truly, speaking to the assembled members and guests.

Please advise if the story and images are satisfactory. There are additional images that could be used if need be.
