Destination BC: Wildfire Response

This year British Columbia endured some of the worst wildfires on record. During the height of the fires, the safety of our residents, businesses and visitors alike was always our primary concern. Destination BC (DBC) took immediate action by developing a communications and marketing plan to help protect visitors and tourism in BC. Unfortunately, as the fires raged on, we saw an increase in trip cancellations—mostly by British Columbians and Albertans. This affected many tourism operators during what is traditionally their busiest season.

In the early stages of the wildfires, we helped keep travellers safe by advising them to “Know Before You Go”—supplying web-based information on the fires, roads, and back-country closures. We also provided industry with emergency planning guides and resources, and provided regular updates for a variety of media outlets (over 100 members of the media). We later launched marketing in short-haul markets to support those areas being indirectly impacted. Now that the fires are over, we are encouraging people to visit and we are showcasing the stories of our industry.

Through our annual Explore BC campaign, DBC has taken action to counteract losses to tourism due to the unprecedented scale, duration and impact of the wildfires on travel within the province. By adjusting programs and redirecting savings, we increased our budget with a focus on promoting recovery efforts in the affected areas of the Cariboo Chilcotin Coast, as well as other impacted areas in the Thompson Okanagan and Kootenay Rockies. DBC will continue to collaborate with partners to support maximum alignment and amplify efforts. The primary audience for this marketing will be travellers from BC and Alberta, with a secondary focus on travellers from Washington State. Phase 1 of the recovery efforts started November 14 and extend until mid-December. Phase 1 tactics include paid search advertising (in BC, Alberta & Washington), print advertising (in BC and Alberta), e-mail, and paid social advertising (BC only). The focus will be on inspiring immediate winter travel, as well as generating awareness and inspiring bookings for 2018. Phase 2 of the recovery efforts are still being planned but will run January through to March 2018.

A high-level creative concept showcasing the “Spirit of BC” has been developed to evoke emotion and drive urgency to travel to the areas most impacted by BC’s wildfires. It relies on integrating the authentic voice of impacted communities and individual tourism business operators into the creative. Within BC, we will also showcase travel deals, and festivals and events to help convert sales, targeting those who are closer to destinations and more likely to travel in the fall shoulder season.

Issue: Meeting with Allan Reid, President and CEO, CARAS, The JUNO Awards & MusiCounts

Background / Facts:

- The Canadian Academy of Recording Arts and Sciences (CARAS) is a not-for-profit organization created to preserve and enhance the Canadian music industry and contribute to higher artistic and industry standards. CARAS showcases and promotes Canadian artists and music through vehicles such as The JUNO Awards (JUNOs) and other year-round initiatives.
- Annually, the JUNOs recognize excellence in the Canadian music recording industry, culminating in a nationally broadcast awards ceremony.
- In 2016, the Province and CARAS began discussions about support for the 2018 event; CARAS required a \$1.7M “bid fee” to secure Vancouver as the 2018 host for the JUNOs.
- The bid fee funds the cost of running the primary events associated with the awards, including the Chairman’s Reception, the JUNO Awards Welcome Reception, the JUNO Gala Dinner and Awards, the JUNO Red Carpet and the JUNO Awards Broadcast.
- On March 6, 2017, the Province committed in writing to provide up to \$1.2M for the bid fee (Appendix 2).
- The letter articulated the Province’s expectation that any additional costs associated with the JUNOs, including the remaining \$500,000 of the requested bid fee, would be the responsibility of CARAS, the host city, and corporate sponsors.
- The \$1.2M provincial contribution came from funds set aside for ‘emergent priorities’ under the BC Music Fund (BCMF). A contract has been issued with CARAS for the funds, administered through Creative BC.
- On April 3, 2017, CARAS announced Vancouver as the host city for the 2018 JUNOs (March 19-25).

Appendix 1: Biography

Allan Reid, President & CEO of CARAS, The JUNO Awards and MusiCounts



Mr. Reid's career began at 18, when he became music director of his hometown radio station in Kelowna, BC. A short time later he was hired by A&M Records in Vancouver where he worked as a promo rep, and then transferred to Toronto where within two years he became the head of Artists and Repertoire (A&R). He served as VP of A&R and VP of Marketing for A&M and through a series of mergers became Senior Vice President A&R for Universal Music Canada in 1999. Mr. Reid was instrumental in the careers of such artists as Ashley MacIsaac, Big Sugar, Hawksley Workman, Hedley, Jann Arden, Jilly Black, Sam Roberts, The Tragically Hip, Sarah Harmer, and more.

In 2007, Mr. Reid joined MapleMusic Recordings as General Manager. MapleMusic Recordings became one of Canada's leading independent music entertainment companies and home to a diverse group of artists including Chantal Kreviazuk, Joel Plaskett, Kathleen Edwards, and Martha

Wainwright. MapleMusic is also home to such renowned international artists as David Gray, Radiohead, and Silversun Pickups. After 25 years working at both major and independent labels in Canada, Mr. Reid decided to chart his own course and move into artist management and consulting work. As the music industry continued to try and redefine itself in the digital age, Allan chose to build upon his strength as an artist relations person. He previously managed recording artists Hawksley Workman and Royal Wood and producers Bill Bell (Jason Mraz, Justin Nozuka, and Tom Cochrane) and Dave Genn (Hedley, Marianas Trench).

In the summer of 2011 Mr. Reid joined MusiCounts, Canada's music education charity associated with The Canadian Academy of Recording Arts and Sciences (CARAS). As Director of MusiCounts he oversaw fundraising and their programs, which include the Band Aid program, the MusiCounts Teacher of the Year Award, Scholarships, and other music education initiatives. Under Mr. Reid's direction, in 2012-2013 MusiCounts had their most impactful year to date contributing over one million dollars to support music education in Canada that year alone. He was also instrumental in the creation of MusiCounts' newest initiative the TD Community Music Program, designed specifically to create opportunities for youth in underserved communities across Canada. 2017 marks the 20th anniversary of the MusiCounts Band Aid Program, which provides musical instruments to schools in need. Since 1997 MusiCounts has grown significantly and by the end of 2017 will have awarded over \$10,000,000 through its programs. These funds will have benefitted over 950 schools and community organizations, supported over 350 post-secondary music program graduates and honoured 12 extraordinary music teachers.

- The previous government made a commitment in March 2017 to transfer the South Building (that had been occupied by Emily Carr University) to Arts Umbrella and provide a one-time grant to cover the cost of the lease.
- A \$7 million grant from Canadian Heritage is contingent on this transfer.
- In October 2017, Cabinet reviewed the issue in light of an alternative idea that would see the facility maintained for the public post-secondary community, as both Langara College and UBC had expressed interest in the building.
- Following this review, government is completing the transfer to Arts Umbrella, as people have already acted on the previous government's commitment.
- Letters went to stakeholders Oct. 25 & 26, 2017, informing them that government decision is to transfer the South building to Arts Umbrella.

Visitor numbers show BC as a choice destination for international travellers

VICTORIA – September marks a strong month of growth for international visitor arrival numbers for the tourism sector in British Columbia.

The latest numbers from Statistics Canada indicate a 4.6% increase in visitors over September of 2016, resulting in 26,478 more visitors arriving in B.C. The total year-to-date international overnight custom entries to B.C. are also up 3.1%, resulting in 139,951 more visitors. September typically represents about 10.4% of annual international overnight entries to British Columbia. A lift in direct air capacity and a global reputation for a beautiful destination contributes to the increase of visitors.

Issue: Summary of 2017 Federal / Provincial / Territorial Tourism Meetings in Ottawa

Background / Facts:

- Three meetings related to tourism coordination across Canada took place in Ottawa September 28-29, 2017.
 - Canadian Council of Tourism Ministers;
 - Federal / Provincial / Territorial Tourism (FPT) Deputy Ministers; and
 - Tourism Ministers' meeting with National Indigenous Organizations.
- The Canadian Council of Tourism Ministers meets annually to discuss issues of importance to tourism across the country. In 2016, Ministers agreed to collaborate on implementation of a tourism strategy.
- The meeting was co-chaired by Canada Small Business and Tourism Minister Bardish Chagger (co-chair) and Ontario Minister of Tourism, Culture and Sport Eleanor McMahon (co-chair). Ministers also attended from Quebec, Manitoba, Saskatchewan, Alberta and Newfoundland.
- British Columbia was represented by Assistant Deputy Minister Claire Avison.
- Key discussion topics of interest to British Columbia included Canada-China Year of Tourism 2018, Indigenous tourism, the FPT Tourism Strategy, and Air Access.
- Presentations were also made by Ontario on Cycling Tourism; Destination Canada on marketing; Tourism Industry Association of Canada on competitiveness; Statistics Canada on tourism statistics collection and collaboration; and Business Development Bank of Canada on tourism business investment (see Appendix 1).

Analysis:

Canada-China Year of Tourism 2018

- Canada aims to double tourism visitors from China by 2021. Canada and China agreed in 2015 to create the Canada-China Year of Tourism 2018 to promote culture, sport and relations.
- Ministers agreed to:
 - Collaborate on a plan to showcase Canadian events and activities from all regions of Canada;
 - Strengthen Canada's readiness to receive Chinese tourists;
 - Undertake a mission of FPT Tourism Ministers to China in 2018.

Indigenous Tourism

- Indigenous political leaders from the Metis National Council and Assembly of First Nations met Tourism Ministers prior to the CCTM meeting followed by Ministers meeting with Aboriginal Tourism Association of Canada, AFN staff, Native Women's Association of Canada (NWAC), and Canadian Council for Aboriginal Business.
- Political leaders supported Indigenous tourism, speaking about the benefits of sharing their cultures to create relationships and develop local economies, and identified how tourism could also be an



effective tool for reconciliation. The NWAC identified the need to build capacity among Indigenous women to make their businesses market-ready.

- ATAC updated Ministers on progress developing Indigenous tourism:
 - Creation of Indigenous tourism associations in provinces and territories to lead development;
 - An increase in training program supports for Indigenous people;
 - Increasing demand for Indigenous experiences by aligning with Destination Canada's marketing.
- B.C. is leading development of Indigenous tourism at the FPT table, as part of the FPT Tourism Strategy, and ADM Avison reported out on the FPT Tourism Directors progress in 2017.

FPT Tourism Strategy

- The Tourism Directors Committee reported progress and next steps on the first year of the FPT Tourism Strategy in 2017. The key areas are competitiveness (marketing, sharing economy, air transportation, and workforce); product development (Indigenous tourism, parks tourism, and festival and events); and statistics and research. (See Appendix 2)

Air Access

- Transport Canada updated Deputy Ministers on air transportation policy and developments. In response to questions about potential privatization of major airports (i.e. YVR), Transport Canada noted the federal government has received the results of a study and has not made any decisions.
- Provinces and territories were encouraged by Minister Chagger to bring air access issues to the attention of Transport Canada Minister Marc Garneau.
- TAC staff continue to coordinate with MoTI to address YVR privatization concerns and provide input into Transport Canada's consultations on air transportation agreement negotiation priorities.

Conclusion / Next Steps:

- B.C. staff will participate on a sub-committee of the FPT Tourism Directors to provide input and help plan Canada-China Year of Tourism 2018.
- B.C. will continue to lead work on Indigenous tourism development this year including:
 - Finalize and distribute results of the Indigenous tourism survey of FPT jurisdictions;
 - Lead work to craft strategies for collaboration based on the survey;
 - Explore creation of a FPT statement of principles to guide Indigenous tourism development;
 - Continue engaging Canada Parks Council to seek opportunities for Indigenous tourism in parks;
 - Engage successful Indigenous tourism associations (i.e. AtBC) to share corporate best practices;
 - Continue to engage ATAC to better align Indigenous tourism development across Canada.
- In addition to leading Indigenous tourism as part of the FPT Tourism Strategy, B.C. will also engage on parks tourism, workforce, and festivals and events, reflecting the B.C. government's interests in these topics.
- The next CCTM meeting will be hosted by Alberta, expected to be held in October 2018.

Appendix 1

Summary of Additional Agenda Items

Cycling Tourism:

Ontario Minister McMahon presented Ontario's strategy to develop cycling tourism, including cycling safety legislation and infrastructure investments.

Competitiveness:

Tourism Industry Association of Canada CEO Charlotte Bell gave an overview of Canadian tourism to Ministers, stating Canada's competitiveness in the international marketplace is lagging. She noted airfares are 40% higher and acquiring visas is more difficult than with many of Canada's competitors.

Destination Canada CEO David Goldstein spoke to Ministers about the Crown corporation's increased emphasis on China; driving demand to shoulder seasons and secondary markets; and an increased focus on business and convention attraction.

Tourism Statistics:

Staff from Statistics Canada, Destination Canada and Manitoba spoke to Deputy Ministers about how PTs are collaborating with Statistics Canada to align priorities and resources and modernize Canada's tourism statistics programs. This is starting to provide robust statistics that are timely and relevant for all of Canada. Destination BC's Research Branch supports this work as a member of the Tourism Research Partners' Forum, along with provincial DMOs and major city DMOs.

Business Development Bank of Canada:

Business Development Bank of Canada's Peter Lawler told Deputy Ministers about the programs and support the bank is offering to tourism businesses such as hotels, golf courses and resorts. He spoke of programs that could help B.C. businesses affected by wildfires.



Appendix 2

Summary of FPT Tourism Strategy Progress 2017

On November 24, 2016 the Canadian Council of Tourism Ministers' (CCTM) agreed to a Declaration committing to collaboration to grow and increase the competitiveness of Canada's tourism sector. The Nunavut Declaration identified key priorities and actions to:

- Strengthen competitiveness by collaborating on marketing; broadening understanding of the sharing economy; facilitating communication on the importance of air competitiveness and access; and identifying potential solutions for labour and workforce challenges.
- Grow Canada's tourism offerings by exploring opportunities to collaborate on Indigenous tourism; festivals and events; and sustainability and economic development from federal, provincial and territorial parks visitation.
- Support a tourism statistical system in Canada that meets the information needs of decision makers.

Since the agreement to the Declaration, the FPT Tourism Directors' Committee has collaborated on all action items. The goal of this interim report is to update FPT tourism deputy ministers on the progress of implementation so far in 2017. Highlights of activities are as follows:

- In marketing, FPT marketing organizations are driving forward a new marketing initiative called North Star 22. This work features a multi-year planning framework from 2018-2022 and a shared dashboard with common performance measures.
- Ontario has led a series of information sessions that saw public and private stakeholders educate the FPT Tourism Directors' Committee on challenges and opportunities in the sharing economy.
- In air transportation, Alberta led the compilation of PT input in the annual consultation on priorities for air agreements' negotiations. Six PTs providing input which was shared with Transport Canada.
- On workforce action item, the FPT Tourism Directors' Committee met with Tourism HR Canada (THRC) to hear about research and analysis on occupational standards, labour market information, certification programs and a new accreditation process that is being developed. THRC also identified Indigenous communities as having excellent potential for contributing to the tourism work force.



- The FPT Tourism Directors Committee has opened a dialogue with the Canadian Parks Council (CPC), the FPT table for parks, to seek opportunities for sharing and collaboration. Alberta led tourism directors' input into a new *Parks for All* strategy that brought a sustainable tourism and economic development lens to the strategy. A working group has been established led by the Northwest Territories to develop areas for collaboration with CPC. Numerous other presentations and consultations have taken place with information sharing from Parks Canada, British Columbia, and ISED.
- Actions taken to advance national progress on Indigenous tourism development focused on obtaining a better understanding of Indigenous tourism and exploring opportunities for potential collaboration. The FPT Tourism Directors' Committee engaged the Aboriginal Tourism Association of Canada (ATAC) to better understand how ATAC is implementing its five year plan. British Columbia is leading a survey of jurisdictions to capture engagement on Indigenous tourism priorities.
- As lead on the festivals and events action item, Québec provided an overview of festivals and events in Canada through a jurisdictional scan that has been shared with directors. Inputs and updates were also collected from across the country.
- On statistics and research a Tourism Research and Statistics subcommittee was formed to develop recommendations for priorities related to statistics and research. 


