

I'm letting you know that there's been a small change to our funding agreement with the JUNO Host Committee.

The \$150,000 was originally intended to fund the BC Artist Showcase, the Juno Tour, and the Celebration Site. For a number of reasons, the Host Committee has chosen to cancel the BC Artist Showcase, and add the budget to grow the Experience Music Program, which awarded small grants to groups across the Province presenting music events leading up to the JUNOs. They have awarded grants to 26 events in a wide variety of locations, representing a wide variety of musical genres.

This change is reflected in the draft contract, which is now being reviewed by the Host Committee. Below are details about the three initiatives we are funding.

The 2018 JUNO Awards Host Committee will deliver the following three initiatives:

1. Experience Music Program: The 2018 JUNO Awards Host Committee, in partnership with Creative BC and Music BC, launched the 2018 JUNO Experience Music Program, offering grants up to \$1,000 for artists, venues, promoters, music organizers and entrepreneurs to present unique music experiences in the lead up to JUNO Week. These events will celebrate BC's local music community, create opportunities for local musicians to connect with new audiences, present music in a variety of venues across the province, and build excitement for the 2018 JUNO Awards.

Twenty-six unique events were selected to shine the spotlight on BC and the local music scene engaging audiences all across the province. Events vary widely in geography (Nanaimo, Fernie, Williams Lake, Kamloops, Surrey), genre (EDM, Indian classical, world music, hip hop, soul, Indigenous, reggae) and style (concert halls, clubs, pop-up performances) and will occur between February 2 and March 22, 2018.

Originally, funds were budgeted for a BC Artist Showcase, however the significant response from the community for EMP grants resulted in using BC Artist Showcase funds to support additional EMP events.

JUNO Tour: Acting as an extension of JUNOFest, the JUNO Tour will take a JUNO nominated/award winning headliner, supported by two local musician or bands, to both Kelowna and Victoria on March 21 & 22, prior to landing in Vancouver on the Friday of JUNO weekend (March 23). Acts will be announced in mid-February 2018. An open call to local bands to participate will go out early February.

3. Let's Hear it: LIVE! Celebration Site: In the heart of Vancouver, at the Vancouver Art Gallery, Let's Hear It Live will be two days of diverse and inclusive live music representing various music scenes from across the province. This free festival site will offer an accessible venue for all of Vancouver to enjoy, incorporating family-focused programming including music for all ages, as well as VIP zones for delegates and stakeholders. The site will be active from noon to 9 pm on March 23 & 24.
