- Mt. Timothy is a non-profit society with limited financial resources
- Mt. Timothy holds an Operating Agreement with the Province that gives them the authorization to use Crown land for resort development, maintenance and operations. In exchange, Mt. Timothy provides the Province with an annual rent.
