I did receive a voice mail from Judith advising me that you had passed this issue on to her, however I feel that you personally should be aware of what has been going on.

In late May I was contacted by a staff member with the Ministry of Tourism, Arts and Culture, asking that we work with them to plan an unveiling of the Chinese Legacy Project located on the On Lee property. This project was completed in the spring of 2017.

A decision was then made to coordinate with the Ministry staff and the community of Lytton for unveilings to be planned on the same day, thus allowing people to attend both events with less travel. The thought from the Ministry staff member was this would encourage more people to attend. The staff member made a trip to both Lytton and Yale to overlook the projects and discuss how we saw the events playing out, ie, timing, food, weather issues etc. Two dates were suggested and the date of July 28 was approved as the date that the Minister of Tourism, Arts and Culture could attend. An email was sent from my office on July 4 with a list of invited guests and I was told that an emailed invitation would be going out. I asked that once the invitation was approved I wished to receive a copy of it so I could personally send hard copies to certain guests as I felt that an emailed invitation was too impersonal. I was told that I would receive a copy. I was also told that the communications department would contact each invited guest after the invitations were emailed to ensure that they were received and encourage them to attend and that the Ministry's Communication department would be handling all of the invitations, the list of speakers, protocol and logistics. I was also told that the reception, cost of food etc. would be reimbursed to us.

Fast forward a couple of weeks. Last Thursday when I hadn't heard anything I proactively made a call letting Phillip Yong know that I would be unavailable for several days and was that I was hoping to speak with someone before I was out of the office. I came back this Tuesday morning to a message from the communications department from that morning asking me to contact them. After a couple of attempts, I spoke to a Cathy Dargie, who informed me she had just received the file on Monday (July 16) and when I questioned why the invitations hadn't gone out, she told me she been directed to email the invitations on Monday July 23. She asked what I had planned for the day of the event to which I let her know that I had been told her office was supposed to be handling all of that. I asked about the reception and being reimbursed for the cost of the food, she said she didn't know anything about that and would get back to me.

This morning I received a call from another staff member in the communications department, who had been passed the issue by Cathy. She understood that there was some confusion and wanted to get it sorted out. Long story short, it appears that there were commitments made by someone, that the communications department can not, or is not, allowed to commit to. They would like to reschedule a 'media' event for later in the summer.

From my end as of right now, I have let the communications department know that the only date on our calendar that is available is August 18, that we won't be providing refreshments, (as they do not cover the cost of that), and that I will let them handle all of the planning, invites, media etc. I also let them know that it was their Ministry that contacted us to work with us to plan an unveiling, not the other way around as they thought. And that right from the beginning, 18 months ago, it was always their suggestion to host both events on the same day, something they are now telling me is not possible.

On a further note and of the most importance is s.22

s.22 who were expecting to attend this event next Saturday, not to mention several calls to the Chief of the Yale First Nation, first for not getting an invitation out to him sooner and

secondly to let him know that the event is now postponed. I work with members of the On Lee family and Ken Hansen, Chief of Yale First Nation and his staff on various projects and issues that arise in our community and to say that I am upset about how this situation has been handled is an understatement. And at a time when the government's current mandate is, (quoted from a letter from Heritage Branch dated March 13, 2018), "undertaking to address commitment to true, lasting reconciliation with First Nations in British Columbia", and "engage indigenous people-for whom the land has held significance for time immemorial-in thinking about the cultural significance of the historic place you manage. And pursuant to these conversations, that you involve indigenous people in presenting to visitors the full time depth of the land in a way that acknowledges the heritage of indigenous people as well as other groups for whom the land has cultural significance; the intertwined history of indigenous, settler and other cultural communities; and the cultural significance of the land for all British Columbians".

I have invited the On Lee family to a small family reception this coming Saturday despite the cancelled event. And I have just now spoken to Ken and let him know that I will keep him informed if the event is being rescheduled.

I felt it was important that you know exactly what had happened and that this letter be kept on file in the event there is any negative fallout that reflects poorly on the Yale Historic Site and all of the hard work we are doing.
