Or anywhere, really. I am VERY excited about it and am looking to get involved to help make it a success.

## A bit about me:

I co-produce and host the <u>BC Was Awesome</u> history TV show. We've completed 27 episodes over the last 3 years, telling offbeat stories from BC's past. Dubbed as "a history show for people who don't like history" it's presented as fun and interesting stories (sometimes serious ones), geared towards everyone. We're going into our third season and the show airs on TELUS Optik, is being shown on Air Canada flights, and has had over two million views through our popular Facebook Page. It's been nominated for 3 Leo Awards. People can watch all of the episodes for free <u>HERE</u>.

- Over 360 Rohingya villages burned to the ground.
- Over 60% of those who fled violence into Bangladesh are women and children.
- Most children in the refugee camps are under age of 5.
- 80,000 women are now estimated to deliver their babies as a result of gang rapes by Burmese soldiers.
- Families are separated. Over 70,000 children have been orphaned

"Never again" was a promise against genocide after humanity had failed to protect Jewish people from Nazis in Germany during WWII.

Half a century later, humanity still fail to prevent more genocides from happening. We are reminded of the Rwandan genocide, Bosnian genocide, Cambodian genocide;many genocide are well known, but many more remains unheard of.

Genocide never happens overnight. It's a process in which the victims slowly become dehumanized, delegitimized, segregated, and eventually annihilated. In the case of Rohingya, and many minorities in Myanmar, their rights were slowly taken, strategically removed from any position of power to make any change, and by the time we realize how badly Rohingya have been oppressed, they have lost their entire ancestral land. They have bore the effect and the fallout of genocide all on their own for the last 50 years. Now, it's time, the international community take a stand against the dictatorial regime, Myanmar is.

We cannot idly standby while another genocide carries on in full fledge right before our eyes and pretend that things will get better on its own. Remember, these are human lives. These are people who struggle to survive just like us. It is time for us to give them the voice, and let them know that WE CARE. Not just in words, but in actions.

Let's make the world aware of how urgent the Rohingya genocide is. Let's march, and let's protest against injustice being done to all. Let's stand in solidarity with every oppressed community. Let's make "never again" mean more than just a passing word used only when convenience.

Vancouver will stand with Rohingya people this August 25, 2018.

This is an event to commemorate genocide of Rohingya people. It is also held across Canada, and internationally.

Thanks so much for spending some time with me this morning. It was great to get an opportunity to touch base about some of the initiatives we are trying to get going in Surrey. As requested, I am summarizing informally some of the activities that could potentially provide an opportunity for Provincial involvement.

As you know it has been almost 20 years since the Provincial government committed to a major investment in Surrey City Centre through the Central City project. Since then virtually all the public investment in the city centre has been undertaken by the City. While this has been very positive, to reach the critical mass necessary for the city centre to really take off I believe that it will be important for the senior governments to get much more involved and to provide further investment. Some of the initiatives we are undertaking and exploring in the city centre include:

- 1. In conjunction with CoS and SFU, we are undertaking a master planning effort for the 6.5 acre "centre block". This includes the lands currently being used for the North Surrey Recreation Centre (scheduled to be replaced and demolished by the end of next year) and the neighbouring bus loop and parking area to the south. This plan will provide a much-needed vision for the city centre and will help to chart some the next critically important city centre development opportunities (both commercial and academic). It is anticipated that these lands will accommodate in excess of 2 million sf and will provide an opportunity to significantly build up the office space inventory in this part of the region. We anticipate this work being completed by the end of the year or early next year.
- Discussions are underway with the Federal Government through the Ministry of Public Services and Procurement Canada (PSPC). The Mayor has had fruitful discussions with the Minister (Carla Qualtrough) last spring which were followed up by meetings with senior Surrey and PSPC staff both in Ottawa and Vancouver \$.13, \$.16, \$.17
