Dear elected representatives,

I'm against the PavCo tower development because it will block Vancouver's public views of the skyline

Vancouver's skyline with mountain backdrop is why the city is so unique and beautiful. It is a free public amenity and asset that make Vancouver famous around the world. The view also makes Vancouver a livable and healthy city.

Like many people living and work in Vancouver, I enjoy viewing the skyline with the mountain backdrop. I like taking photos of the Vancouver skyline with the mountain backdrop

The reasons I oppose the PavCo tower are:

- The City and Province of BC should not privatize our free public views and sell it off to developers to build million dollar condos.
- Vancouver's public views are an irreplaceable free public asset and should not be blocked by private multimillion dollar condos.
- We must protect our public views for the next generation.
- Sets a bad precedence for other real estate developers to pressure the City to let them penetrate protected view corridors/cones.

There are many alternatives to mega towers for Vancouver. 75% of Vancouver is one floor or single family houses. Vancouver should focus on low or medium height development instead of these Mega towers. I sincerely ask the Council to approve a lower tower alternative of under 300ft that does not penetrate the view of our great city.
