On behalf of Minister Beare and Minister Fleming, I am happy to respond.

Creative BC is the provincial agency of record for the administration of the Amplify BC program. Their programs, services and investments are designed to help the province's creative sector (motion picture, interactive digital, music and publishing) realize its economic potential and contribute to the future prosperity of our province.

The Amplify BC program is open to all professional musicians, of all genres, including classical and experimental. Due to the economic focus of the fund, it is designed to support musicians who have structured their career as a business. In a sole proprietorship, one person performs all the functions required for the successful operation of the business and assumes all the liabilities. The sole proprietor is said to be self-employed.

Registering a business as a sole proprietorship allows for the generation of a business number. This provides the musician with the ability to establish a business bank account; it is also used as an identifier for remitting taxes to government, Canada pension premiums, EI premiums, and making WorkSafeBC payments. The \$70 fee is a one-time cost to the applicant. Subject: Concern about accessing funding through Creative BC for Music Industry

Dear Hon. Rob Fleming, and Hon. Lisa Beare,

I am hoping to find the best person to direct my concerns with the barriers to accessing funding through Creative BC, specifically the BC Music Fund and Amplify BC.

Increasing funding to Creative BC was toted as an influx of money to the BC Music industry. There is a barrier within the eligibility requirements that, in my opinion, feels like an intentional deterrent a certain type of music professional from applying to these programs.

BC has a strong base of music professionals working as sole proprietors under their personal names. Many of these have made long careers in the music industry in BC. In my circles, most of these people have music practices coming out of classical or experimental music traditions.

The issue is that in order to apply for funding, one must register their business. This comes with upwards of a \$70 fee. As sole proprietors functioning under personal names, it is my understanding that this is an unnecessary step to working as a professional musician in British Columbia.

This requirement in the application means that one needs to pay a \$70 fee to access funding. Completing this step as a sole proprietor, there is no perceived (or possibly any) additional benefit aside from being allowed to submit a application to this specific program. It is worth noting that funding programs are highly competitive and there is no guarantee of a successful application.

I have been working as a professional in the music scene in BC for more than 10 years now, and have had conversations with people who have been working much longer. My understanding is that this is the only funding application available to BC Musicians that is funded by the provincial government which requires this step and the payment of this fee.

I see this as a problematic fee within the context of a funding application. It creates, for some an actual barrier and for others a perceived barrier. Because of this requirement it is preventing some BC Music professionals from feeling that this is a program is intended for them. In my opinion, some of these are professionals who would benefit the most from these applications.

I initially felt that this funding was not intended for a professional like myself, and was a veiled attempt to exclude musicians coming from classical and experimental music backgrounds, however, after speaking with people from Creative BC, they stress that this is program is available to all musicians of all musical genres.

I am optimistic that there is a solution that eliminates this barrier to sole proprietors functioning under their personal names.

Thank you for hearing my concerns.
