(3) The Lieutenant Governor in Council may make
regulations

(a) prescribing a period in each year in
which a reference to time is, for general
purposes in British Columbia, a reference
to Pacific Daylight Saving Time, and

(b) varying the reckoning of Pacific
Standard Time.

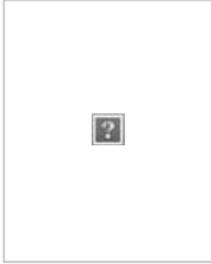
