opening bars of a very famous opera, transporting the audience back in time.

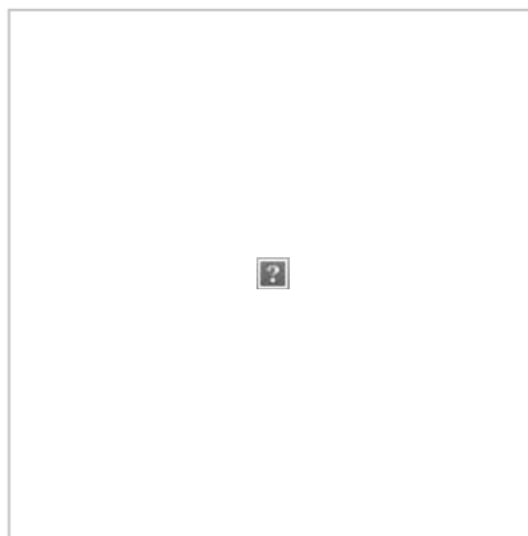
