- The naming Rights RFP is scheduled to close at 2:00pm on May 15, 2019.
- Following the RFP closure, PavCo will review all proposals and meet with proponents as required.
- PavCo will then present options and make a recommendation to government for decision.
- Government decision is anticipated early in the fall.

Q.3 Can I get some detail please on the land that is expected to be sold for \$15 million by 2020-21 (p. 14. Footnote number 1). Is the \$15 million proceeds on the land sale net of \$8.5 million accommodation payment to First Nations in 2018?

<!--[if !supportLists]-->• <!--[endif]-->PavCo owns a parcel of land known as Area 10c, located adjacent to the Stadium below the proposed Georgia Street extension, which has significant development potential.

<!--[if !supportLists]-->• <!--[endif]-->PavCo's Service Plan recognizes this future revenue potential in the budget for 2021/22 under 'Other Revenues', with an approximate valuation of \$15 million. The \$15 million valuation is an estimate carried forward from previous years, and does not necessarily reflect the present or future valuation which may result rezoning of the land, or other factors.

no immediate plans at this time to sell the land. Following Vancouver City Council's decision in 2018 to approve the rezoning of Area 10C with two options, we are working with the City, First Nations and other stakeholders as it considers various options for this land.
