Hi There

I'm looking for some educated stances on how to restore our salmon stocks. Is the salmon a important animal to this organization?

From what I see there are a few things that have been done and some that haven't.

One is the locations of some of these fish farms. Is it really a good idea to continue the same practices? We have the majority of the farms on major migration routes.... Should we be looking at closed systems?

Next is the damage done by log holds and the bark that falls off the trees. Most of these holds are in the mouths of rivers and estuaries. Is there something we can do to clean-up the bark and restore some of those habitats? How long does it take for the bark to biodegrade in the salt water? How far does it travel in the currents?

Logging, urbanization of streams, pollution of the various waterways, both fresh(spawning streams and rivers) and salt, over fishing, lack of proper management of the various user groups taking advantage of over harvesting due to lack of surveillance (I e. over limits by sporties, poaching by various groups at the mouths of spawning streams and in the rivers and streams, poor management of actual "real numbers" of over fishing quotas, and lack of current accurate numbers of spawners returning to all of our spawning systems, and the list goes on.

Many thoughts were aroused after reading the following papers.

1. The current Salish Sea Marine Survival Project on Predation by Ben Nelson, et all.
2. Seals and sea lions may be slowing salmon recovery, hurting Orcas. By Chistopher Dunagan.
3. Several papers posted in the Columbia Basin Report.
4. An extensive paper presented by the Gill Netters Association in the late 1900's
5. Brandon E.Chasco et all NOAA
6. Dr.Walters et all Oceans and Fisheries at UBC
7. Pacific Salmon Foundation Salish Sea Marine Survival Projects
8. Peter Olesiuk Oceans and Fisheries at UBC

Several very significant scientifically proven facts stand out and run a common thread through the above papers.

1.Harbor seals, protected by the Marine Mammal Protection Act of 1972 have nearly doubled in numbers in the inland waterways since 1972—going from 210,000 to 355,000

On the North East Pacific they grew from 350,000 to 1,126,469

2.California sea lions grew from 5,900 to 47,000
increased from 74,400 to 78,500

3. Stellar sea lions

4 Transient Orcas grew from 294 to 644

population grew from 8,600 in 1975 to 80,000

To summarize the numbers from the Gill Netter Association. These numbers come from D.F.O. publications

FOOD CONSUMPTION OF THE ABOVE GROUPS.

Has anyone found any written evidence of the break down of their food groups?

using the consumption numbers published in the above papers. For Harbour seals, they range from 5lbs/day to 14lbs/day

The consumption numbers for California sea lions range from 30lbs/day to 50lbs/day.

The numbers for Stellar sea lions ranged from 40 to 60lbs/day

The numbers for Fur seals was stated at 5.5lbs/day

For simplification of the math use the following rounded consumption numbers

1. Harbour Seals 10 lbs/day
2. California Sea Lions 40lbs/day
3. Stellar Sea Lions 50lbs/day
4. Fur Seals 5lbs./day

The consumption math falls into place as follows for the current time period

Species Herd size Pounds/day total lbs./day

Harbour seals 1,126,469 10 11,264,690

California lions 339,600 40 13,584,000

Stellar lions 356,000 50 17,800,000

Fur Seals 2,898,000 5.5 15,939,000

That does not include the consumption by Orcas (664 outside 70 inside)

Grand totals: 58,587,690lbs/day!!

Totals per month (assume 30 day month) 1,757,631,000 lbs/mo

That is 878,810 tons/mo.

1 current seine boat can hold 55 tons which equals 15,978/boat loads/mo!!

For sake of argument lets assume that that consumption rate is 50% of various salmons (Chinook, coho, sockeye, pinks, chums, steel head) which is most likely a low number.

The numbers for salmon consumption (remember no Orcas included here) would be: 439,405 tons/mo

Again for easy math, lets assume the average weight of salmon to be 10 lbs. There for consumption of salmon in this analysis would be: 4,394,050 salmon/mo!!

The growth rate of the seals and sea lions et all averages 10% plus (compounded)/year and the production of salmon is not even close to keeping up to this number.

Now we add in the destruction (consumption) caused by seal predation on smolts in the estuaries to this mix.

Dunagan states the production of Chinook smolts alone in the West Coast area, including hatcheries and wild is 29,000,000.

He also states that the consumption of Chinook smolts to be 85% or 24,000,000.

Similar current studies (as stated above) on the Big Qualicum, Cowichan and Puntledge show that the seal predation to be 1 kg/seal/day of coho smolts. At 2g/smolt that is 100 coho smolts/day x how many seals ?

The above study (of which the P.S.F. was also involved) did not include Chinook.

These are staggering numbers and need to be addressed as soon as possible.....while I don't believe there is issues in all areas on the coast but I obviously see that it is around the Fraiser and cowichan area when salmon are spawning. Should they be protected or managed? While I dont believe culling a species is a answer I do believe that being able to harvest to balance some streams and rivers might be good.

What can we do as individuals and organizations to improve this? What can we do now to make immediate impacts on salmon restoration?

The wild salmon stocks are declining at a alarming rate and will threaten many species that rely heavily on these salmon but there is no immediate action. Once a river or stream goes dead there is no coming back..

Predators are threatening this animal. Poor agriculture is threatening this animal. Damage to their environment is threatening this animal. Dams and climate change are threatening this animal.

People of the coastal and fishing communities don't want this species to die. There are a lot of people, communities, cultures, and animals that depend on it's survival. Our jobs and our livelihoods are at stake. The time for procrastination is over we need to come up with a management plan to address all areas of concern so our children can hope to have some of the opportunities that we have had.

I am writing with regards to concerns I have about the BC ferry system.

the ferry system is an accepted part of our life.

However in the last couple of years I have found the system becoming elitist with those having disposable income able to jump the queue with reservations. This cash grab is an unfair bias against people that do not have disposable income to spend on reservations. \$30 for reservations for a return trip can buy a lot of food for a family.

The BC ferries are a required form of transportation s.22 – there is no other way – except seaplane which is even more costly.

There is absolutely no reason for reservations. We all need to reach our destination and this system should be first come first serve (residents & tourists alike) especially as the ferry system represents part of the BC and Canadian highway system. We don't pay to get first in line on BC highways and that shouldn't happen on the ferry system either. The only caveat I can see to reservations would be for persons with a medical pink slip and a physician's note indicating they have had surgery or chemo treatments where they are feeling very sickly. Those of us that cross for other random medical appointments are quite capable of waiting in line.

Please stop this elitist system of jumping the queue. If line-ups are such a problem then more ferry runs are required not disposable cash from riders.

I would have copied this to BC ferries but they have no email address on their website so I have sent this same letter to them through their online system.

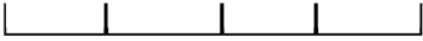

This cash grab is an unfair bias against people that do not have disposable income to spend on reservations. \$30 for reservations for a return trip can buy a lot of food for a family.

The BC ferries are a required form of transportation^{s.22} – there is no other way – except seaplane which is even more costly.

There is absolutely no reason for reservations. We all need to reach our destination and this system should be first come first serve (residents & tourists alike) especially as the ferry system represents part of the BC and Canadian highway system. We don't pay to get first in line on BC highways and that shouldn't happen on the ferry system either. The only caveat I can see to reservations would be for persons with a medical pink slip and a physician's note indicating they have had surgery or chemo treatments where they are feeling very sickly. Those of us that cross for other random medical appointments are quite capable of waiting in line.

Please stop this elitist system of jumping the queue. If line-ups are such a problem then more ferry runs are required not disposable cash from riders.

Q: Is this lighting project as a result of the tragic pedestrian death earlier this year?

A: Anytime there is an accident (fatality or injury) it is a terrible thing – and it deeply impacts the whole community. Our hearts go out to the family and friends of the victim.
From 2013 to 2017, there were 471 collisions on this section of highway that currently has no lighting – so it's very difficult for drivers to see pedestrians and cyclists, especially at night and in bad weather. 8 of these crashes involved pedestrians and 7 involved cyclists. We've heard the concerns about the lack of street lights along this popular route, and we are taking action by installing new lighting. This will make it safer for everyone who travels this route.

As a constituent in your riding, I am writing to thank you for your increased investment of \$5M in the BC Arts Council over the next three years. Your investment clearly illustrates that you understand the important economic and social value of the arts, culture and heritage in communities around the province.

The much-needed increase to the BC Arts Council will make a difference to the sustainability of arts and culture organizations in BC. With a combined workforce of over 98,000 cultural workers in BC and a cultural GDP of \$7.2 billion, the cultural sector represents 4% of BC's economy.
