Request

The reporter is inquiring about the Vancouver Whitecaps and related allegations about coaching and abuse of athletes and is looking for comment from government.

The reporter would like to know:

1. Do we provide them with any funding?
2. Do the Whitecaps rent property tied to government, such as BC Place?

Recommendation – Provide Statement from Minister

For release on background (not for attribution):

- The Ministry of Tourism, Arts and Culture does not provide any funding to the Whitecaps. The Whitecaps have a licence agreement with the B.C. Pavilion Corporation. The agreement relates strictly to the use of BC Place Stadium for the Whitecaps professional soccer team.

Information related to the request:

In February 2019, allegations of abuse by a former coach of the Whitecaps FC women’s team and Canada’s women’s under-20 national team were brought forward by former player Ciara McCormack in a blog post. The full post can be read here: <https://bit.ly/2W6iFfx>

McCormack claims Canada Soccer and the Whitecaps did not adequately address or investigate her concerns. More allegations came out in a statement issued on April 1st from a group of players of Canada’s under-20 women’s national team from 2008.

Whitecaps FC issued an unsigned statement on social media on April 17th in response to the allegations stating the club is in “active communication with the VPD” and is “initiating an independent third-party review of its respectful workplace policies procedures.” See statement at: https://vancouver-mp7static.mlsdigital.net/elfinderimages/2019/club-letter/WhitecapsFC_letter.pdf

This response, and the lack of action prior, led to a walkout by supporter groups and fans at BC Place on April 17th to protest the club’s handling of the accusations. More information on the walkout

On April 23rd, 2019 news reports broke about a coach currently working for the Whitecaps FC West Kootenay academy in Nelson, BC. In 2013, Brett Adams left his coaching job in England while being investigated for allegations of racism. Adams was hired by Whitecaps FC in October 2013.

Whitecaps FC President Bob Lenarduzzi says the team was not aware of the allegations against Adams at the time and did not learn about his situation until 2015 when the Football Association in England suspended him and imposed a fine. The Whitecaps reached out to the Nelson Soccer Academy who said Adams had proven to be, “a good member of the community.” The club did “not feel pulling Brett out of the community would have been the best thing for our kids.”

In light of the recent news reports, Lenarduzzi said, “Everyone was fully aware,” of what had happened in 2013 and Adam’s conduct in the years following, however, “We said he deserved a second chance.” For reference, see The Province article:
