**Delta Grinding Facility (Minister Doug Donaldson – Ministry of Forests, Lands, Natural Resource Operations and Rural Development)**

On May 7, 2019, the federal Minister of Environment and Climate Change has granted substitution of the environmental assessment process for the Delta Grinding Facility Project (Delta Facility) to the Environmental Assessment Office (EAO). EAO is proceeding on behalf of the federal Crown as set out in the Memorandum of Understanding between the Canadian Environmental Assessment Agency and the British Columbia Environmental Assessment Office on Substitution of Environmental Assessments (2013).

The Delta Facility would involve the construction and operation of a supplementary cementitious material grinding facility and marine terminal on Tilbury Island in Delta, British Columbia. The Delta Facility is anticipated to have a production capacity of 650,000 tonnes of material per year over a predicted 40-year operating life.
