"My priority as Agriculture Minister is to help farmers farm. Serving food and other farm products on the farm can be an excellent way for farmers to build and sustain their businesses.

Provincially, one issue is the current rule that allows only alcohol-producing farm businesses to serve small amounts of food, without application to the ALC.

To be clear, that rule has been in place for more than a decade, and it is not a change made by our government.

Our government continues to make farming and ranching a priority in B.C. and we have undertaken a comprehensive approach to preserving the ALR to ensure it is available for farmers and ranchers now and into the future.

We are also committed to continue to enhance the supports and resources for farmers and ranchers and this could include policy changes related to value added activities on the ALR such the serving of food raised or grown on the farm to consumers.

At the same time, it is also my duty to make sure the long-term integrity of the Agricultural Land Reserve is protected.

# Support for Agri-Tourism in the ALR:

- The previous government established rules for serving food in the ALR.
   Generally, restaurants have always required a decision from the ALC to operate on the ALR.
- The only change made by the current government was to level the playing field so that all alcohol producers in the ALR had the same opportunities as those that were previously provided only to wineries, including the ability to operate a food and beverage service lounge. Government is considering whether further changes are needed to the old rules to better support producers, while continuing to protect the ALR.
- The current rules on events in the ALR were introduced by the previous government in 2016. They have been in place for three years and have not changed.
- Landowners wishing to hold events that exceed the criteria in the 2016 regulation can apply to the ALC, which will make an independent decision on their applications.
- Similarly, the regulations regarding serving food on the ALR were established by the previous government over a decade ago and have not changed.
- Farm businesses that produce alcohol are able to serve food, though nonalcohol producers are not able to serve food at this time.
- Supporting farmers to hold events to celebrate and sell farm products on their properties is a key part of helping farmers farm.

It's that time of year again! Can we connect for a quick call? We're producing a Heritage Minute about Elsie MacGill "Queen of the Hurricanes.

She's hands down one of Canada's most amazing people and a major pioneer for women in STEM and we thought the BC government would be interested in being involved. She's also an incredible Vancouverite and British Columbian - she learned to swim from Joe Forte, had drawing lessons from Emily Carr and attended UBC for 2 years.

MacGill led Canada's fighter plane production in WWII and was likely the first woman in the world to get a degree in electrical engineering and also the first to get a masters in aeronautical engineering. She was also a force in women's rights during the 1960s and 70s - both her mother and grandmother were suffragettes. Honours include: Order of Canada, Centennial Medal, Amelia Earhart Medal. She's also a member of the Aviation and the Canadian Science and Engineering Hall of Fame.

The problem is that the average Canadian hasn't heard of Elsie, which is why <u>Historica Canada</u> - the not-for-profit that funds and makes the Heritage Minutes - is producing this one. It's actually the second Minute we've had the honour of producing with them. The recently released <u>Vancouver Asahi</u> was the most watched Minute yet, and the first BC-based production of a Minute.

Historica has provided base funding to produce this Minute, but we're looking for title sponsors to each

contribute up to This additional funding will allow us to do Elsie's story justice. In particular, some of the important historical recreation that will really bring the story to life. Most importantly, we want to include a scene with one of the actual remaining Hurricane planes as Elsie went on each test flight. 

It might be useful to give you a brief update on where things are at. Please forgive me if I'm repeating what you already know. Alternatively if you want more info on any point I'd be happy to provide it.

As I'm sure you know as a result of our bid submission (which I am assuming you saw, but let me know if you don't have it and I will get you your own copy) we were shortlisted with two other cities (we still don't know which ones). Subsequently we have had a series of video conferences with the Invictus Games Foundation (IGF) staff to further refine and develop the bid and to respond to their questions.

I also took the opportunity two weeks ago to go to London to meet with the IGF to do some "relationship building". More specifically we were able to have the Premier attend a meeting with the IGF at Canada House. In that meeting the Premier was an absolute champion for our bid. He very clearly expressed the absolute commitment of his government and the Feds to host the Games. We really couldn't have had a better advocate. We have subsequently heard back from IGF that their Board (including Prince Harry) are very impressed with our Bid and the support we clearly have from government. s.22 s.22

The next step will be for the IGF's CEO (Dominic Reid) to do a site visit. He will visit all three cities and report back. The visit to Victoria is tentatively scheduled for August 24-27 with the working days being the 25th and 26th. With the Premier's assistance and support we are hoping to arrange a reception at Government House for the evening of the 26th with the key supporters of the bid

from the province and local governments along with members of the local sport community and potential volunteers. This will be an important opportunity to demonstrate broad government and community support as well as to introduce many of the key players that would be involved in hosting the Games themselves. (I hope it goes without saying that having you there would be incredibly helpful).

After the site visit we are expected to attend a formal presentation of the bids in London on or about September 17.

Thanks again for working your magic to connect the Premier with Invictus COO Richard while you were recently in London. Richard shared how positively impactful that was, especially regarding hearing firsthand from the Premier about BCs (and Canada's) strong commitment to the 2020 Games. I'm sure you got the photos from the meeting...

Our team continues to have weekly contact with the Invictus CEO and COO regarding Bid specifics, and we continue to feel the relationship is getting closer and very aligned. One key update is the tentative date of Aug 26/27 for their multi-day site visit to Victoria. We should get confirmation next week, and will share the "program" detail once signed off with London. The hope is to hold a small reception at Govt House, and invite Govt leads and Invictus to speak, meet, and socialize. We also learnt that our Bid presentation (with the other two proponents) is tentatively scheduled for September 15 or 16 in London. The final decision should land by the end of September, and then we're off an running hopefully. Obviously we will keep you and other key Govt (BC/Fed/Municipal) leads updated.

In terms of advice, we need a short term injection of modest funds (\$50k) to: host their visit; prepare our final presentation; and go present. As you may know, all cash so far to support the Bid came from founding organizations (ie, Tourism Victoria) and local Municipal supporters. The new amount essentially matches the dollars raised to get us in the game and now to be down to the final three. We're wondering where to land this ask please? I'm working up a description to support it. Any and all thoughts are really appreciated.





- Innovation (Canada-BC Agri-Innovation) Provides funding to support promising new products, practices, processes and technologies.

The space is 2 buildings, 20,000 sqft with working artist studios, a gallery & event space for performance works.

While the City Council's recent vote to alleviate 2% of the tax burden over the course of 4 years, for businesses is appreciated, the reality is that 2% over 4 years on a \$100,000 of annual tax does not significantly affect a small non-profit organization like ours. As you know, many cultural organizations have already been snuffed out and we continue to face the reality that we will likely board up the windows this year if change is not imminent. Meetings are ongoing with the landlord for lease renegotiation, but this does not look like a real solution and closing has become a clear reality before years end. After 15 years of contributing to our community, this is will be a travesty.

The Beaumont Studios in addition to many other arts organizations in Vancouver need long-term solutions to help survive as cultural spaces. Hyperinflated real estate prices and the way property taxes are evaluated create unrelenting financial pressure for triple-net leaseholders. In 2014, the property we lease was assessed at \$4 million; in five years, it rose to almost \$13 million. Why? There is a dawning recognition that ungoverned forces have been at play.

This "best use" evaluation determines the very real taxes we pay. Every year we are taxed as if we were a luxury car lot or corporate tower but we are not; the majority of our residents in our space that pay rent are low-income artists in business for themselves, professional hobbyist or cultural sector workers and all have become struggling local taxpayers. The past few years have all but killed us to continue living in this city, our home.

To date, we have had years of long-running conversations with Arts & Culture staff members Diana Leung and Alix Sales. We have met with Andrea Reimer and Heather Deal on many occasions, both at our venue and at City Hall. We have spoken with Grace Cheng (Director of Finance office) and Marty Radakovich (City

Assessment), George Heyman (MLA) and many others, including Mike Weibe most recently. Yet still, there has been little to no action nor much reassurance that any is forthcoming. Meanwhile, land values spiral up and our countdown clock ticks faster. We need acknowledgment that CoV has heard us, and are coming up with real concrete solutions and fast when it seems over the course of these years, no actual action or resolve has happened and this approach of non-activity has got to stop.

In fall 2017, we became aware of some legislation that could make all the difference. We have presented it to all of you over the years since all of you. The existence of this legislation has been confirmed and explained by Nick Damian of BC assessments (see his letter below). In the spring of 2018, The Beaumont met with many of our key stakeholders and members of our fellow arts organizations with the intention to mobilize, lobby and advocate to find a solution to the shared cultural space crisis. We concluded that we must entreat the City Council to direct City Staff to use legislation section 396(f) for our cultural space as it is in their discretion to do so.

How do we begin this process? This is our formal request that the process of enacting this legislation begins as soon as possible.

The legislation states that indeed "the city has the authority at their discretion to offer a promissory exemption of property taxes to not-for-profit organizations like ours". Creating a separate category of/for non-profit cultural groups would be immediately recognized by the Assessment Authority, giving the city/council the power to relieve groups like ours from 100% of the property tax burden. Which is so desperately needed, urgently.

We are not a big business. We are not a corporation. We are not driven by foreign capital or organized crime. We are local people who live and serve in the community. We are part of the culture of Vancouver. We are one of Vancouver's longest and last standing arts hubs.

Our request is that we work together to implement the legislation. The control is in the hands of the city, not the province and not the property owner. Any use of this legislation should mandate that the landowner must be transparent, as ours is, and pass the exemption to the non-profit organization, such as ours holding long term triplenet leases, which is the only place where the respite can exist.

The city has the flexibility to set the term of any relief from 1 to 10 years. Consider beginning by making for 1-5 years and revise it as the market changes, which we sincerely hope it does. This approach would not lock the city into something that is detrimental over the long term. Our goal would be 100% relief from property taxes as long as we remain a non-profit organization in this current space. Same as if we were an arts organization that owned the property, which is exempt at a provincial level. This inequity between leaseholders vs. owner arts organizations is simply inexplicable.

If an owner of an empty lot can throw up a box of dirt, call it a community garden, and get a tax break then please consider the positive effect that people working with people can have on a community. And please consider the effect of yet another arts organization boarding up its windows and then in turn, pointing fingers back at the city of Vancouver for not taking the steps they could have to prevent it. We want to be a symbol of endurance and Vancouver spirit and this council can be a part of that positive example of a city that cares about its culture, not another casualty of too little, too late.

We are eternally grateful for your consideration to help us in this process. We believe that change is coming and the real estate turbulence of the past few years is subsiding under new controls. We are thankful and hopeful that you have our back in this almost impossible situation.

Most recently I sent word to the City Manager, Sadhu Johnstone and hope that with between our pleas to the council members, the Mayor, Mr Johnstone and yourself that the process of moving this legislation ahead will be considered with much

## seriousness.

This "best use" evaluation determines the very real taxes we pay. Every year we are taxed as if we were a luxury car lot or corporate tower but we are not; the majority of our residents in our space that pay rent are low-income artists in business for themselves, professional hobbyist or cultural sector workers and all have become struggling local taxpayers. The past few years have all but killed us to continue living in this city, our home.

To date, we have had years of long-running conversations with Arts & Culture staff members Diana Leung and Alix Sales. We have met with Andrea Reimer and Heather Deal on many occasions, both at our venue and at City Hall. We have spoken with Grace Cheng (Director of Finance office) and Marty Radakovich (City Assessment), George Heyman (MLA) and many others, including Mike Weibe most recently. Yet still, there has been little to no action nor much reassurance that any is forthcoming. Meanwhile, land values spiral up and our countdown clock ticks faster. We need acknowledgment that CoV has heard us, and are coming up with real concrete solutions and fast when it seems over the course of these years, no actual action or resolve has happened and this approach of non-activity has got to stop.

In fall 2017, we became aware of some legislation that could make all the difference. We have presented it to all of you over the years since all of you. The existence of this legislation has been confirmed and explained by Nick Damian of BC assessments (see his letter below). In the spring of 2018, The Beaumont met with many of our key stakeholders and members of our fellow arts organizations with the intention to mobilize, lobby and advocate to find a solution to the shared cultural space crisis. We concluded that we must entreat the City Council to direct City Staff to use legislation section 396(f) for our cultural space as it is in their discretion to do so.

How do we begin this process? This is our formal request that the process of enacting this legislation begins as soon as possible.

The legislation states that indeed "the city has the authority at their discretion to offer a promissory exemption of property

taxes to not-for-profit organizations like ours". Creating a separate category of/for non-profit cultural groups would be immediately recognized by the Assessment Authority, giving the city/council the power to relieve groups like ours from 100% of the property tax burden. Which is so desperately needed, urgently.

We are not a big business. We are not a corporation. We are not driven by foreign capital or organized crime. We are local people who live and serve in the community. We are part of the culture of Vancouver. We are one of Vancouver's longest and last standing arts hubs.

Our request is that we work together to implement the legislation. The control is in the hands of the city, not the province and not the property owner. Any use of this legislation should mandate that the landowner must be transparent, as ours is, and pass the exemption to the non-profit organization, such as ours holding long term triple-net leases, which is the only place where the respite can exist.

The city has the flexibility to set the term of any relief from 1 to 10 years. Consider beginning by making for 1-5 years and revise it as the market changes, which we sincerely hope it does. This approach would not lock the city into something that is detrimental over the long term. Our goal would be 100% relief from property taxes as long as we remain a non-profit organization in this current space. Same as if we were an arts organization that owned the property, which is exempt at a provincial level. This inequity between leaseholders vs. owner arts organizations is simply inexplicable.

If an owner of an empty lot can throw up a box of dirt, call it a community garden, and get a tax break then please consider the positive effect that people working with people can have on a community. And please consider the effect of yet another arts organization boarding up its windows and then in turn, pointing fingers back at the city of Vancouver for not taking the steps they could have to prevent it. We want to be a symbol of endurance and Vancouver spirit and this council can be a part of that positive example of a city that cares about its culture, not another casualty of too little, too late.

We are eternally grateful for your consideration to help us in this process. We believe that change is coming and the real estate turbulence of the past few years is subsiding under new controls. We are thankful and hopeful that you have our back in this almost impossible situation. Most recently I sent word to the City Manager, Sadhu Johnstone and hope that with between our pleas to the council members, the Mayor, Mr Johnstone and yourself that the process of moving this legislation ahead will be considered with much seriousness.

I look forward to hearing from you and thank you in advance for any of your time and efforts.

I write today on behalf of The Beaumont Community – its 100 resident artists, 10 employees, dozens of volunteers, membership base of 600 members, and our extended community of thousands – We would like to state in advance our gratitude for your consideration to champion with us towards solutions to the devastating situation of how this year's property taxation increases will impact our organization and the impending door closure of our space, which is currently being considered and prepared for by December 31st, 2019.

While the City Council's recent vote to alleviate 2% of the tax burden over the course of 4 years, for businesses is appreciated, the reality is that 2% over 4 years on a \$100,000 of annual tax does not significantly affect a small non-profit organization like ours. As you know, many cultural organizations have already been snuffed out and we continue to face the reality that we will likely board up the windows this year if change is not imminent. 



Dear Parliamentary Secretary Kahlon, Minister Ralston, and Minister Beare,

Surrey's upcoming 5X Festival staged by the Vancouver International Bhangra Celebration Society (VIBC) is a place where global South Asian culture and identity can be expressed, embraced and reconnected. Since 2004, the VIBC has been dedicated artistic expression and representation that inspires cross-cultural creativity, community engagement and inclusivity between ethno-cultural boundaries.

However, the VIBC has recently received opposition from the Surrey RCMP over the anticipated performance of an influential voice in Punjabi music, Sidhu Moose Wala. Currently, Assistant Commissioner Dwayne McDonald has advised the City of Surrey of his view that Sidhu Moose Wala poses a public safety risk. As such, the City and the venue, Center City Mall, have postponed VIBC's permit for this rapidly approaching festival. The venue owners have given us until 5pm PDT today to pull Moose Wala from our line-up.

This opposition to Sidhu Moose Wala's performance is ill-informed and perpetuates misunderstandings of the South Asian community in Surrey.

It has been brought to the RCMP's attention that two appearances by Sidhu Moose Wala were marred by violence in Surrey and Calgary. However, Sidhu Moose Wala was not present at the venue when violence occurred. These incidents resulted from a combination of factors including a lack of adequate security, alcohol consumption and late show- times. None of these factors are unique to the South Asian community, and none of them are applicable in the case of the 5X Festival. In actual fact, Sidhu Moose Wala recently completed a successful USA wide tour in legitimate venues with proper security, resulting in no public safety concerns. Moose Wala is signed to one of the largest agencies in the world, UTA, which represents a wide variety of talent including David Gilmour and The Tragically Hip.

The RCMP's efforts to derail Sidhu's performance represent (intentionally or not) cultural prejudice, poor judgement and will directly affect the representation and cultural appreciation that the South Asian community deserves. Our event is safe. At this stage in the process, our managers are presenting back the strategic plans to tourism stakeholders -- essentially, the summary of the community consultations conducted with them over the past year or so. For instance, four small sessions were held along the Sea-to-Sky corridor (North Van, Squamish, Whistler, Lillooet) with 15-60 people in attendance. Following our presentation, they become working level meetings, so I think the best opportunity for an MLB presence would be a generic video that we can use everywhere. There will be dozens more of these in the coming year, but only two confirmed so far in the next quarter.

By the way, the four Sea-to-Sky sessions were not listed on our last (Feb-June) Events Update for the Minister since we consider these operational, but they are appearing on the Events Update list as of this quarter. Also, FYI, Amber in MTAC receives weekly, detailed updates from our DD team on which sessions are coming up (as the timing for each is confirmed).

Lytton was an unusual request as it was driven by the local MLA, not us. As noted, the MO was contacted directly by the MLA last February. Dear Parliamentary Secretary Kahlon, Minister Ralston, and Minister Beare,

Surrey's upcoming 5X Festival staged by the Vancouver International Bhangra Celebration Society (VIBC) is a place where global South Asian culture and identity can be expressed, embraced and reconnected. Since 2004, the VIBC has been dedicated artistic expression and representation that inspires cross-cultural creativity, community engagement and inclusivity between ethno-cultural boundaries.

However, the VIBC has recently received opposition from the Surrey RCMP over the anticipated performance of an influential voice in Punjabi music, Sidhu Moose Wala. Currently, Assistant Commissioner Dwayne McDonald has advised the City of Surrey of his view that Sidhu Moose Wala poses a public safety risk. As such, the City and the venue, Center City Mall, have postponed VIBC's permit for this rapidly approaching festival. The venue owners have given us until 5pm PDT today to pull Moose Wala from our line-up.

This opposition to Sidhu Moose Wala's performance is ill-informed and perpetuates misunderstandings of the South Asian community in Surrey.

It has been brought to the RCMP's attention that two appearances by Sidhu Moose Wala were marred by violence in Surrey and Calgary. However, Sidhu Moose Wala was not present at the venue when violence occurred. These incidents resulted from a combination of factors including a lack of adequate security, alcohol consumption and late show- times. None of these factors are unique to the South Asian community, and none of them are applicable in the case of the 5X Festival. In actual fact, Sidhu Moose Wala recently completed a successful USA wide tour in legitimate venues with proper security, resulting in no public safety concerns. Moose Wala is signed to one of the largest agencies in the world, UTA, which represents a wide variety of talent including David Gilmour and The Tragically Hip.

The RCMP's efforts to derail Sidhu's performance represent (intentionally or not) cultural prejudice, poor judgement and will directly affect the representation and cultural appreciation that the South Asian community deserves. Our event is safe.
