Issue: Ministry Grant Funding Allocation in 2019/20

Background / Facts:

Community Resilience Through Arts and Culture Program (CR program)

- The CR program was launched in 2017/18 to support arts and culture events, festivals and
 initiatives led by groups in communities that are experiencing hardship, historic oppression or
 other challenges.
- The program provides grants ranging from \$2,500 to \$15,000 for eligible activities including cultural events, festivals and community celebrations; and arts and culture projects, programs or workshops.
- Program funding focuses on cultural revitalization within Indigenous communities with more than 80% of grants supporting projects centred on Indigenous culture and support for government's commitment to the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP).
- Program funding is allocated from the Corporate Initiatives and Strategic Priorities Branch budget:
 - o In 2017/18, 61 grants totalling \$535,000 were provided to 55 communities
 - o In 2018/19, 83 grants totalling \$735,000 were provided to 69 communities

First Nations Revenue-Sharing Agreement

- As of April 2019, the Province and First Nations Leadership Council entered into a Revenue-Sharing Agreement where approximately \$3 billion over 25 years will be shared with B.C. First Nations.
- First Nation communities in B.C. will be eligible for between \$250,000 and \$2 million annually through this agreement starting in 2019/20. These communities will determine their own priorities for the funding, which can be used for a wide range of benefits, including: health and wellness, housing, infrastructure, training, environmental protection, economic development, governance capacity and cultural revitalization.

Family Day

- In support of Family Day, the Ministry provides funding to support free events across the province.

- In 2019, the Ministry provided \$350,000 to support free Family Day events:
 - \$250,000 to the BC Recreation and Parks Association to support application-based grants, of up to \$1,000, to member organizations to provide access to free activities such as ice skating, swimming, snowshoeing, live music;
 - o \$50,000 to the BC Museums Association; and
 - \$50,000 comprised of \$40,000 to the Royal BC Museum and \$10,000 to the Vancouver
 Art Gallery to support the cost of hosting free activities.

B.C. First Nations, Province partner in historic revenuesharing agreement

Victoria - As part of Budget 2019, First Nations in British Columbia will have a stable, long-term source of funding to invest in their communities' priorities, through a historic revenue-sharing agreement between the Province and the First Nations Leadership Council.

Starting April 2019, approximately \$3 billion over 25 years will be shared with B.C. First Nations, meaning every First Nation community in B.C. will be eligible for between \$250,000 and \$2 million annually through the agreement.

First Nations communities will determine their own priorities for the funding, which can be used for a wide range of benefits, including: health and wellness, housing, infrastructure, training, environmental protection, economic development, governance capacity and other uses.

The agreement to share provincial gaming revenue was reached after decades of work and advocacy by the First Nations Leadership Council, represented by the First Nations Gaming Commission, as directed through resolutions by Chiefs at assemblies of the British Columbia Assembly of First Nations, the First Nations Summit and the Union of British Columbia Indian Chiefs. The Commission is establishing a new B.C. First Nations limited partnership to manage the funding, overseen by a First Nations-appointed board of directors.

Sharing revenue with First Nations communities is an important step that puts reconciliation into action. This agreement is part of B.C.'s commitment to create a new fiscal relationship with First Nations, recognizing self-government and self-determination.

- In 2017-18, the B.C. government collected \$1.391 billion in net revenue from gaming activities.
- Currently, 31% of total provincial gaming revenue is distributed to fund a Health Special Account, community gaming grants and host local governments. This will remain unchanged, and an additional 7% will be distributed to the First Nations new limited partnership. The remainder will continue to go into the Province's general revenues.
- Funding will be distributed to communities based on the following formula, developed by the First Nations Gaming Commission in consultation with First Nations:
 - 50% base funding (divided equally among partnered First Nations, including modern Treaty Nations, in B.C.);
 - 40% based on population, and

• 10% for geographically remote communities.

KEY FACTS REGARDING THE ISSUE:

- The BCGS is a Crown service-delivery agency that receives approximately \$2 million in annual funding from the Ministry of Tourism, Arts and Culture (MTAC).
- 2019/2020 BCGS Mandate directions are to support economic and tourism development; increase opportunities for Indigenous athletes; make sport affordable; implement inclusive experiences; and enhance safety practices with a focus on harassment and abuse.

Discussion Topics:

1. Premier's Award for Organizational Excellence – In 2018, the Indigenous Sport, Physical Activity and Recreation Council (ISPARC) received a Premier's Innovation and Excellence Award in the category of Organizational Excellence for their work over the past decade facilitating change in the health and well-being of Indigenous people through sport and healthy living initiatives. BC Games Society was identified by ISPARC as a key partner and this work has inspired more than 135,000 Indigenous people to become physically active and achieve their best as an athlete, coach, leader or official. It has also resulted in collaborative partnerships that have enhanced inclusiveness and reconciliation throughout the provincial sport system.

Recommended Response:

 The Minister commends the BC Games Society on creating opportunities for Indigenous athletes and coaches and promoting cross-cultural awareness for Games participants; and congratulates BC Games Society on their contribution toward this significant achievement. (Speaking notes included as Attachment 2) 4. Safety and Security – BCGS will provide an update on actions to proactively enhance safety and security of the Games. Examples include piloting a new on-site education initiative for all coaches and athletes competing at the Games. BCGS has actively also engaged in work that aligns with the Red Deer Declaration for the prevention of harassment, abuse and discrimination in sport (e.g. viaSport safe sport design sprint).

Recommended Response:

- BCGS can be recognized as a leader within the sport sector in taking proactive steps on sport safety to ensure all athletes have safe and inclusive experiences at the Games.

Research & Analysis

Consultations

- Over the past two years, consultations with various art organizations and Indigenous communities have indicated that there is strong support for an arts infrastructure fund.
- In December 2017, Minister Lisa Beare hosted a consultation organized by BCAC for arts leaders
 which identified arts infrastructure as a key priority, specifying, "Infrastructure is the key to
 accessibility", and "Provincial funding should be designed to leverage the Canada Cultural Spaces
 Fund (CCSF)".
- In April 2019, First Peoples' Cultural Council reported to the BCAC that "...community consultations conducted for the Arts Program Review confirm that there is limited Indigenous controlled arts infrastructure, spaces or events. There is significant need to develop cultural and organizational infrastructure and capacity in urban, rural and remote settings."

<u>Previous B.C. Arts Infrastructure Funding Programs</u>

- The Province previously offered two limited infrastructure programs to support art in B.C.:
 - BC Creative Spaces (FY 2012/13 2013/14), provided \$2,054,000 in funding for 78 construction/renovation/specialized equipment projects for arts organizations and Indigenous groups. The program received high-quality applications and the final reports show significant province-wide impact.
 - BC Collaborative Spaces (FY 2015/16 2016/17) targeted support specifically for creative hubs and other co-location infrastructure projects. Many poorly aligned applications were received, which resulted in staff recommending ending this program and restarting BC Creative Spaces.
 Funding for arts infrastructure was not renewed, and the recommendation stands.
- In FY 2017/18, TAC provided \$10.9 million in one-time grants to three large projects through yearend contingency funding:
 - o \$6.0 million to Art Gallery of Greater Victoria for renovation,
 - \$3.9 million to 312 Main Street for establishing a creative hub, and
 - \$1.0 million to Sun Wah Centre for establishing a creative hub.

Attachment 2: Canada Cultural Spaces Fund (CCSF) Overview

The Canada Cultural Spaces Fund is a federally administered grant program. The CCSF national budget is \$60M/year. 2019/20 is year two of the 10-year commitment to double the budget from its previous \$30M/year. The Western Region envelope (Alberta, BC and the Yukon) is \$13.2M/year.

Objectives and expected results for the Canada Cultural Spaces Fund

The objectives of the Canada Cultural Spaces Fund (CCSF) are to contribute to:

- improved physical conditions for professional arts and heritage related collaboration, creation, presentation, preservation, and exhibition; and
- increased and improved access for Canadians to arts and culture.

The CCSF achieves these objectives by supporting:

- the construction and/or renovation of arts and/or heritage facilities, including creative hubs; and
- the acquisition of specialized equipment and the development of feasibility studies for the construction or renovation of arts and/or heritage facilities, including creative hubs.

The expected results

- Artists, creators and heritage practitioners have access to professional cultural facilities;
 and
- A variety of arts and heritage experiences are available in a wide range of communities.

The long-term results of the CCSF will allow Canadians to value and access arts and heritage spaces in their community for creation, collaboration, presentation, preservation and exhibition.

Eligible Organizations

- A not-for-profit arts and/or heritage organization operating in a professional manner, incorporated under the Canada Not-for-Profit Corporations Act, or under the equivalent provincial or territorial legislation.
- A not-for-profit organization, incorporated under the Canada Not-for-Profit Corporations Act, or under the equivalent provincial or territorial legislation, that is proposing the development and management of a creative hub.
- A provincial/territorial government, a municipal administration, one of their agencies or an
 equivalent Indigenous peoples' institution or organization that has historically demonstrated its
 support to professional artistic or heritage activities including Indigenous cultural practice in their
 community

- the construction and/or renovation of arts and/or heritage facilities, or creative hubs;

Issue: Family Day 2020 – Funding and Programming Support

Background / Facts:

- British Columbia will hold its ninth annual BC Family Day on Monday, February 17, 2020.
- In February 2018, the <u>Premier announced</u> that Family Day would be changed from the second to the third Monday in February to align with the other provinces in Canada.
- From 2014 2018, the Province provided \$250K \$300K annually to support hosting of Family Day events in B.C. communities (Attachment 1: History of Family Day Funding).
- In 2019, TAC provided a total of \$350,000 in direct awards to four organizations:
 - \$250,000 to BC Recreation Parks Association (BCRPA);
 - \$50,000 to BC Museums Association (BCMA) (1st year receiving Family Day funding);
 - \$40,000 to Royal BC Museum (RBCM); and
 - \$10,000 to Vancouver Art Gallery (VAG).
- BCRPA and BCMA awarded grants of up to \$1,000 for local governments and other organizations to host free, Family Day events across B.C.
 - Supported activities included free admission to museums and cultural centres, ice skating, swimming, snowshoeing and music.
- TAC funding to RBCM and the VAG allowed for free admission and/or family events at their facilities on Family Day.
- In 2019, ~102,954 people participated in TAC funded Family Day events, including:
 - 80,000 people at BCRPA-supported events (over the long weekend)
 - o 13,000 people at BCMA-supported events
 - o 9,654 visitors to the RBCM; and
 - 300 visitors to the VAG (open from 12-4pm)
- For Family Day 2019, the BC Recreation and Parks Association awarded 198 Family Day grants to 116 communities across B.C. including:
 - 177 grants to Local Governments, and
 - 21 grants to First Nations band councils.
- For Family Day 2019, the BCMA awarded 59 Family Day grants to 48 communities, including 7 grants to First Nation band councils.
- The Family Day funding has been delivered by TAC for the past six years. Program delivery partners have a strong expectation that it will continue.

Analysis:

- In 2019, the BCRPA indicated the Family Day grants "continue to be the most utilized and anticipated annual initiative the BCRPA is involved with."
- BCRPA's diverse network of stakeholders promotes community events and progams across BC, including rural, remote and northern regions.
- According to the BCMA, the inaugural Family Day funding resulted in:
 - o a greater diversity of visitors (socio-economically and culturally) to the museums, galleries

Sport framework consultation process

- The sector consultation process is nearing completion:
 - The Minister and Parliamentary Secretary Kahlon have been engaged in consultation with the sector for more than 18 months.
 - On July 17, 2019, Parliamentary Secretary Kahlon shared a draft report with more than 70 provincial sport leaders at Sportscape (Sportscape is viaSport's annual session for all provincial level sport and multi-sport organizations). The report summarized the feedback to date.
 - s.13

 An opportunity to provide more in-depth feedback was provided through a series of facilitated workshops and through facilitator-led webinars August 15 and 16.
 - Feedback will be consolidated into a Key Findings report and reviewed by the Multi-sport Leadership Council in late August. A final report will be submitted to the Ministry in early September for consideration in the final Sport Framework.

Safe Sport

- viaSport is a strong proponent of the Red Deer Declaration for the Prevention of Harassment, Abuse and Discrimination in Sport signed by Federal-Provincial-Territorial Ministers in February 2019.
- Given the mobility of athletes and coaches, a Pan Canadian approach to sport safety is critical. Collaboration across jurisdictions is key. British Columbia has been a strong contributor to this national work including:
 - hosting a BC Summit as part of the nationwide Safe Sport Summit Series in March 2019 with nearly 200 stakeholders; and
 - o contributing to the development of a draft universal safe sport code.
- While BC continues to be a strong contributor to the Federal-Provincial-Territorial work, both the Ministry and viaSport share the concern that progress at the national level is moving quite slowly. As such viaSport and the Ministry continue to collaborate on ways to advance safe sport with BC more quickly.
- Concrete actions to date have included:
 - actively promoting the Responsible Coaching Movement and issuing Commit to Kids licenses; and
 - hosting a 5-day session in April/May 2019 with athletes, coaches, volunteers, and parents to generate ideas for improving sport safety.
- viaSport is currently synthesizing information from its consultation processes and will submit recommendations to the Ministry this September.

KEY ISSUES:

- Susan Jackson, Chair of the BC Arts Council would like to highlight recent activities at the BCAC.
 Agenda items include:
 - 1. Progress on the implementation of the New Foundations Strategic Plan;
 - 2. Plans for the upcoming regional board meeting in October; and
 - 3. Vacancies and upcoming expiries on the Council.

Strategic Plan Implementation

- In July 2018, the BC Arts Council (BCAC) launched a new strategic plan, <u>New Foundations 2018</u>
 2022.
 - The plan focuses on four priority areas including Sustainability and Creative Development, Indigenous Arts and Culture; Equity, Diversity and Access; and Community Arts and Regional Arts.
- In addition, BCAC received two consecutive budget lifts bringing it to an all-time high of \$34M from a baseline of \$24M in FY 2017/18.
 - The additional investment has strongly enabled the implementation of the strategic plan.
- BCAC is making progress under all priorities in the strategic plan:
 - Sustainability and Creative Development
 - In FY 2019/20, additional funding will be invested to support larger, more viable grant amounts for *Individual Arts Awards* recipients.
 - s.13
 - Indigenous Arts and Culture
 - BCAC is supporting the upcoming Arts BC (40th Anniversary) Conference, Kelowna October 17-19, 2019.
 - BCAC will deliver a three-hour workshop on bridging activities with Indigenous communities and offering travel subsidies for community arts organizations to attend the conference, including Indigenous organizations.
 - Equity, Diversity and Access

- An equity consultant has been procured to support BCAC in strengthening engagement with historically underserved groups and increasing their access to funding.
- BCAC will 'soft' launch (i.e. only to a select client group initially) a new online Grant Management System (GMS) s.13 Clients will now be able to more easily submit and track their applications online.
- Community Arts and Regional Arts
 - BCAC is broadening eligibility for community arts funding programs to friendship centres, francophone associations, and cultural centres and associations that are delivering community-accessible arts programming.
 - From a FY 2017/18 baseline, BCAC will invest an additional \$1.1M in *Community Arts* bringing the allocation up to approximately \$2.26M.

Upcoming Regional Board Meeting

- The next BCAC board meeting will take place in Fort St. John on October 16/17, 2019.
- The meeting will include a business portion as well as a community outreach/engagement event to give the Council an opportunity to meet with current and future clients in the area.

Council Membership

- The Council welcomes Michael Murray and Roy Henry Vickers, and is requesting the positon made vacant with the resignation by Manjot Bains be filled.
- The Council currently has one vacancy with at least one more expected in December 2019.

- Continue to take a leadership role by mentoring and increasing the Royal BC Museum's
 presence across the province with regional outreach with the goal of supporting
 capacity building in all museums around the province and making the museum and
 archives more available to all British Columbians by:
 - continuing to provide support to other heritage, scientific and cultural institutions with museum expertise;
 - acting as a resource for research and the sharing of knowledge about British
 Columbia, which includes loans of objects and specimens; and
 - curate and support touring exhibits around the province.
- Offer unique visitor experiences, both onsite and online, by continuing to offer relevant and engaging exhibitions and educational programs, including:
 - Orcas: Our Shared Future;
 - Wildlife Photographer of the Year 2020; and
 - Delivering the 2020/21 learning programs.
- Continue to support the work of the modernization project and continue to engage the public, including Indigenous communities and youth, on the proposed modernization of the RBCM and the vision for the museum of the future.
- Continue to work with the Ministry of Tourism, Arts and Culture to develop options for the safeguarding and storage of the RBCM's collections to better protect the artifacts that are not currently on display.
