Twitter statement:

Like many people, reports of a racist physical and verbal attack on teenagers peacefully riding the bus over the weekend left me shocked and saddened. Attacking a group of youth for speaking a language other than English goes against everything we stand for as British Columbians. I want this group of teenagers to know – despite what you experienced on that bus, you are welcome in B.C.

As I travel across the province this summer to meet with community leaders at the forefront of these issues, I'm struck by how common these incidents are becoming. But I'm also inspired to hear how communities are coming together and standing up to the small minority of people who are using racism and hate to try to divide us.

Whether it's graffiti of swastikas in our communities, people being the target of racial slurs, or political leaders using racism as a tool for political gain, we need to stand together and decide that this type of aggression has no place in B.C.

B.C.'s diversity is our identity and one of our greatest strengths. It's part of why this is such an amazing place to live and visit. Our government will always stand up for diversity, inclusion and mutual respect, and work to build a better future for every person, in every community.

- Incidents of racism and discrimination are increasing – both in Canada and around the world. Police-reported hate crimes have risen in B.C. in recent years, from 164 reported incidents in 2015 to 255 incidents in 2017.
- As our government continues its work to champion human rights, diversity and inclusion, Parliamentary Secretary Kahlon wants to hear from community leaders about what is being done, what is working and how the provincial government can support this work.
- Fort St. John is one of several communities he is visiting across the province. In each community, he will be meeting with community leaders, faith leaders, racialized community leaders, local government officials, and Indigenous leaders, as well as people who have been impacted by racism or hate.

Dear Evan

It was great to meet you and connect with the Premier again at the launch of the Mental Health Plan. As you are aware, the Premier asked me to write to you as a follow up to the conversation the Premier and I had at the event.

Please thank the Premier for his encouraging words and pass on this information. I am chair of the Punjabi Canadian Legacy Project Advisory Committee that was started in 2015. I agreed to work on this because being a registered nurse, I know that a person's identity or self-concept is necessary for well-being. Mental health issues, relationship violence and gangs headline our local newspapers highlighting Punjabis. A contributing root cause for these issues is lack of identity and I believe a part of the reason that these issues occur is because Punjabis do not see themselves as belonging and included in the fabric of our society, our institutions remain Eurocentric and white and white privilege continues. Since the contribution of Punjabis to the fabric of society is not documented or taught in schools, not even universities, there remains a feeling of less than or not good enough in the minds of minority youth. Youth are not aware of the contributions that the Punjabi community has made since the early settlers of the late 1890's. There remains an equity gap. For these reasons, I am passionate about this project and need your support. I have been talking with Ravi Kahlon and asking him to make this a priority since he was elected. I will be meeting with him again, as the Premier suggested, on July 12. Now I will explain what has been done so far.

From 2015-2018, under the directives and guidance of the Punjabi Canadian Legacy Project Advisory Committee, the South Asian Studies Institute at the University of the Fraser Valley in partnership with the Royal BC Museum undertook two rounds of province-wide Punjabi Canadian community consultations. As a result, the communities have requested the following legacy initiatives be developed

- Create Punjabi Canadian related School Resources for K-12
- Community history research/connectivity in all the regions of BC
- Punjabi Canadian Labour Movement Archival Project
- Social History of Punjabi Canadians
- Historic Sites of BC – record and preservation
- Punjabi Legacy Travelling Exhibition to all parts of BC

The work has already started and you can see the initial output at this website (www.canadiansouthasianheritage.ca). From Campbell River to Prince George, from Trail to McKenzie and places in between, there is so much rich and valuable history that needs to be uncovered and recovered.

I have attached the budget and material that we have given to Ravi as Parliamentary Secretary for Sport and Multiculturalism and to staff in the Ministry of Tourism, Arts and Culture. We have created two budget options, ideally we need s.21 for a project that will help right the wrongs of the past and leave a legacy for future generations. s.21
s.21. I have also attached the Haq (meaning rights) and History book that we created.

I really need the Premier to support this project. If you need anything else, please let me know.
