Message to all Employees on COVID-19

I apologize for sending this out so late in the day, but it has been a really eventful, hectic week and I thought it important to reach out to you now, rather than wait for Monday.

Over the last several weeks, the Public Service has taken on the extraordinary task of monitoring, planning for and responding to the progression of the COVID-19 virus, while also delivering services to the public under unique and evolving conditions.

While all ministries have a role to play in the response to COVID-19, I would like to particularly acknowledge the incredible focus and efforts of the Ministry of Health over the past several weeks. We all know that the virus has had a rapid path from emerging in early January to being the centre of global disease control efforts and news coverage. Over that time, Deputy Minister Stephen Brown, Provincial Health Officer Bonnie Henry and many others in the Health team have been working tirelessly to prepare our health care system and limit the spread of COVID-19 across the province.

Given that COVID-19 has taken a rapid path from emerging in early January to being present in almost every country around the world today, many of you may have concerns and questions about how to protect yourself in the workplace and at home with your families.

Government has taken significant steps to protect the health and safety of public servants and we will continue to adapt our approach as necessary based on regular input and expert advice of the Provincial Health Officer and the BC Centre for Disease Control. Information on workplace issues specific to the BC Public Service is available on the [MyHR site](#) which will be updated regularly with the latest information. If you have questions that are not addressed in the available information resources, please seek advice through the MyHR service or raise your questions with your supervisor or Deputy Minister. In the case of a genuinely urgent workplace safety emergency, you can call 1 250 952 0911.

I would note that:

- The best way to protect ourselves and each other is to practice effective prevention and “social distancing” actions, which includes washing our hands properly and regularly, avoiding touching our faces, and staying home when sick.
- The BC Public Service will support virtual work options during the COVID-19 response where operational requirements can be fulfilled. Deputy Ministers have the authority to determine which services can be delivered virtually and will do so on a case-by-case basis.
- Dr. Bonnie Henry has provided guidance on cancelling events or gatherings involving 250 people or more, but was clear that this does not mean closing workplaces with 250 or more people. At the discretion of Deputy Ministers, smaller meetings and events can continue, but ministries should make accommodations for telephone or Skype participation and reduce numbers where it is practical to do so.
- Current recommendations now advise against all non-essential travel outside of Canada, including to the United States. Anyone who does travel outside Canada will be required to self-isolate for 14 days upon their return.
- Actions taken by other countries are not necessarily applicable in a Canadian or B.C. context. B.C.

officials are working closely with Canada to coordinate matters of federal and federal jurisdiction. Dr. Henry is also working closely with her national and international colleagues and makes decisions informed by medical evidence and local needs and circumstances.

The extraordinary pace and circumstances of COVID-19 are placing new demands on ministries and public sector organizations and causing strain for our clients, stakeholders and colleagues, and I would ask that you treat yourselves and each other with compassion and understanding. My thanks to all public servants who are actively involved in supporting the complex, challenging and evolving provincial response. We all can do our part by doing our best to minimize the potential spread of the virus, and to support our colleagues who are working to protect British Columbians.
