Issue: Request to proclaim July 20-26, 2020 as Chinese Cultural Heritage Week in British Columbia

Background / Facts:

- A proclamation request has been submitted by Bo Jiang from the Canadian Community Service
 Association (CCSA) to proclaim the week of July 20-26, 2020 as the Chinese Cultural Heritage Week in
 British Columbia.
- Based in Richmond and established in 2002, the CCSA provides settlement and cultural exchange services for Chinese-Canadians in Metro Vancouver and promotes communication and cooperation among various ethnic Chinese groups and communities in B.C.
- The CCSA organizes an annual, large-scale Chinese Cultural Heritage Festival and Vancouver Water Splashing Festival at Swanguard Stadium in Burnaby.
- This year's celebrations will take place virtually during the week due to COVID-19 pandemic and the ban on large gatherings.
- TAC issued a Chinese Cultural Heritage Week proclamation for the first time in 2019.
- In the 2016 Census, more than 540,155 British Columbians identified their heritage as Chinese, the fourth largest population subgroup in British Columbia after English, Scottish and Irish.

Analysis:

- This request meets established proclamation criteria for the multiculturalism file given it:
 - has significance or general application to B.C.;
 - o observes milestones, recognizes achievements or directs attention to a worthy cause;
 - is not political by nature;
 - o would not be considered offensive or frivolous by the public; and
 - o aligns with both the Ministry's mandate and BC Multiculturalism Act.
- Section 2 of the Multiculturalism Act states that two of the purposes of the Act are to: "recognize
 that the diversity of British Columbias...is a fundamental characteristic of the society of British
 Columbia;" and "encourage respect for the multicultural heritage of British Columbia."
- In 2019 TAC supported nine heritage-based proclamations: Sikh Heritage Month, Day of Nowruz, Bangla Heritage Week, Asian Heritage Month, Italian Heritage Month, Tamil Heritage Month, Latin American Week, Chinese Heritage Cultural Week, and Taiwan-Canada Culture Exchange Day.
- If approved, there is an opportunity to coordinate this proclamation with planned announcements regarding the Chinese Canadian Museum. A paragraph in this year's proclamation has been added to reflect this announcement, at the request of the Arts and Culture Branch.
- In the context of the recent increase in anti-Asian racism in BC, the proponent has also requested new language in the proclamation that highlights the issue and speaks to the contributions of the Chinese-Canadians to BC in implementing COVID-19 safety measures.

Request

My name is Brendan Shykora, I'm a reporter with the Morning Star in Vernon BC. I'm reaching out with the hope of learning more about the province's new anti-racism network, Resilience B.C. It officially replaced Organizing Against Racism and Hate earlier this year, and with all that has transpired since then (starting in Minneapolis) it's a good time to look back at the decisions that prompted the change, and how the new network may be more impactful than the last.

I'm curious regarding how this new program plans to serve local communities. The old program was "a coordinated community approach ... in 36 member communities." While a Resilience BC hub has been established in Victoria, it would be great to see how that hub will help connect other communities in the province to anti-racism resources.

I understand Ravi Kahlon was in charge of leading the community dialogues that in turn led to the new Resilience BC. I'm not sure if he is available to speak, but if so I'd like to request an interview.

If anyone else who is involved or is knowledgable about the program is available for an interview, that would be great as well.

Background

Recommendation

Since Brendan requested to speak to Minister Kang, suggest we send the answers as a statement from her to be able to be quoted.

1) Is there a rough timeline for when those spokes will be in place?

The Call for Proposals for the spokes closed on May 22. We are now in the process of selecting the community spokes, which will be announced this summer.

2) What will those spokes look like? As in, what services might they provide?

The spokes are community-based branches that help see through service delivery.

The spokes will:

- Represent communities and work with local organizations.
- Identify local priorities and move projects forward.
- Spokes can choose to organize themselves at the municipal level (e.g. Prince Rupert) or at the regional level (e.g. North Coast).

3) What will have changed or been improved upon in comparison to the phased out OARH model?

- The main difference is that Resilience BC is a province-wide anti-racism network that will be delivered through a hub and spokes model.
- This model will allow for a more systemic and collaborative approach to improve community capacity to respond to emerging trends and incidents of racism and hate.

•	Under Resilience BC, individual communities will receive new supports from a centralized "Hub" service provider with specialized expertise in addressing racism. The program will provide better coordination and training as well as make best practices and education more available to communities.
