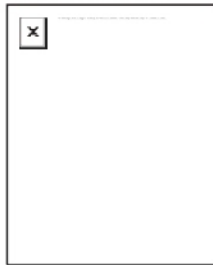

More supports for the Lower Mainland to combat racism

VANCOUVER – The Province is strengthening anti-hate and anti-racism supports for communities with 13 new organizations offering Resilience BC services in B.C.’s lower mainland.

“There is no place for racism and hate in British Columbia. To fight racism and hate crimes, we must work together in a coordinated way in communities in every corner of the province.” said Anne Kang, Minister of Citizens’ Services and responsible for Multiculturalism. “These community spoke organizations will lead action at a local and regional level to respond to and prevent racist and hate activity.”

Under the Resilience BC program, 34 organizations were selected to provide services in 40 communities throughout the province following a competitive procurement process. The organizations chosen demonstrated a strong understanding of current racism and hate issues and have a defined course of action at a local or regional level driven by solid community partnerships.

- S.U.C.C.E.S.S. (United Chinese Community Enrichment Services Society) (Tri-Cities)
- WitWorks Ltd (Sechelt/Gibsons)

“Archway has been involved in anti-racism work for over three decades and we are very proud of how our community stakeholders have been coming together for years to address issues of race, bigotry and exclusion,” said Manpreet Grewal, Director of Multicultural and Immigrant Services, for Archway Community Services, Abbotsford. “We are pleased to be a community spoke for Resilience BC and we will use this funding to increase our training, information and other important resources to combat acts of discrimination and racism and to support a safer community where everyone belongs.” (approved)

Resilience BC, launched in November 2019, is a province-wide anti-racism network delivered through a hub and spokes model. In May, the Province selected the Victoria Immigrant and Refugee Centre Society to serve as a provincial hub to connect communities with information, training and resources across the province. The spokes are community-based branches that identify local priorities and move projects forward that address systemic and institutionalized racism at a local level.

Most recently through Resilience BC, the Province launched resiliencebcnetwork.ca, an online portal to support people who experience or witness a racist incident. The website offers information in 12 languages and multilingual videos will soon be added to the site.

Resilience BC is one of many actions the B.C. government is taking as part of its commitment to stand up for diversity, end racism and all forms of discrimination, and support multiculturalism in British Columbia.

Quick Facts:

- Establishing Resilience BC was an outcome of a series of community consultations on racism led by Ravi Kahlon, former Parliamentary Secretary for Sport and Multiculturalism, in 2019.
- A total of \$300,000 from the Resilience BC annual budget has been allocated to fund the community spoke services. There are two funding models:
 - Individual Community Spokes: annual funding of up to \$7,500 per geographic community.
 - Regional Spokes: annual funding for two or more of neighbouring communities that pool funding (e.g. up to \$15,000 for partnerships involving two communities, etc.)
- The total investment in Resilience BC is \$540,000 annually.

Key Messages:

Everyone deserves to be treated fairly in our province.

We acknowledge that for many Black, Indigenous and other people of colour, that hasn't always been the case.

Ensuring the police are accountable to the highest standards for fair and unbiased conduct is crucial to maintaining public trust.

We've strengthened the Independent Investigation Office and introduced new standards on police stops, which include not permitting arbitrary stops or ones based on race.

But more can and must be done.

BC's Police Act is 45 years old.

It's out of date and out of step with our approach to harm reduction and mental health.

Expectations on front-line police responders have grown and our policing and public safety model needs to reflect communities' current and future needs.

We've struck an all-party committee to engage with communities and experts on how the 45-year-old Police Act can be modernized to reflect today's challenges and needs with respect to mental health, harm reduction and systemic racism.

Issue: Request to proclaim July 11, 2020 as Srebrenica Awareness Day in British Columbia

Background / Facts:

- A request has been received by the Institute for Research of Genocide Canada for British Columbia to proclaim July 11, 2020 as Srebrenica Awareness Day. The request is supported by the Bosnia Herzegovina Cultural Centre Society based in Vancouver.
- 2020 marks the 25th anniversary of the Srebrenica Massacre.
- On October 19, 2010, Canada's parliament passed the Motion M-416 designating July 11 annually as Srebrenica Remembrance Day in Canada.
- Motion M-587, passed in the House of Commons on April 24, 2015, included the Srebrenica Genocide, and Srebrenica Genocide Remembrance Day as part of "Genocide Remembrance, Condemnation and Awareness Month" every April.
- The Srebrenica Massacre, also known as the Srebrenica Genocide, was the killing in July 1995 of an estimated 8,000 Bosniak men and boys in the region of Srebrenica in Bosnia and Herzegovina by Bosnian Serb forces.
- The United Nations had declared that the Srebrenica Massacre is the largest mass murder in Europe since World War II and the largest massacre carried out by Serb forces during the Bosnian war.
- The International Court of Justice ruled in February of 2007 that the Srebrenica Massacre was genocide with the specific intent to destroy Bosnian Muslims who were living in the area.
- In September 2014, a permanent exhibition commemorating the Srebrenica Genocide was opened in the Canadian National Museum of Human Rights in Winnipeg.
- Mayors of the Canadian cities of Toronto, Hamilton, Windsor and Saskatoon proclaimed July 11th the Remembrance Day of the Genocide in Srebrenica.
- According to the 2016 census approximately 3,200 British Columbians identify their heritage as Bosnian while 12,895 BC residents identify as Serbian.

Analysis:

- This request meets established proclamation criteria for the multiculturalism file given it:
 - has significance or general application to B.C.;
 - observes milestones, recognizes achievements or directs attention to a worthy cause;
 - is not political by nature;
 - would not be considered offensive or frivolous by the public; and
 - aligns with both the Ministry's mandate and BC Multiculturalism Act.
- Section 2 of the Multiculturalism Act states that two of the purposes of the Act are to: "recognize that the diversity of British Columbians...is a fundamental characteristic of the society of British Columbia;" and "encourage respect for the multicultural heritage of British Columbia."
- The draft proclamation has been reviewed by Order in Council Office and the Intergovernmental Relations Secretariat who have no concerns.
- Proclamations recognizing genocide and systematic persecution issued by the province include the Holocaust Memorial Day and the Ukrainian Holodomor Memorial Day.

Recommendation:

- Approve the Srebrenica Awareness Day (July 11, 2020) proclamation.
