I am writing to express my enthusiastic support of the proposal for the expansion of the Purcell Wilderness Conservancy to include the Argenta-Johnsons Landing Face, the 6200 hectare west facing slope stretching from Hamill Creek, Argenta in the North to Fry Creek, Johnsons Landing in the South and presided over by the highest mountain on Kootenay Lake, Mt. Willet.

The importance of these 6200 hectares of low-to-mid elevation forest is manifold, including its ecological value to the Purcell Wilderness Conservancy, its essential contribution to the health and stability of the adjacent communities of Argenta and Johnsons Landing, and its aesthetic importance for the tourist industry of the region. Unfortunately, this important region is threatened with logging development by its inclusion in the 2017-2022 Forest Stewardship Plan of Porcupine Wood Products. This issue needs your urgent attention to avoid irreversible damage.

Please help to legislate the perpetual protection of the Argenta-Johnsons Landing Face by including it in the Purcell Wilderness Conservancy as soon as possible. Until this is secured, I request a moratorium be placed on all development proposals to this area.

I would appreciate a response from you on how you intend to proceed in regard to this issue.

My name is s.22 I am a musician who performs under the stage name Art d'Ecco.

Over the past few years, I have been the beneficiary of the Amplify Music fund (FKA BC Music Fund) and as a result I have been able to elevate my career as an emerging artist.

It was brought to my attention recently that this particular fund that has assisted BC based musicians in the past, is now in jeopardy of disappearing.

I am writing you today requesting that you to renew of the Amplify BC fund.

A little background:

I have been playing music since I was s.22

After many years spent working in s.22
decided to quit and pursue music *full time* s.22

The transition wasn't without its growing pains.

On a whim I decided to apply for the chance to perform at Music BC's Rifflandia showcase in Victoria BC. These important festival events are an opportunity to show your stuff to the industry of decision makers, the gatekeepers holding the proverbial key to your future success.

Artists and bands salivate at the chance to play these events and they are an important cornerstone to every career in music. Look up and down the top 40 music charts - every single rock star, pop artist, mega hit maker? They all started somewhere, and that somewhere is most likely an emerging artist festival like Rifflandia, held right here in BC.

I landed a spot on the Saturday evening and we had a great showcase for the crowd at Music BC's venue.

After this performance I was introduced to an agent named s.22 from one of the top agencies in Canada - s.22

After some back and forth via email, he offered to help pass my album around to some music managers out east in Toronto.

A week later I was on the phone with s.22 a prominent manager. "Art, I dig the album. But I can only work with you if I can get a you a deal otherwise it just isn't worth my time. Give me a couple of weeks to shop this around".

A week later my phone rang. It was s.22 "Art, I have news... s.22 wants to sign you. s.22
This is huge."

A few months later, I had a lucrative publishing deal with Rough Trade Publishing (worldwide), and an American agent to boot.

I have since requested additional travel assistance funding from Music BC. Their grants have afforded me the opportunity to promote my album around the globe.

My story is just one of many others who have benefited from the Amplify Music Fund, and I urge you to consider extending the fund, so that the next generation of emerging artists can receive the same opportunities that I had over the last couple of years.

The next success story is waiting in the wings, and they need your help!
