We haven't met, ^{s.22} and he suggested I direct my question to you! I'm hopeful that you may be able to point me in the right direction (he wasn't sure if this was your jurisdiction). I'm doing some contract work for the Victoria Academy of Ballet, a certified post-secondary institution with the PTIB (AEST). We have a number of students from Mexico and Japan with approved study permits for September, ready to join us. The question is obviously when.

We received an email from CI news with a [letter from Hadju and Mendicino](#) indicating that this was a provincial issue and it was up to institutions themselves to send Covid-19 response plans, etc., to respective provincial ministries of health and immigration (the immigration part is why ^{s.2} thought of you).
