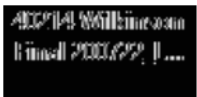

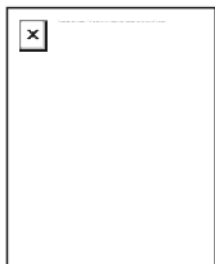

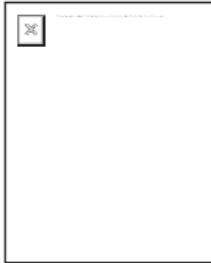

It appears that many RV users plan to head to BC this year because of the milder weather there compared to the rest of the country. I have a few questions below. Are the province's campsites and other facilities equipped to handle a larger than normal number of RV users?

The vast majority of BC Parks campsites are not winterized and therefore are not appropriate for winter RV users. There are a number of private campsites and RV sites that are ready to welcome people from across the country this winter.

Does the ministry have any advice to RV users who are contemplating coming to the province this winter?

- There is an expectation that they will be expected to follow the same rules as everyone else in B.C. and travel safely and respectfully.
- People travelling in B.C. – no matter where they're from – should follow Dr. Henry's Travel Manners and stick to the same travel guidelines as British Columbians.
- That means check before you go, fewer faces in bigger spaces, if sick stay home, wash your hands, keep a safe physical distance, come prepared and bring supplies and respect all travel advisories.
- Do your research before you travel and make sure your trip is right for you, right for your family and right for the community you are visiting.
- Only come in close contact with people you know – this will help public health officials to trace your contacts more quickly, should you become sick.
