Please find attached an overview of the media reporting on the third-floor gallery closures, as announced on November 3, 2021.

A few immediate notes and observations:

- After yesterday's media questions, through Dan's interviews, and online/email questions from the public, our comms team will now be working on a more extensive Q+A that will be ready for Monday. We will share the revised draft.
- Future messaging needs to be more specific in terms of using language that includes all people of BC as we
 consult and create new museum narratives. It seems to be the most common point of contention from yesterday's
 news.
- Future messaging needs to place greater emphasis on the long-term process of decolonization (and when
 appropriate, linked to the Modernization project). Although we shared the approved messaging that it would take
 years to complete, there were some media reports (CTV specifically) that reported incorrectly about the galleries
 reopening with new exhibits. (We are working with media outlet(s) on correcting those assumptions).

Royal BC Museum Announces Upcoming Changes to Core Galleries

Context

The media release containing the announcement was sent to the Royal BC Museum's full media list at 9:15 AM. The museum's communications department subsequently scheduled several in-person and phone/videocall interviews with acting CEO Dr. Daniel Muzyka, and responded to several other media enquiries with written statements using preapproved language from the announcement.

On balance, the media coverage on November 3 was balanced and accurate, but the museum's communications manager, Sam Rich, will be reaching out to certain reporters to correct misinformation. The communications team will also assist other museum staff with answering messages from the public or respond on their behalf. There are approximately 50 email messages as of this morning (November 4).

The Q&A document (developed by museum staff, the Ministry of Tourism, Arts, Culture and Sport, and Government Communications and Public Engagement) will be continually updated to reflect the evolving discussion about the announcement.

Advice for the Minister of Tourism, Arts, Culture and Sport

Tuesday Nov. 9, 2021

Key Messages

- The Royal BC Museum is working to modernize museum practices and is committed to sharing the stories and voices of all British Columbians.
- The museum's galleries were developed a half century ago through a Eurocentric lens that does not accurately reflect the stories of all British Columbians.
- It's imperative to ensure the stories of Indigenous peoples and that of other cultural groups who have helped to build this beautiful province are accurately reflected in our exhibits at the RBCM
- The Royal BC Museum's decision to close down sections of its third floor is part of its work to modernized museum practices, and its commitment to decolonization.
- This decision is aligned with our government's commitment to truth and reconciliation that demands we diversify and decolonize the way we share the history of B.C.
- The steps to modernize and reimagine the RBCM in the 21st century will benefit the generations that follow.

Q&A:

- 1. Does the closure have to do with the racism allegations last summer?
- The museum is working to become a fully safe and inclusive workplace following allegations of systemic racism from a former senior staff member.
- The museum's galleries were developed a half century ago through a Eurocentric lens that does not accurately reflect the stories of all British Columbians.
- The Royal BC Museum's decision to close down sections of its third floor is part of its work to modernized museum practices, and its commitment to decolonization.
- 2. What were some of the concerns people heard about the 3rd floor in particular?

- The narrative of the galleries on the third floor celebrates a European-settler view of what is now British Columbia and is long overdue for updates.
- The work to include under-represented voices and contemporary stories of BC begins on the third floor.

3. Does the closure have to do with modernization? What is the latest on that?

- RBCM is beginning closing sections of the third floor to start the process of decolonization in these galleries.
- Our government is committed to modernizing the Royal BC Museum and we are looking at options of what this could look like.

4. Can you clarify what sort of consultations with Indigenous communities went into this decision?

- In 2019, RBCM engaged with Indigenous communities across B.C. and will be following up on the engagement recommendations as part of the modernization process.
- RBCM and Ministry staff have met with the Songhees First Nation on multiple occasions.
- Continuing to work closely with the Indigenous communities will be key to the success of this project.

5. And what sort of consultations will be taking in place in deciding what should replace the displays?

 Some initial consultation has been undertaken, and we will be reaching out to communities across the province to ensure that the experiences and contributions of contemporary Indigenous people, as well as Canadians from other underrepresented groups, as the project continues.

6. When will the 3rd floor reopen?

- There will be minimal closures of the third-floor galleries, with limited impact to visitors, starting in November.
- There will be a full closure of the third-floor galleries as of January 2nd 2022.
- The process of creating new narratives is long and requires a thoughtful process of community outreach, consultation and collaboration. We expect this work to take a number of years to complete.

Updated Nov. 9, 2021

Background: On Nov. 4, 2021, the BC Royal Museum announced it will closing the mezzanines in the Becoming BC Gallery, which have largely focused on promoting the story of European settlement as it starts its efforts to decolonize the indigenous exhibits. The decision was made in response to the calls from indigenous leaders to make the institution a welcoming place for everyone. The closure of the indigenous exhibits is a necessary as the museum begins to create new narratives that include underrepresented voices and stories of people in B.C.



BACKGROUND

The current plan presented by the museum is that popular galleries will be closed and dismantled while the museum consults and plans what to do with the space. Given the complexity of consultation combined with the number of stakeholder groups and the technical challenges of designing new museum exhibitions, the process could be lengthy:

"The process could take years, Muzyka [acting CEO] said, as consultations begin with "all voices from British Columbia" on how to redesign and curate the third floor. Until it's complete, the third floor will remain closed."

[Vancouver Sun, November 4, 2021]

We would like to think that the Museum has begun to at least consider what kind of exhibit might replace the "colonial" exhibits that are to be removed, but of course if the expressed desire for consultation is sincere these ideas can only be in the most general form.

The museum does not attract the number of visitors as it did when it was free, but it is still a significant part of Victoria's tourist industry. Closing some of the most popular galleries can only hurt our attractiveness to visitors. A process of consultation that appears to drag on unduly, at a cost to our economy, may work against, rather than for, the process of reconciliation with First Nations and other groups.

If the museum were to carry out the process of consultation and detailed exhibit design before closing the exhibits, the period when the galleries are "dark" could be reduced from years to months.

RECOMMENDATION

That the Mayor write on behalf of council to the Provincial government and to Royal BC Museum board members to request galleries of the museum intended for redevelopment remain open to the public until consultation is completed, themes for the replacement exhibits are determined, and detailed design is complete.

Third Floor Galleries - Updates for December 6, 2021

On November 3, 2021, the Royal BC Museum announced it will be closing the third-floor galleries, at 6:00pm on December 31, 2021. This includes the Becoming BC and First Peoples galleries.

Why are the third floor galleries being dismantled?

In 2019, Government undertook a public engagement to inform the modernization of the museum. We heard that British Columbians want us to make changes that will include the voices and reflect the lived experiences of the communities and peoples in British Columbia. It's imperative to ensure the stories of Indigenous peoples and that of other cultural groups who have helped to build this beautiful province are accurately reflected in our exhibits at the RBCM. This decision is aligned with our government's commitment to truth and reconciliation that demands we diversify the way we share the history of B.C.

The steps to modernize and reimagine the RBCM in the 21st century will benefit the generations that follow. Museums around the world are undergoing a similar process.

Aside from the wooden facades, and Captain Vancouver's ship, all the artifacts in the Becoming BC Gallery, which includes Old Town, and the First Peoples Gallery are being kept and conserved. Many of these artifacts will form part of the new galleries. No history is being erased and no treasures are being destroyed. What is being dismantled is the display cases, the wooden facades and staging, which includes Old Town and the ship *Discovery*.

The facades, staging and display cases of the exhibits need to be modernized. When the galleries on the third floor were built over 50 years ago, materials were used that do not meet today's standards. They contain asbestos, lead, and other hazardous material.

Suggestion to include government's commitment to the RBCM and making it a priority through its mandates

Why is this happening now?

Government initially started its Modernization process at the Royal BC Museum four years ago. The need for upgraded facilities to preserve and protect cultural and historical treasures of British Columbia was identified and shared publicly. The Museum's extensive collections have outgrown the available space and the buildings no longer meet today's accessibility or seismic standards.

The Collections and Research Building (CRB) in Colwood is the first phase of the Modernization project and is currently in the request for proposals stage. The successful design and build team will be announced in Summer 2022 and the CRB is expected to open in 2025.

As part of the Modernization project, in the government consultation in 2019, we heard that British Columbians want us to make changes that will include the voices and reflect the lived experiences of the communities and peoples in British Columbia.

The intent to move forward on the updates required to the galleries was shared more recently in our June 29th 2021 Report to British Columbians, which outlined the need for the Museum to replace its outdated human history galleries with inclusive new exhibits that reflect the diversity of the people of British Columbia.

Government is currently reviewing options for the second phase of Modernization, which could include a brand-new building. A decision is expected in 2022.

Will Old Town be rebuilt?

It has always been our intention that Old Town and the First Peoples Gallery will return in some form and will reappear in future galleries with more inclusive storytelling.

We have heard from many British Columbians that Old Town is their most loved part of the museum. The immersive sights and smells are a popular highlight. These opinions, thoughts, concerns and ideas will help to inform future decisions and will be part of the museum's community outreach and engagement process over the coming years.

The asbestos issue in the facades of the exhibits, including Old Town and the First Peoples Gallery. It is important to note that these are just facades, essentially immersive display cases, and they can be recreated using materials that meet today's standards. The historical and cultural treasures housed within these facades will all carefully removed and conserved. No history is being erased and no treasures are being destroyed.

Is the asbestos in the exhibitions a risk to visitors?

The asbestos within the exhibition facades is not a risk to visitors until it is disturbed. Removing it has been a priority for the museum for some time now. Building materials containing asbestos were commonly used until the associated health risks were understood. Canada banned the use of asbestos in 1979. Parts of the Becoming BC gallery were opened in 1972, and the First Peoples' Gallery in 1977. Asbestos poses very little risk to health until the fibres are released into the air; this is a common issue during renovations to older buildings such as the museum. When the fibres are released into the air, they can cause respiratory problems. HealthLink BC has provided information regarding asbestos.

Is the asbestos in the exhibitions a risk to museum staff?

The museum staff who will be working on the decanting process on the third floor were fitted for and equipped with special respiratory equipment to protect them while they conduct this important work.

The process of decanting galleries—what does "decant" actually mean?

"Decant" is a term frequently used in a museum context and means to remove sensitive historical objects or specimens from their gallery displays, and or eturn them to storage in collections areas. It does not refer to the exhibition facades

What does decanting involve?

Decanting involves an initial inspection of the collections on display to determine whether conservation treatment is necessary, to preserve the objects for future exhibits and future generations, before they are returned to collections for storage- and considered for use in future exhibits.

Indigenous cultural belongings, such as those on display in the First Peoples Gallery, take even longer to decant because the process must follow important cultural protocols set by the communities from where the objects originated.

What exhibits have been closed since the November 3rd announcement?

The lumber and mining mezzanines in the Becoming BC gallery, and the Cosmology display in the First Peoples' gallery closed in November. The work on decanting these exhibitions has begun, however none of the work will involve disrupting hazardous material until the third floor is fully closed. All other exhibitions, including the ship Discovery, Old Town, the gold panning exhibition featuring the water wheel and Totem Hall will remain open to visitors until December 31st 2021.

Who is responsible for the decanting work?

At the Royal BC Museum, decanting is overseen by curators, conservators or collections managers—all of whom are trained to safely handle collections. This work will take place in partnership with communities where relevant, to ensure artifacts are handled in the culturally appropriate ways.

There are no wrecking crews, construction workers or renovation labourers involved in the process of decanting. Historical objects and specimens are very fragile and sensitive to their environments, so decanting can only be performed by museum professionals who are specially trained to handle the collections.

Once the decanting process is completed, where are the items going?

The objects removed from the galleries will be carefully removed, packed and stored. Some items will find a home in the new Collections and Research Building, scheduled to open in 2025 in Colwood, BC. Some items from the Becoming BC and First Peoples Gallery may be included in the new galleries at the museum site.

How long will the process take?

We anticipate the process will take several years.

Decanting is a delicate process that can only be overseen by specially trained museum staff; and it is very time consuming. To ensure the safety of the historical objects and specimens on display, the work must be performed carefully.

Indigenous cultural belongings, such as those on display in the First Peoples Gallery, take even longer to decant because the process must follow important cultural protocols set by the communities from where the objects originated.

How long have the objects been untouched in some of those exhibits?

With the exception of regular conservation inspections, many objects in the third-floor galleries have been on display since the galleries first opened, 50 years ago. A thorough review of where and why objects are on display is long overdue.

How are galleries and exhibitions maintained over time?

Objects on display receive regular inspections and, if necessary, conservation treatment. There are daily inspections of the museum by the Exhibitions team, where they look for obvious signs of disruption or damage to the galleries, these are also monitored by our security team on camera.

The Conservation and Collections teams practice regular care and maintenance in terms of dusting and cleaning of open displays and running an integrated pest management program.

Third Floor (Human History) Galleries – Updates for December 10, 2021

Context: On November 3, 2021, the Royal BC Museum (the museum) announced we will be closing the third-floor galleries, at 6:00pm on December 31, 2021. This includes the Becoming BC and First Peoples galleries.

Why are the third floor galleries being closed?

As part of the Modernization project, in the government consultation in 2019, we heard that British Columbians want us to make changes that will include the voices and reflect the lived experiences of the communities and peoples in British Columbia.

It's imperative to ensure the stories of Indigenous peoples and that of other institutionally underrepresented peoples are accurately reflected in our exhibits and galleries at the museum.

All the artifacts and cultural items in the First Peoples gallery and the Becoming BC gallery, which includes Old Town, are being kept and conserved. Many of these artifacts will form part of the new galleries. No histories are being erased and no treasures are being destroyed. Structures like the display cases, the wooden facades and staging, which includes Old Town and Captain Vancouver's ship *HMS Discovery* will be dismantled.

The facades, staging and display cases of the exhibits need to be modernized. When the galleries on the third floor were built over 50 years ago, materials were used that do not meet today's standards. They contain hazardous materials such as asbestos and lead. In normal operations these materials do no provide any risk to visitors or staff, but with the modernizing and changing of the spaces, these materials could be disturbed which requires us to take proper precautions and ensure everything is modernized and up to current standards.

The B.C. government is working to modernize the Royal BC Museum. As outlined in Minister of Tourism, Arts, Culture and Sport's mandate letter, work continues to redevelop the museum.

Why is this happening now?

The museum's board of directors has committed to modernizing the museum and ensuring it is a culturally safe and inclusive place for all the people of BC.

The museum has been working toward modernization for a number of years. In 2018, the Province began working with the museum to support modernization. The need for upgraded facilities to preserve and protect the collections was identified and has been shared publicly. The museum and archives' extensive collections have outgrown the available space and the buildings no longer meet today's accessibility or seismic standards.

The Collections and Research Building (CRB) in Colwood is the first phase of the Modernization project and is currently in the request for proposals stage. The successful design and build team will be announced in summer 2022 and the CRB is expected to open in summer 2025.

The intent to move forward on the updates required to the galleries was shared in our. June 29th 2021 Report to British Columbians, which outlined the need for the museum to replace our outdated Human History galleries with inclusive new exhibits that reflect the many histories of the people in British Columbia.

Government is currently reviewing options for the second phase of Modernization, which could include a new building. A decision is expected in 2022.

Community engagement is an important part of modernization. We have begun initial outreach, including an interactive survey posted on the third floor of the museum that asks visitors to share what they love most about the galleries and what they would like to see in the future. We are also in the planning stages of a formal province wide public outreach process which will begin in April 2022.

Will Old Town be rebuilt?

It has always been our intention that future galleries continue to be immersive and experiential. Deep consideration and collaboration on how to develop a more inclusive and contemporary experience, including Old Town and the First Peoples Gallery, will be undertaken in the next few years.

We have heard from many British Columbians that Old Town is a loved part of the museum. The immersive sights and smells are a popular highlight. These opinions, thoughts, concerns and ideas will help to inform future decisions and will be part of the museum's community outreach and engagement process over the coming years.

There are hazardous materials in the facades of the exhibits, including Old Town and the First Peoples Gallery. It is important to note that these are just facades, essentially immersive display cases and props, and they can be recreated using materials that meet today's standards. In normal operations these materials do no provide any risk to visitors or staff, but with the decanting of the spaces, these materials could be disturbed which requires us to take proper precautions and ensure everything is modernized and up to current standards.

The historical and cultural objects housed within these facades will all carefully removed and conserved. No histories are being erased and no collections are being destroyed.

Are the hazardous materials in the exhibits a risk to visitors?

The materials within the exhibition facades is not a risk to visitors. Removing hazards has been a priority for the museum for a number of years. In normal operations these materials do no provide any risk to visitors or staff, but with the modernization and changes to the spaces, these materials could be disturbed which requires us to take proper precautions and ensure everything is modernized and up to current standards.

Are the hazardous materials in the exhibitions a risk to museum staff?

The museum has a hazardous materials consultant providing direction and advice for all work. The museum staff who will be working on the decanting process on the third floor are all trained to work within those areas and are fitted for and equipped with special safety equipment to protect them while they conduct this important work.

What exhibits have been closed since the November 3rd announcement?

The lumber and mining mezzanines in the Becoming BC gallery, and the Cosmology display in the First Peoples' gallery closed in November. The work on decanting these exhibitions has begun,

however none of the work will involve disrupting hazardous material until the third floor is fully closed. All other exhibits, including the ship Discovery, Old Town, the gold panning exhibit (featuring the water wheel) and Totem Hall will remain open to visitors until December 31, 2021.

The process of decanting galleries—what does "decant" actually mean?

"Decant" is a term frequently used in a museum context and means to remove collections - historical objects or specimens - from their gallery displays.

What does decanting involve?

Decanting involves an initial inspection of the collections on display to determine whether conservation treatment is necessary, to preserve the objects for future exhibits and future generations, before they are returned to collections for storage and considered for use in future exhibits or research.

Indigenous cultural belongings, such as those on display in the First Peoples Gallery, take longer to decant because the process must follow important cultural protocols set by the communities from where the objects originated. Museum staff will continue to work with communities on access to their cultural objects and treasures throughout the closure.

Who is responsible for the decanting work?

At the Royal BC Museum, decanting is overseen by curators, conservators and collections managers—all of whom are trained to safely handle collections. This work will take place in partnership with communities where appropriate, to ensure artifacts are handled with proper cultural protocols.

There are no demolition crews, construction workers or renovation labourers involved in the process of decanting. Historical collections are very fragile and sensitive to their environments, so decanting can only be performed by museum professionals who are trained to handle the collections.

Once the decanting process is completed, where are the items going?

The objects removed from the galleries will be carefully removed, packed and stored. Items from the Becoming BC and First Peoples gallery will be included in the new galleries at the museum site.

How long have the objects been untouched in some of those exhibits?

With the exception of regular conservation inspections, many objects in the third-floor galleries have been on display since the galleries first opened, 50 years ago. A thorough review of where and why objects are on display is long overdue.

How are galleries and exhibitions maintained over time?

Objects on display receive regular inspections and, if necessary, conservation treatment. There are daily inspections of the museum by the Exhibitions team, where they look for obvious signs of disruption or damage to the galleries, these are also monitored by our security team on camera.

The Conservation and Collections teams practice regular care and maintenance in terms of dusting and cleaning of open displays and running an integrated pest management program.

BACKGROUND

On September 18, 2020, the B.C. government announced the first phase of the Royal BC Museum Modernization project, the construction of the Collections and Research Building (CRB). The government has not yet made its decision on the scope of the redevelopment of the downtown RBCM location. The government anticipates making a final decision on that phase in 2022.

The B.C. governmentRBCM purchased an 8-acre parcel of land in the Royal Bay Development in Colwood for \$14.9 million. The 15,500 square-metre facility will use mass timber construction and meet CleanBC energy efficiency standards. Building construction will generate more than 950 direct and indirect good-paying jobs.

In Fall 2020 the government began preparing the site for construction. The project posted the request for qualifications (RFQ) in June of 2021 to secure a proponent to design and build the facility. The RFQ closed on Sept. 8, 2021 and three of the six respondents were shortlisted to participate in the request for proposal (RFP) stage which runs from November 2021 to June 2022. The three teams invited to participate were:

- · Kinetic Construction Ltd. Smith Bros. & Wilson (B.C.) Ltd. and Wright Holdings Inc.
 - o Diamond and Schmitt Architects, Inc.
 - o Aspect Structural Engineers Canada Ltd.
- · Ledcor Design-Build (B.C.) Inc. and Knappett Projects Inc.
 - o John McAslan and Partners
 - o Fast + Epp Structural Engineers Inc.
- Maple Reinders Constructors Ltd.
 - Michael Green Architecture Inc.
 - o Equilibrium Consulting Inc.

Partial compensation in the amount of \$1 million will be paid to each unsuccessful proponent in accordance with the terms of the RFP and is intended to partially cover the costs to participate in the RFP process. This is standard business practice for major infrastructure design-build procurements, led by Infrastructure BC, to ensure robust competition and high quality, responsive submissions.

The government expects to break ground in fall 2022 and complete the CRB in winter 2024.

The museum's galleries were developed a half century ago and they do not accurately reflect the many people from diverse cultures, including Europeans, who have contributed to the province's history. In 2019, Government undertook a public engagement to inform the modernization of the museum resulting in British Columbians wanting changes that would ensure the stories of Indigenous peoples, and that of other cultural groups who have helped to build this beautiful province, are accurately reflected in the museum's exhibits.

On November 3, 2021, The Royal BC Museum announced that it would close sections of the third floor to start the process of decolonization in these galleries, in response to the call to action from Indigenous leaders to increase cultural safety and ensure the museum is a welcome place for everyone.

Full closure of the third floor occurred January 2, 2022. The news has generated substantial negative media attention and public reaction suggesting the museum is attempting to erase European settler history, both in mainstream media and on social media platforms.

Public Engagement

From April 1, 2019 to June 27, 2019, the B.C. government held a public engagement on RBCM's future. The feedback from the engagement helped inform the business case. The government held seven public meetings in five communities (Victoria, Vancouver, Kelowna, Prince George and Duncan), and a

province-wide virtual meeting. The government also hosted an engagement website that garnered a total of 5,182 visits and 177 online comments. In addition, on Sept. 5-6 and 10-11, 2019, RBCM led focused engagement sessions with Indigenous peoples.

The museum is currently in the planning stages of a formal province wide public outreach process which will begin in Spring 2022. The purpose of this community engagement is to inform the modernization process and the development of the new broader, inclusive narrative for the galleries.

I read the following article this morning and am very concerned. A Public Service Agency investigation into racism at the Royal BC Museum concluded "The Museum is a dysfunctional and 'toxic' workplace, characterized by a culture of fear and distrust,". Now the mismanagement is resulting in complete demolition of many exhibits including Chinatown and the First Nations Languages exhibit without any plan or budget for the replacement. As a crown corporation, the expectation will be for government to foot much of the bill. Without a plan in place, this seems to be incredibly wasteful. It seems the responsible path would be to delay demolition until stakeholders have agreed to a plan for the replacement and budget has been obtained.

This is probably wishful thinking but I am hoping that bringing this to your attention could result in some intervention by the Provincial Government. As mentioned, the article notes a start date for demolition of January 2nd.

Thank you for reaching out, and hope all is well. Happy to share some KM's for you to include in a response to Minister Popham's constituent.

KM's:

Will there be further closures in the future?

- The narrative of the galleries on the third floor celebrates a European-settler view of what is now British Columbia, and is long overdue for updates.
- o The work to include under-represented voices and contemporary stories of BC begins on the third floor.

What other steps out of the report to BC has the museum undertaken?

 In collaboration with our Indigenous Advisory & Advocacy Committee the museum is reviewing every aspect of the organization from governance at the board level, staffing, HR policies, to collections, research, exhibitions, and inclusion of under-represented voices.

What will the new galleries look like?

- The vision for updated, inclusive galleries will be informed by consultation with stakeholders including community partners.
- We will ensure Indigenous voices are heard and included, and the interpretation of Indigenous cultures is led by Indigenous communities.
- We will seek out diverse perspectives on BC identity—especially underrepresented voices—to broaden historical narratives and foster inclusivity.

When will community consultation on the new narratives start?

Some initial consultation has been undertaken, and we will be reaching out to communities across the province to ensure that the experiences and contributions of contemporary Indigenous people, as well as Canadians from other underrepresented groups, as the project continues.

Are you closing the third-floor galleries due to repatriation?

- No, the galleries are not closing due to repatriation, they are closing as part of our efforts around decolonization and as a first step towards broader and more inclusive narratives.
- The Indigenous Collections and Repatriation department (ICAR) will continue to work through repatriation requests and work with Indigenous communities.

What is next?

- The next steps are for the third-floor galleries to be deconstructed and decanted with artifacts being returned to collections for care and conservation treatment.
- Concurrently, we'll determine a process for community outreach and engagement to hear the diverse perspectives on BC identity, that will help to shape the future narratives.

Quote from RBCM Acting CEO Daniel Muzyka

"Decolonization of the museum's galleries is important and long overdue," says acting CEO Daniel Muzyka. "As part of our work to implement modernized museum practices, in particular our efforts around decolonization, we will be closing the third-floor so we can decant our galleries. This is necessary to begin the long-term work of creating new narratives that include under-represented voices and reflect the lived experiences and contemporary stories of the people in BC."

Thank you for reaching out, and hope all is well. Happy to share some KM's for you to include in a response to Minister Popham's constituent.

KM's:

Will there be further closures in the future?

- The narrative of the galleries on the third floor celebrates a European-settler view of what is now British Columbia, and is long overdue for updates.
- o The work to include under-represented voices and contemporary stories of BC begins on the third floor.

What other steps out of the report to BC has the museum undertaken?

 In collaboration with our Indigenous Advisory & Advocacy Committee the museum is reviewing every aspect of the organization from governance at the board level, staffing, HR policies, to collections, research, exhibitions, and inclusion of under-represented voices.

What will the new galleries look like?

- The vision for updated, inclusive galleries will be informed by consultation with stakeholders including community partners.
- We will ensure Indigenous voices are heard and included, and the interpretation of Indigenous cultures is led by Indigenous communities.
- We will seek out diverse perspectives on BC identity—especially underrepresented voices—to broaden historical narratives and foster inclusivity.

When will community consultation on the new narratives start?

Some initial consultation has been undertaken, and we will be reaching out to communities across the province to ensure that the experiences and contributions of contemporary Indigenous people, as well as Canadians from other underrepresented groups, as the project continues.

Are you closing the third-floor galleries due to repatriation?

- No, the galleries are not closing due to repatriation, they are closing as part of our efforts around decolonization and as a first step towards broader and more inclusive narratives.
- The Indigenous Collections and Repatriation department (ICAR) will continue to work through repatriation requests and work with Indigenous communities.

What is next?

- The next steps are for the third-floor galleries to be deconstructed and decanted with artifacts being returned to collections for care and conservation treatment.
- Concurrently, we'll determine a process for community outreach and engagement to hear the diverse perspectives on BC identity, that will help to shape the future narratives.

Quote from RBCM Acting CEO Daniel Muzyka

"Decolonization of the museum's galleries is important and long overdue," says acting CEO Daniel Muzyka. "As part of our work to implement modernized museum practices, in particular our efforts around decolonization, we will be closing the third-floor so we can decant our galleries. This is necessary to begin the long-term work of creating new narratives that include under-represented voices and reflect the lived experiences and contemporary stories of the people in BC."

The Royal BC Museum third floor comprises the First Peoples gallery, *Our Living Languages: First Peoples' Voices in BC* exhibition, and *Becoming BC* gallery. A phased approach to closure allows British Columbians to plan a last visit (on or before December 31, 2021) to beloved exhibits as they were originally built.

"Decolonization of the museum's galleries is important and long overdue, says acting CEO Daniel Muzyka. "As part of our work to implement modernized museum practices, in particular our efforts around decolonization, we will be closing the third-floor so we can decant our galleries. This is necessary to begin the long-term work of creating new narratives that include under-represented voices and reflect the lived experiences and contemporary stories of the people in BC."

The phased closure will begin with the mezzanines in the *Becoming BC* gallery, which have largely focused on promoting the story of the European settlement of BC. Initial work will have a very limited impact for visitors through to the end of the year.

"We are diversifying and decolonizing the way we share the history of B.C.," says Minister of Tourism, Arts, Culture and Sport, Hon. Melanie Mark. "For too long, museums have been colonial institutions that exclude others from telling their own stories. We have an opportunity to change that, and it starts here, now, on the museum's third floor."

Royal BC Museum staff will continue to offer opportunities for community engagement through webinars, online learning and virtual tours. The museum will also expand its provincial travelling exhibition and pop-up exhibit programs, including installations across Greater Victoria.

· What are the timelines for closure for the third-floor galleries?

- There will be minimal closures of the third-floor galleries, with limited impact to visitors, starting in November. The phased closures will affect lower-traffic areas including the mezzanine levels in Old Town. Forestry and Mining.
- There will be a full closure of the third-floor galleries as of January 2nd 2022.

Will there be further closures in the future?

- The narrative of the galleries on the third floor celebrates a European-settler view of what is now British Columbia, and is long overdue for updates.
- o The work to include under-represented voices and contemporary stories of BC begins on the third floor.

• Is this the first stage of a full closure? Is the museum going to close?

 Closing and beginning to decant the third-floor galleries is an important first step on a journey to broaden historical narratives and foster inclusivity.

· Does this mean the museum project is moving forward?

 This is one of the first milestones on the journey to implement contemporary museum practices and begin the necessary long-term work of creating new narratives that include under-represented voices and contemporary stories of the people in BC.

What is next?

- The next steps are for the third-floor galleries to be deconstructed and decanted with artifacts being returned to collections for care and conservation treatment.
- Concurrently, we'll determine a process for community outreach and engagement to hear the diverse perspectives on BC identity, that will help to shape the future narratives.

• What other steps out of the report to BC has the museum undertaken?

 In collaboration with our Indigenous Advisory & Advocacy Committee the museum is reviewing every aspect of the organization from governance, staffing, HR policies, to collections, research, exhibitions, and inclusion of under-represented voices.

How are the museum staff affected?

Museum staff will play an integral role in decanting the exhibits and packing up the artifacts, specimens
and cultural belongings. This is an exciting time to be a part of crafting new narratives in how we tell the
stories of the people in BC.

What will happen to the current exhibits from the third floor e.g. Old Town?

- o Exhibits on the third floor will be deconstructed and decanted.
- Artifacts, specimens and other sensitive objects will be returned to collections areas for inspection and conservation treatment.
- Work will be done to review other exhibit materials and some pieces may be stored for future use.

What will the new galleries look like?

- The vision for updated, inclusive galleries will be informed by consultation with stakeholders including community partners.
- We will ensure Indigenous voices are heard and included, and the interpretation of Indigenous cultures is led by Indigenous communities.
- We will seek out diverse perspectives on BC identity—especially underrepresented voices—to broaden historical narratives and foster inclusivity.

• When will community consultation on the new narratives start?

Some initial consultation has been undertaken, and we will be reaching out to communities across the

· What is the cost of the new gallery work?

- The initial work is on deconstructing and decanting the existing exhibits: future milestones will lay out a plan for the new galleries.

Why does this need to happen now?

We've heard from British Columbians and they want us to act, to make bold changes that will include
the voices and reflect the lived experiences of the communities and peoples in the land we call British
Columbia today. Closing the third-floor galleries is the first step on a journey to doing this.

• Why was there no public consultation?

- <u>During our consultation in 2019 \Wwe-have</u> heard loudly and clearly from British Columbians that the status quo is not good enough—that change is urgently needed. We are answering that call.
- Regarding this specific announcement, there was never any way the museum could begin work to update gallery narratives and build a more-inclusive museum without closing the third-floor.

- The Collections and Research Building (CRB), planned for Colwood, is a separate project that will house the Royal BC Museum collections and research departments and the BC Archives, in a purpose-built facility

How can you close the First Peoples Gallery to Indigenous peoples?

 We recognize that, even though there is much work to be done to update the First Peoples Gallery, it is a very important place to Indigenous and non-Indigenous visitors. While the gallery is closed, the Indigenous Collections and Repatriation department (ICAR) will continue
to serve Indigenous communities in BC through private consultation, visits to the collections, online
access and, continued focus on repatriation of Indigenous cultural materials.

• How will people learn about BC Human History with these galleries closed?

- The Learning Portal and Teacher's leaning aids created and managed by the museum, are incredible, freely accessible online resources to learn about all aspects of BC.
- The museum will continue to offer opportunities for community outreach and additional engagement through outreach, webinars, online learning (including the Learning Portal and teachers learning aids) and virtual tours. History, it seemed, happened somewhere else, wasn't at all interesting and didn't matter.

Vancouver is also a place where ongoing demolition and redevelopment give the visible past so little presence. So historical awareness helps foster a sense of continuity. More importantly, it offers perspective on the present and maybe the future too.

But in B.C. we have too few opportunities to engage young people and interested adults in the subject. The Becoming B.C. Gallery provided a great introduction not only to this province, but to history as a subject that's both interesting and important. The gallery also drew visitors to the museum's very extensive native exhibits.

Of course, no one with any concept of the subject would think a single museum gallery, book, university program or other source would comprise the alpha and omega of any historical topic. And there's sometimes an element of truth to the saying that history is written by the victors. But the accuracy of that statement depends on the degree of control imposed by the victors.

Recent events at the Royal B.C. Museum don't bode well for an accurate, balanced presentation of history.
