**ISSUE:**

Connecting displaced people and their animals with accommodations is a critical component of emergency management. s.13; s.17 to connect displaced people with a place to stay in an efficient manner.

**BACKGROUND:**

- After a year of unprecedented emergency management challenges – wildfires, flooding, landslides, and a global health pandemic – British Columbia is facing a new season of potential emergencies.
- B.C.’s accommodators – hotels, motels, and resorts – have played a large role in emergency response, primarily finding space for displaced people.
- The current system for finding accommodations for those displaced by disasters is ad-hoc and relies on a variety of booking systems, some analogue and time-consuming are launched when disaster strikes.
- The current approach to finding accommodation for displaced people is response-focused and does not fit Priority 4 of the United Nations Sendai Framework - enhancing disaster preparedness for effective response.

TACS provided advice to TRAN about being specific with information on highway closures. This comes from a webpage on TRAN site referencing “Highway 3 being open to essential travel” and need to be clear between what two points. TACS to clarify with TRAN if charter buses same as intercity buses as essential vehicles that can access Highway 5 or whether have to use Highway 3 only.

Watch for DBC newsletter tomorrow for winter travel guide and other info for businesses.

TACS continues to engage with the federal government on clarifying travel rules and providing certainty.

CCCTA connecting with Pacific Coastal on whether need to expand flights to Cariboo. Noted Adventure Charters is intercity bus company with service to Cariboo from Lower Mainland.

TOTA noted Merritt Municipal Campground is gone. No word yet on rebuilding.
