The activity residents have noticed taking place in this area is road shoulder maintenance being carried out by the maintenance contractor. The shoulders in the area were in need of grading to remove turf build-up and restore the shoulders to their original width. The road surfaces and bases will also drain properly which helps prevent potholes and road edge failures. Gravel will be added where required.

Ministry funding is uncertain so far this year for road reconstruction or paving on Salt Spring Island. In the interim, the Ministry will endeavor to accomplish as many improvements as possible under the road maintenance contract.

Re: Rourke Road and Beddis Road

I am replying to your e-mail sent to Mr. Murray Coell, MLA Saanich North and the Islands, concerning Rourke Road and Beddis Road.

The Ministry is aware of the condition of Rourke Road and Beddis Road but unfortunately funding to resurface the roads is not available at this time. I have listed Rourke Road for resurfacing; however, there are many roads on the Gulf Islands requiring rehabilitation. When funding is available the roads are reassessed and resurfaced on a priority basis according to condition and traffic volume. I will discuss with the maintenance contractor the inclusion of the worst sections of Rourke Road in the annual major asphalt-patching program next year.

Until such time as these roads can be included in our program, I will advise the contractor to ensure that regular patrols are carried out and any deficiencies such as potholes are promptly repaired. Under the present maintenance program, mowing is only done once a year. However, sight distance and visibility must be maintained at all times. If you do not obtain satisfaction from phoning the contractor concerning pothole repairs or sight distance issues, please contact my office at 250-952-4484.

Dave Edgar and I had a conversation concerning this proposed Slegg Lumber Development on Beddis Road a few months back.

the Ministry did not see a need for a traffic impact assessment for this development, and as we were not requesting this report, could not provide a terms of reference.

I have read through this report, and offer the following comments:

- The Bunt Report is suggesting that Beddis Road be posted at 40 kmh between Fulford-Ganges Road and the
 development site in order to obtain better sight distance. The minimum posted speed we allow is 50 kmh,
 and I do not believe that reducing the posted speed will make any difference to how drivers travel this road, and
 Douglas Road, which the report is using as the reason for the need to reduce the speed, generates very little
 traffic.
- The projected traffic volumes/increase identified in the report seems exceptionally high conclusions state 1200 1850 vpd. I have driven this road many times, and most of the time I am the only vehicle on the road for several kilometres, and on very few occasions, meet one or two other vehicles. I do not know if we have any current traffic counts for this road or the Fulford-Ganges/Beddis intersection.
- I am certain that the Ministry is not planning any improvements to the Fulford-Ganges/Beddis interstion, and I am not convinced that the Slegg Lumber people need to make any changes to this intersection. Do we have any accident data for this intersection?

I currently have a subdivision application in for this property to allow for the separate lot for the Slegg Lumber business, and another for the Farmers Coop business. If these changes/improvements to the intersection of Fulford-Ganges/Beddis are deemed to be necessary by the Ministry, then I can have this made a condition of the Preliminary Layout Approval.

Further to the Slegg lumber rezoning/OCP amendment application, I am forwarding a copy of the Transportation Impact Assessment completed for this project. While I realize that MOTI did not see any need for such a report, there was enough opposition to the project in the ALR exclusion phase of the project, that the applicant decided (with encouragement from the Islands Trust) to pursue a traffic impact assessment anyway.

We would appreciate your comments on the attached. Of particular interest to you, I think, are the following sections:

- Section 3.4 -- the Accident History, particularly at the intersection of Fulford-Ganges Road/Beddis Road/Charlesworth Road
- Recommendation 7, found on page 30 of the report, related to improvements at this intersection.

You may also wish to comment on the report from the perspective of the MOU between MOTI and the Islands Trust (1992) with regard to road standards and classifications.

If we could have your comments by July 22, that would be most helpful.

RE Access from Beddis Road to Lot 1, Sections 16 & 17, Range 5 East, North Salt Spring Island, Cowichan District, Plan 26104

Thank you for your letter dated August 21st, 2006 requesting clarification on the proper placement of an access to your property.

Your access should be a minimum of 15 metres from the intersection of Beddis Road and Price Road. I have enclosed an information package on residential driveways for your information.

A permit is not required for accesses to single family residences. However, if your intended use is multi-family or commercial, an access permit is required.

The Beddis Road / Douglas Road intersection does not currently meet the recommended minimum sight distances for 50 km/h or 40 km/h design and running speeds. While it appears that they could be met with vegetation clearance for 40 km/h, the sight lines for meeting 50 km/h requirements traverse private property and would require vegetation clearance and perhaps grading.

It is recommended that an advisory speed sign of 40 km/h be installed on Beddis Road northbound south of its intersection with Douglas Road in conjunction with undertaking the recommended vegetation clearance on the west side of Beddis Road to ensure that minimum recommended sight distances are met for this posted speed.


Beddis Road / Douglas Road as a three-legged with each approach leg having one lane in both travel directions. As shown in Exhibit 9, Douglas Road intersects with Beddis Road on the outside of a horizontal curve and there are concerns about adequate sight distances to the south for vehicles accessing Beddis Road from Douglas Road.

I write to advise you that the Salt Spring Island Local Trust Committee passed the following Resolution at its regular business meeting on February 2, 2012:

SSI-30-2012

It was MOVED and SECONDED that the Salt Spring Island Local Trust Committee request that the Ministry of Transportation and Infrastructure (MOTI) install an advisory 40 km per hour speed sign at the intersection of Beddis and Douglas Roads, Salt Spring Island, and manage vegetation along Beddis Road in such a way that sight lines are preserved in accordance with the suggestions of the Bunt report and the existing agreement between the Islands Trust and MOTI.
