Dear National Safety Code Carrier:

To improve the safety of the commercial carrier industry in British Columbia, a process to monitor carriers' safety performance has been implemented.

This letter is to alert you that your safety performance, as measured by your National Safety Code (NSC) Carrier Profile score(s), is higher than the provincial median for carriers of the same or similar fleet size. This raises safety concerns about your operation.

If your safety performance continues to deteriorate, your safety records will be audited. When the audit is complete, an overall audited Safety Rating is assigned. Tickets may be issued if violations are found during the audit.

If after audit there is further deterioration of your safety performance, a recommendation may be made to the Director, Commercial Vehicle Safety and Enforcement that your Safety Certificate be cancelled.



Commercial Vehicle Safety and Enforcement monitors carriers' safety performance to improve the safety of the commercial carrier industry in British Columbia.

 etc.) and any other document that can support the hours of service records
- Log books and/or time records if operating within 160 kms. of home terminal, along with supporting documentation, sorted by driver, for the last six (6) months. Examples of supporting documentation include bills of lading; shipping documents; fuel receipts (complete with accurate dates and times of fueling); accommodation receipts; driver dispatch receipts; driver trip receipts; payroll records; charter trip reports; and other receipts (meal, bridge tolls, truck wash, emergency repairs, etc.) and any other document that can support the hours of service records
- Trip inspection reports for the last 90 days
- Vehicle maintenance information (past 24 months)
- Copies of each vehicle registration (power units and trailers)
- Manufacturers' defect notices (recall notices) where applicable, and proof of repair(s)

A carrier safety inspector will audit your compliance with regulations pertaining to drivers, vehicles, hours of service, transport of dangerous goods (if applicable), and record-keeping practices. When the audit is complete, you will receive an overall audited Safety Rating. Tickets may be issued if violations are found during the audit.

It is an offense to obstruct an inspector conducting an audit (MVAR 37.33(2)).

Failure to appear for this audit or to provide the records requested will result in the immediate suspension of your NSC Safety Certificate and could lead to its cancellation.

Carrier must ensure that the commercial motor vehicle license plate or unit number appears on each daily log.

Carrier must ensure that the name of every carrier with whom the driver worked or with whom the driver was otherwise engaged during the day appears legibly on each daily log.

Carrier must ensure that the legible name of co-driver appears on each daily log.

Carrier must ensure that the start of the period covered by the log, where it is different than midnight, appears on each daily log.

Carrier must ensure that the home terminal address and principal place of business of each carrier for whom the driver worked or was otherwise engaged during the day appears legibly on each daily log.

Carrier must ensure that the total hours spent in each period of duty status appears on each daily log.
