-HOUSE DIVIDED INTO 4 SUITES (HOMEOWNERS ON FLR1; 2X RENTAL SUITES ON FLR 2; 1X RENTAL SUITE ON FLR 3) -
FIRE STARTED IN DETACHED GARAGE AND SPREAD TO HOUSE, CAUSING A TOTAL LOSS OF BUILDINGS AND
CONTENTS ON THIS PROPERTY, PLUS EXPOSURE DAMAGE TO NEIGHBORING HOUSE AT 7141 BURGESS ST. -s.22
(HOME OWNER) WAS TRYING TO ADD 2X 50 AMP BATTERIES TO POWER AUXILIARY EQUIPMENT ON AN ELECTRIC
SCOOTER (I.E. SCOOTER FOR HANDICAPPED PERSON) INSIDE THE GARAGE -POSITIVE AND NEGATIVE WIRES
ACCIDENTALLY CROSSED, CAUSING A SHORT CIRCUIT, WHICH IN TURN RESULTED IN ONE OR BOTH OF THE
BATTERIES OVERHEATING AND STARTING A FIRE -s.22 ATTEMPTED TO EXTINGUISH FIRE UNSUCCESSFULLY
