FIRE REPORT - **STRUCTURE** (NARRATIVE)

INCIDENT NUMBER: **DWV 2015 07 06 04 01**

Remarks:

THIS FIRE ORIGINATED IN THE UNSECURED GARAGE AT ABOUT 4:00 A.M. THE HOMEOWNER WOKE TO THE SOUND OF THE SMOKE ALARM. SHE OPENED THE FRONT DOOR AND SAW FIRE BURNING AROUND, BUT NOT IN OR ON, HER CAR, WHICH HAD BEEN LAST PARKED AND SECURED, WITH WINDOWS CLOSED AT ABOUT 8:30 P.M. THAT EVENING. THERE WERE NO ELECTRICAL OUTLETS IN THE GARAGE, NOR EVIDENCE RECOVERED THAT INDICATED A LIKELY CAUSE OF FIRE. SEVERAL WITNESSES STATED VERY SHORTLY THEREAFTER THAT THE ENTIRE AREA WAS ENGULFED IN FLAMES AND THAT THE FIRE HAD EXTENDED BEYOND THE GARAGE OUT THE NORTH SIDE TO THE HEDGE ON THE WEST SIDE OF THE PROPERTY AND THAT SPARKS WERE FALLING ON THE ADJACENT HOME. THIS FIRE IGNITED THE NEIGHBOURING HOUSE TO THE WEST AND CAUSED APPROXIMATELY \$22,000.00 DAMAGE.

s.22 WOKE ABOUT 4 A.M. TO WHAT SOUNDED LIKE BEARS IN A GARBAGE CANS, THEN THE CANS FALLING OVER AND TUMBLING DOWN THE DRIVEWAY. SHE THEN HEARD WHAT SOUNDED LIKE RAIN INTENSIFYING TO HAIL. SHE LOOKED OUT HER s.22 WINDOW AND SAW A SOLID ORANGE COLUMN WITH A POINTED TOP. AFTER CALLING 9-1-1, SHE LOOKED OUT AGAIN AND SAW A TORCH OF SPARKS COMING FROM THE CEDAR TREE BETWEEN 2668 AND 2670 BELLEVUE. SHE WENT OUTSIDE AND FROM THE STREET COULD SEE THE GARAGE OF 2668 BELLEVUE ENGULFED IN GLAME WITH NO GARAGE DOOR IN PLACE AND FLAMES RISING UP THE EAST WALL OF 2670 AND OVER THE ROOF AT THE NORTH EAST CORNER.
