Here are the bullets I will provide:

- In BC, the Insurance Corporation of British Columbia (ICBC) provides driver licensing services.
 Drivers licensing is covered under the BC Motor Vehicles Act (under the Ministry of Transportation).
- BC does not have a reciprocal licensing arrangement with Syria, so those with a Syrian driver's license will need to go through testing. However, if proof can be provided of driving experience, they may receive credit under ICBC's graduated licensing program.
- ICBC offers free, over-the-phone language services to help communicate with customer representatives, and it offers the knowledge test required for a learner's permit in 13 languages including Arabic.
- A learner's permit is good for two years, but requires the driver to have another adult, aged 25+ and with a class 5 licence, sitting in the passenger seat. They also may not drive between the hours of 12am and 5am. There are two stages to the GLP Program......a minimum 1 year learners stage with the adult aged 25 requirement and the hours you noted and an additional two year Novice Stage. A Road Test is required after each stage. The requirements under the Novice program is restrictions of two passengers without an adult......zero tolerance for alcohol for both the stages
- Interpretations services available immediately preceding the road test, but the ICBC policy requires that drivers take the Class 7 (Novice) and Class 5 road test unassisted. ICBC reports that thousands of road tests are taken each year using hand signals to indicate testing directions.

I will start with the Knowledge Test.......Arabic is one of the 13 languages that we have on the DL Knowledge Test (KT) Kiosks throughout the province......the expectation and policy is that knowledge tests and all others will be done unassisted. Once the KT is passed and it is time for a Road Test ICBC will recommend the customer comes into the office with someone who can translate......they usually do because of the language barrier and the support organizations come to support.

- Interpretations services are not available for road tests, and the ICBC operations manual currently requires that drivers take the Class 7 (Novice) and Class 5 road test unassisted.

Also, if we were looking to change the ICBC operations manual to allow for interpreters on road tests (perhaps as an exception for Syrian refugees)— to whom would you recommend I speak?
