Dear Mr Haley;

I am the person who phoned you about a small beach access road that full-on industrial waste applicants want on Pender Island and you asked me to send you an email.

I already contacted a different highways department regarding additionally added culverts diverting two large and important watersheds. He asked me to contact you with my concern.

Below two fast flowing watersheds going into Browning (ocean) Bay water has been recently diverted into two bays Hamilton and Brackett. Looking on Google map you can see the erosion/silt washing and filling up the bays with silt and highway, Driftwood Centre, farm pigs contaminates (public safety). The marina has been plagued by this for 40 years, now made worse because of a political play by a proposed industrial waste site application above Browning.

***Now the applicants want to put an industrial road allowance on a very small but main beach access road to our only real public beach. Originally this was a private beach access road used by the marina and little kids walking barefoot from their homes to the beach. times, cars and tourists stopped while huge industrial trucks compete to access and drive along this little road. It's a ridiculous, even a crazy concept to allow industrial traffic.

I and a friend walked and ground proofed this whole area. \$.22

wrong location for industrial, never mind industrial waste and big toxic trucks. In my opinion it is way too dangerous, destructive and will contaminate the entire beach area (public safety).

Highways originally turned them down but Recently a Trust Planner seems to be in conflict. (The maps have been manipulated and are a real mess). Your Pender highways people are old "friends" of the applicants. The island is small and everyone knows each other intimately so bias can't be helped. A clear responsible head must prevail.

This is wrong, deleterious and dangerous for children, families and traffic.

I am asking you to look into this and insist this road not be allowed for this purpose. It is too dangerous.

Decisions are being made very soon. This is an urgent matter.
