- The project extends the West Shore Parkway 3.5 kilometres between the Trans-Canada Highway and Highway 14 (Sooke Road). It is a new 2-lane road with bike lanes, sidewalks in residential areas, additional streetlights, transit stops, boulevard medians, and upgraded sewer infrastructure.
- Drivers will save time with a more direct connection between the two major commuting arteries, and it will be safer for cyclists and pedestrians.
- The City of Langford is delivering the project. Some sections are already open but this is the final piece that completes the connection between Highways 1 & 14. The project is finishing ahead of schedule.

- The Ministry of Transportation and Infrastructure built a second left turn lane on the Trans-Canada Highway to accommodate additional traffic that is expected to use the new connection from Highway 1 to Highway 14. It opened to traffic in November 2016.

Dear Minister Heyman,

I met recently with John Kimantas and Paul Grey, the most active members of the BC Marine Trails Network Association, an incorporated non-profit society. Attached below is the link to their proposal for an inside passage marine trail. My understanding is that they will be requesting a meeting with you, to make a more formal presentation, and also to provide some budget numbers. My understanding, without confining them to it, is that we are talking under a million dollars for a proposal that I think is extremely worthwhile and has great merit.

Their hope would be to consider this as a sesquicentennial project. As July 20, 2021 is the 150th anniversary of British Columbia becoming part of Canada. They have worked diligently already with First Nations along the coast and have established excellent relationships in that regard; indeed, it was the Snuneymuxw First Nation who hosted a significant event earlier this summer on Newcastle Island, which is managed under contract by Snuneymuxw First Nation for the British Columbia Parks system. The land involved on the Marine Trail is all crown land, and obviously requires the consent of First Nations, but the proposal is worthwhile, and their association has nearly 500 members now. The Island Coastal Economic Trust provided funding to them, they were incorporated in 2009 and obtained charitable status in 2016. Because this impacts on so many of our colleagues, I am forwarding copies of this to various MLAs as outlined, with a hope that it will inspire their interest and support for what, from a financial perspective, is a modest proposal, but one that would have a significant benefit. I appreciate your attention to this, and your office should expect Mr. Kimantas and Mr. Grey, and potentially other representatives of the BC Marine Trails network, to be contacting your office for a meeting.

I am writing this letter to you in regards to concerns I have regarding B.C. Ferries and members of their Commercial Accounts and Customer Care team. I currently run a small business in Victoria and have been a customer of B.C. Ferries s.21 We have been receiving complimentary blocks of reservations for the past 2 years. When it came to renewing our block of reservations they sent 2 representatives from the Commercial Accounts over and told us that they were no longer going to extend our reservations due to the fact that we do not fall under the criteria of a commercial vehicle. While we are not big transport vehicles our business relies heavily on delivering vehicles in a timely manner and also it helps my employees guarantee they will not be sitting in heavy ferry traffic for 3-5 hours in summer months and long weekends. Also this will have a huge impact on the business. The one criteria that the commercial team kept emphasizing was were not falling under the specified weight to be deemed a commercial vehicle. While we may not fall in that weight category we can move up to 20-30 vehicles a day from Nanaimo and Victoria terminals. Our ferry invoices are generally s.21 monthly. I have called Customer Care now several times to continue negotiations with them and they are very unwilling to do that. I am hoping that someone from your office can assist us some way that we may open up negotiations once again to discuss this. Here are some points listed below that may be helpful.

- . receiving reservations for 2 years.
- . received reservations for the 7 a.m. and 1 p.m. sailing only (10) Vic. To Van. And Van. To Vic.
- . received reservations for the 6:30 a.m. and 12:50 sailing only (8) Nan. To Van and Van. To Nan.
- . took away reservations at the end of September 2017 with no real reason.
- . have sent correspondence to Commercial Accounts and Customer Care and they are no longer responding back.
- .s.21
- .
- . they provide us with ferry cards so it cannot be paid on credit card and s.21
- . my invoices are usually between s.21
- . my employees also spend money every day on the ferry.
- . IDDL use the ferry 6 days a week 12 months a year.

- . we are a commercial business and have a corporate account.
- . they claimed when they gave us the reservations it was a big mistake but couldn't really give me any specifics except GVW under 5,500 kg.
- . have requested to speak to Supervisor or Manager and they ignored that request.
- . I had been corresponding with Jill Hawe/Assistant Manager/Customer Care.
- . Met with Navin Sami/General Manager/Commercial Services Division back in July, have not spoken to him since.
- . I have correspondence and data supporting correspondence prior to the last few weeks.

I would like to thank you in advance for taking the time to read this letter to you. I feel B.C. Ferries will have a huge impact on my business due to the long waits, and their lack of concern for small business in B.C. is concerning.

Last week, Gibsons Councilors Silas White and Jeremy Valeriote, and Chief Administrative Officer Emanuel Machado, invited s.2 and I (s.22 Sunshine Coast commuters) to meet with the B.C. Minister of Transportation and Infrastructure, Claire Trevena. We pitched a proposal seeking a small subsidy for a foot-passenger-only ferry service from Lower Gibsons to Downtown Vancouver. We suggested it could be an extension contract of BC Ferries (similar to the Stormaway III service provided by Kona Winds Charters to Kcats Island), or put out to tender for a stand-alone service provider. Point being, the Sunshine Coast needs more frequent and reliable transportation options for people trying to get to and from their places of employment if we want to attract and retain young families. The Town of Gibsons recognizes the value of having a foot-passenger-only ferry service so much that it has included it in the Town's Strategic Plan!

As a commuter of many years, year after year, I have seen young family after young family move to the Coast, only to give up and move back to the city after a year or two due to ferry burn-out. There are lots of spin-off benefits to supporting commuters on the Sunshine Coast: many of their spouses end up working in our hospital, school system, and social programs. Plus, their kids are in our schools, they buy homes in our communities, and they spend 95% of their salaries on the Coast.

The Minister was very supportive of the proposal, but stated she needs to spend the next year focusing on "fixing BC Ferries." We closed the meeting with a request that she consider incorporating our proposal into whatever coast-wide strategic plan the BC Government is developing, and offered whatever support our community can provide.

Thank you Town of Gibsons, for recognizing the value of commuters to our Sunshine Coast communities and for seeking creative opportunities to bolster support for our Strategic Plan.

I have spoken to Minister Trevena about the concerns raised by residents and visitors to the Pender Harbour area around the road conditions –in particular Irvines Landing Road and Hotel Lake Road.

Irvines Landing Road is an old logging road that wasn't built to modern specifications. It appears to be sluffing into Mixel Lake. As one writer stated, "There is no shoulder so the pavement itself is collapsing into the lake and with no guard rails drivers constantly go over the middle line, on a blind corner." This has led to a few near-misses that I have heard about, and was reportedly a factor in a fatality a few years ago. Hotel Lake has the same serious problems. Lee Road is also seen as dangerous by local residents. People tend to drive in the middle of the road when the edges are bumpy and broken. There are no warning signs, no slow signs, and no center line. I've been told of a recent near-miss on Lee Road.

I was at a public meeting this past weekend, and I will be attending another this Friday. The issue was raised then, and I anticipate it will be raised again. I would really appreciate it if I could reassure residents that these concerns are being addressed. Thanks for your ongoing attention to this and other issues on the Sunshine Coast.

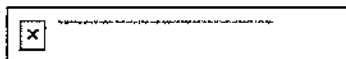

Lisa,

I visited the exterior of the Hwy 1/Mtn Hwy site today and took, again, some disturbing photos. Generally, the entire site is completely exposed to erosion when the next rain event occurs. Issues at site include the following:

1. Multiple storm drain covers that have street grates protected but curb grates are not protected (photo 0575).
2. Multiple storm drain covers that are either broken (photo 0583), clogged (photo 0605), or using improper/non-industry standard material (photo 0585).
3. Multiple storm drains that are in succession that are not filtering dirty water and sending it to an open storm curb grate (photo 0614).
4. Both site entrances on the south side of Highway 1 are armoured but are clogged with sediment with it being driven out on to the roads (photos 0602 and 0612).
5. Sediment (silt) fence is improperly sited and installed, and is blocking pedestrian access (photo 0581). Sediment fence is not used on steep ground. It is to capture slow moving sediment laden water on shallow slopes. I counted five different locations where the sediment fence is sited incorrectly and improperly installed.
6. An excavator is working directly beside Keith Creek (photo 0596). Is the excavator running biological friendly oils? The sediment fence is not an effective barrier against excavator fluid spills.
7. A fuel container is not in secondary containment and is at risk of machinery strikes as it is sited improperly (photo 0592).
8. The one route that I am aware of that is used to drain water from the site is now high and dry (photo 0600). I could not see where a sedimentation pond (an area to locate site water to allow sediment to settle out of suspension) is located.

9. Ground disturbance activities along Keith Road has resulted in piles of dirt left on the edge of the sidewalk (photo 0609) and is at risk of being transported onto Keith Road.
10. Poly sheeting that was placed in May has not been maintained and is presently torn and un-anchored (photo 0593).
11. Multiple slopes with minimal vegetation cover are not protected (photo 0590) and have been in this state since clearing and grubbing occurred.

My previous site visits occurred on March 27 and June 15, 2017. I am seeing the environmental issues increase in number and in severity. Previous emails to Jay Porter, Senior Project Manager, Ministry of Transportation and Infrastructure have resulted in zero action on these matters. It appears that my previous email below has resulted in zero action on these matters as well. In my 15+ years of environmental monitoring and practicing erosion and sediment control, I have never come across a site that has such poor environmental management from the project managers, site managers, site contractors, and site environmental monitors. I would like to remind everyone that the introduction of sediment into fish bearing waters (Keith Creek flows into Lynn Creek) is an illegal offence under Provincial and Federal legislation. I would like to mention that I have had recent discussions with the office of MP Jonathan Wilkinson and have included him on this email. I have also included District of North Vancouver Mayor Richard Walton.

The above list represents a serious amount of site environmental exposure and can be rectified if managed properly. Due to the ongoing issues for this site that I have personally witnessed, I would like to propose that the Project retain a qualified environmental professional (such as myself, a Certified Professional in Erosion and Sediment Control (CPESC) with EcoLogic Consultants) to complete a thorough environmental audit of the site to avoid the likely environmental issues that I foresee occurring at the end of the summer once the season changes. Summer is the best time of the year to plan, properly site, install, and maintain erosion and sediment control structures, well before any serious rain events. There is still time to secure this site environmentally for the fall, winter, and spring rain events but time is running out.

Lisa,

I just visited the Hwy 1 / Mountain Highway interchange site. I observed literally hectares of exposed soil with not one erosion control structure on site (photos 0534, 0541, 0550). Weeks ago trees were cleared and stumps removed on the western slope on the approach down the Highway Cut. The soil is now at a state where it is at the greatest risk of erosion, and it has been raining all day.

The drop inlet sediment barrier (the the black slitted cap within the gravel, photo 0547) is what I visually estimate to be less than 0.1% of the total catchment area. Industry standards (such as the City of Coquitlam) has a 1-2% requirement. Sediment bags (in fact, filter fabric, not an industry standard anymore) over storm drain covers on Mountain Highway are clogged and have not been replaced since my last visit on March 27th even though I respectfully brought this to the attention of the site superintendent, Mike Farynuk (photo 0545). From what I can observe, I believe that this site drains into Keith Creek, a tributary to Lynn Creek.

Jay Porter (contact info at the bottom of this email) refused my March 2017 request for a site visit. I would like to formally request that the DNV (you or Richard) ask Mr. Porter for a DNV and EcoLogic site tour. If a tour is offered, I will ask the Squamish Nation if they would like to join. Summer is a great time to express the importance of erosion and sediment control and to have the installation, monitoring, and maintenance of control structures in place prior to the Fall and Winter. Thank you for your attention on this matter.

Lisa,

I visited the exterior of the Hwy 1/Mtn Hwy site today and took, again, some disturbing photos. Generally, the entire site is completely exposed to erosion when the next rain event occurs. Issues at site include the following:

1. Multiple storm drain covers that have street grates protected but curb grates are not protected (photo 0575).
2. Multiple storm drain covers that are either broken (photo 0583), clogged (photo 0605), or using improper/non-industry standard material (photo 0585).
3. Multiple storm drains that are in succession that are not filtering dirty water and sending it to an open storm curb grate (photo 0614).
4. Both site entrances on the south side of Highway 1 are armoured but are clogged with sediment with it being driven out on to the roads (photos 0602 and 0612).
5. Sediment (silt) fence is improperly sited and installed, and is blocking pedestrian access (photo 0581). Sediment fence is not used on steep ground. It is to capture slow moving sediment laden water on shallow slopes. I counted five different locations where the sediment fence is sited incorrectly and improperly installed.
6. An excavator is working directly beside Keith Creek (photo 0596). Is the excavator running biological friendly oils? The sediment fence is not an effective barrier against excavator fluid spills.
7. A fuel container is not in secondary containment and is at risk of machinery strikes as it is sited improperly (photo 0592).
8. The one route that I am aware of that is used to drain water from the site is now high and dry (photo 0600). I could not see where a sedimentation pond (an area to locate site water to allow sediment to settle out of suspension) is located.
9. Ground disturbance activities along Keith Road has resulted in piles of dirt left on the edge of the sidewalk (photo 0609) and is at risk of being transported onto Keith Road.
10. Poly sheeting that was placed in May has not been maintained and is presently torn and un-anchored (photo 0593).
11. Multiple slopes with minimal vegetation cover are not protected (photo 0590) and have been in this state since clearing and grubbing occurred.

My previous site visits occurred on March 27 and June 15, 2017. I am seeing the environmental issues increase in number and in severity. Previous emails to Jay Porter, Senior Project Manager, Ministry of Transportation and Infrastructure have resulted in zero action on these matters. It appears that my previous email below has resulted in zero action on these matters as well. In my 15+ years of environmental monitoring and practicing erosion and sediment control, I have never come across a site that has such poor environmental management from the project managers, site managers, site contractors, and site environmental monitors. I would like to remind everyone that the introduction of sediment into fish bearing waters (Keith Creek flows into Lynn Creek) is an illegal offence under Provincial and Federal legislation. I would like to mention that I have had recent discussions with the office of MP Jonathan Wilkinson and have included him on this email. I have also included District of North Vancouver Mayor Richard Walton.

The above list represents a serious amount of site environmental exposure and can be rectified if managed properly. Due to the ongoing issues for this site that I have personally witnessed, I would like to propose that the Project retain a qualified environmental professional (such as myself, a Certified Professional in Erosion and Sediment Control (CPESC) with EcoLogic Consultants) to complete a thorough environmental audit of the site to avoid the likely environmental issues that I foresee occurring at the end of the summer once the season changes. Summer is the best time of the year to plan, properly site, install, and maintain erosion and sediment control structures, well before any serious rain events. There is still time to secure this site environmentally for the fall, winter, and spring rain events but time is running out.

Lisa,

I just visited the Hwy 1 / Mountain Highway interchange site. I observed literally hectares of exposed soil with not one erosion control structure on site (photos 0534, 0541, 0550). Weeks ago trees were cleared and stumps removed on the western slope on the approach down the Highway Cut. The soil is now at a state where it is at the greatest risk of erosion, and it has been raining all day.

The drop inlet sediment barrier (the the black slitted cap within the gravel, photo 0547) is what I visually estimate to be less than 0.1% of the total catchment area. Industry standards (such as the City of Coquitlam) has a 1-2% requirement.

Sediment bags (in fact, filter fabric, not an industry standard anymore) over storm drain covers on Mountain Highway are clogged and have not been replaced since my last visit on March 27th even though I respectfully brought this to the attention of the site superintendent, Mike Farynuk (photo 0545). From what I can observe, I believe that this site drains into Keith Creek, a tributary to Lynn Creek.

Jay Porter (contact info at the bottom of this email) refused my March 2017 request for a site visit. I would like to formally request that the DNV (you or Richard) ask Mr. Porter for a DNV and EcoLogic site tour. If a tour is offered, I will ask the Squamish Nation if they would like to join. Summer is a great time to express the importance of erosion and sediment control and to have the installation, monitoring, and maintenance of control structures in place prior to the Fall and Winter. Thank you for your attention on this matter.
