Good morning Harbir & Parabhjeet Bains,

As you may know, we are currently in the process of reviewing the websites and social media presence of all perimeter seating bus licensees to ensure all advertising is compliant with the terms and conditions of the new special authorization licences, including Board approved rates and *Liquor Control and Licensing Act* compliance. Where we identify advertising that may contravene the terms and conditions of a licence, we will advise the licensee and ask that the website be revised. If the websites are amended without delay, no further action will be taken. Continuing to advertise services that are not in compliance with a licence may result in administrative fines or penalties.

While reviewing your website, <u>www.ritzlimos.com</u>, we found text that could reasonably infer that the consumption of alcohol in vehicles or by minors is permitted.

We are recommending that licensees avoid contributing to the misconception that alcohol is permitted in commercial passenger vehicles. As such, we want to draw your attention to the text bolded and underlined in the above attachment.

If you have any other related websites, please ensure all content is compliant.

Hi Deborah and Steve

As you know, a perimeter seating bus (PSB, seats 12 or more passengers, plus the driver) was involved in a fire in Vancouver's Downtown Entertainment District last night. The company and vehicle information has not yet been confirmed to me but here is what I can ascertain from the media photos and PT Branch records:

- The logo on the vehicle appears to be that of Silver Star Limousine Ltd. (Silver Star)
- This is <u>not</u> the same company involved in Chelsea James' fatality



- Silver Star has been a PT Licence holder since 2006 and the licence was last renewed in May 2017
- Silver Star is currently licensed to operate 10 limousines, including 4 PSB
- Silver Star operates a vehicle similar to that in the photos, a 2008 Ford F550, which can seat up to 20 passengers (this should not be released until confirmed)
- The Registrar has investigated one complaint against the licensee, related to rates, and has not issued any administrative penalties
- This is the same company whose passenger allegedly assaulted a VPD officer in 2016 when their PSB was stopped and officers tried to arrest a passenger following an incident at a restaurant earlier in the evening. Silver Star's vehicle was allowed to proceed with the remaining passengers once the arrests were made.

Hi, Kim. I spoke to Kirk, who suggested that you may be able to complete a research project for Kristin and I next week (due to Kristin November 20). In each case, please design a succinct chart that outlines what's noted below. A version of each will likely be appended to a briefing note we are preparing for the minister.

- An inter-jurisdictional scan of the rules/laws specific to party buses in Canada (earlier we found AB SK and MN), and any US states that jump out at you (we found California). Laws may be alcohol-related, or methods for monitoring the safety of passengers (the driver can't really do that effectively while driving). Enforcement is also a challenge ... so any information on enforcement methods and their success would be helpful (e.g. random inspections, routine inspections, etc.).
- An incident scan (via the media) for the last five years focusing on Canada, but perhaps including examples of US incidents. Show what happened (e.g. death or injury), what they did about it (beefed up laws, inspections, enforcement, etc.), and how things are working for them now.

Proposed response:

- I am aware of a party bus catching fire on Saturday night in downtown Vancouver.
- I'm relieved to hear there were no injuries in this incident.
- The Vancouver Police Department and the Vancouver Fire Department are the lead investigating agencies. Once they have identified the company and vehicle involved CVSE and PTB will have more information to provide about the company's safety record.

If asked – I understand the company is called Silver Star Limousines – what can you tell me about their record?

It is important that we let Vancouver Police and Vancouver Fire proceed with the
investigation – they still need to confirm the company and vehicle involved. Once we
have confirmed this information, we can provide more information on their safety
record.

Is this the same company that was involved in Chelsea James' death?

No. That company was called Silver Lady. This is a different party bus company.

Regarding this accident- why can't the family of the victim get answers on whether or not the driver paid his fines?

- This was a very tragic situation and my heart goes out to the family of this young woman who lost her life at such a young age. I certainly understand and respect the family's need for closure.
- In terms of the investigation, our CVSE branch worked closely with the Vancouver Police Department and provided as much information as possible to assist them with this case.
- As the Premier said on Friday, it is unacceptable that the family can't find out if the
 driver has paid his fines. I agree with the Premier and I'm certainly committed to
 working with the family to get an answer to their questions.

What have you done to improve safety in this industry?

- In 2015, we strengthened the licensing regulation for limousines with perimeter seating to ensure increased safety and enforcement of these vehicles and making operators more accountable.
- Licensees have to display their Passenger Transportation licence plate and decal on every vehicle, allowing us to monitor individual vehicles in each fleet.
- This enhanced regulation of the industry has allowed government and police to better enforce the industry and motivate operators to provide a service that is safe and compliant with provincial laws.
- Consumers, especially those booking trips for minors, are encouraged to look for licensees that advertise strict policies related to drinking in vehicles.
- To raise awareness of liquor laws in B.C., the ministry distributed over 900 decals to licensed limousine operators for display in their vehicles, reminding passengers that

consuming alcohol in any vehicle is illegal in B.C.

What about chaperones on party buses? How will that improve safety?

- I agree that more can be done to improve safety in the industry.
- I'm committed to looking at enhancing regulations possibly looking at more robust vehicle inspections and look at the requirements set out for operators.
- My ministry will continue to monitor the industry to see if our current regulations go far enough.
