Yes. To be clear: the project was headed by Glenn Sigurdson's CSE Group under contract to the City of Vancouver. They are mediation specialists.

Glenn brought me in at the end of the process, on a sub-contract, to try and clear the log-jam - they had spent most of the year settling on rules of engagement. There was unfortunately little engagement on the key issues, so that the deliverable posted with Council ended up being the discussion paper I had provided.

The discussion paper explicitly had no recommendations (it says this at the beginning and the end). As per the title, it is a "Framework for Choice".

It identifies issues and options for discussion.

The present work includes hearing the BC industry intelligently on what they want and are willing to consider, and providing the government with an analysis and policy considerations. I should also note that this industry is extremely fast moving as business models of commercial ride-share companies evolve - thus the 2015 paper is good start for discussion, but there are more and different options and considerations today. Recent events, such as London England's threatened revocation of Uber's license, and Uber's current dispute with Quebec, are also material.

Each jurisdiction has a different history, and different preferences. Thus a "made-in-BC" solution is a real thing: communities must make their own, informed, choices. I hope we can help that process.

Does this provide what you needed?
