Good afternoon,

I met with Mainroad and Tower fencing this morning to discuss the details of the new fencing installation, scheduling and traffic management.

The fencing materials were ordered 2 weeks ago but take 6 weeks for delivery. Therefore **we will be starting installation on January 13th** and it should take up to 2 weeks (weather dependant) and be completed by January 24th. Similar to what we allowed during the Leigh Road interchange project they are permitted to have a **NB** (outbound) fast lane closure from 7AM to 2PM and a SB (inbound) fast lane closure from 9AM to 5PM


Start and End points have been tweaked as well. We will be starting approximately 100m north of the grass median at Millstream. This is to maintain the option in a major incident event to remove barrier and have an opening wide enough that all traffic can redirected to the NB or SB lanes. The fence will end approximately 100m south of the Leigh Road bridge structure.

Mainroad will be putting up CMS signs starting January 2nd for advance notice of the upcoming work.

Also as part of this project I will be seeking approval to relocate the 80km/h posted speed limit 370m to the south for NB traffic and relocate the 90km/h speed limit 1km to the north for SB traffic.



I've gone through our count sheets to see how many additional pedestrians may be crossing further east of McCallum (as we noted all pedestrians). It seems like there could be an additional 5-10 pedestrians crossing the highway out of the line of sight. Next round of counts may be best done on each interchange bridge (will have to check lines of sight).

As a bonus we did a vehicle count at the north Leigh Road interchange intersection (since we were out there and had the time) yesterday afternoon. I will summarize it and provide a comparison to the projections for interest.


