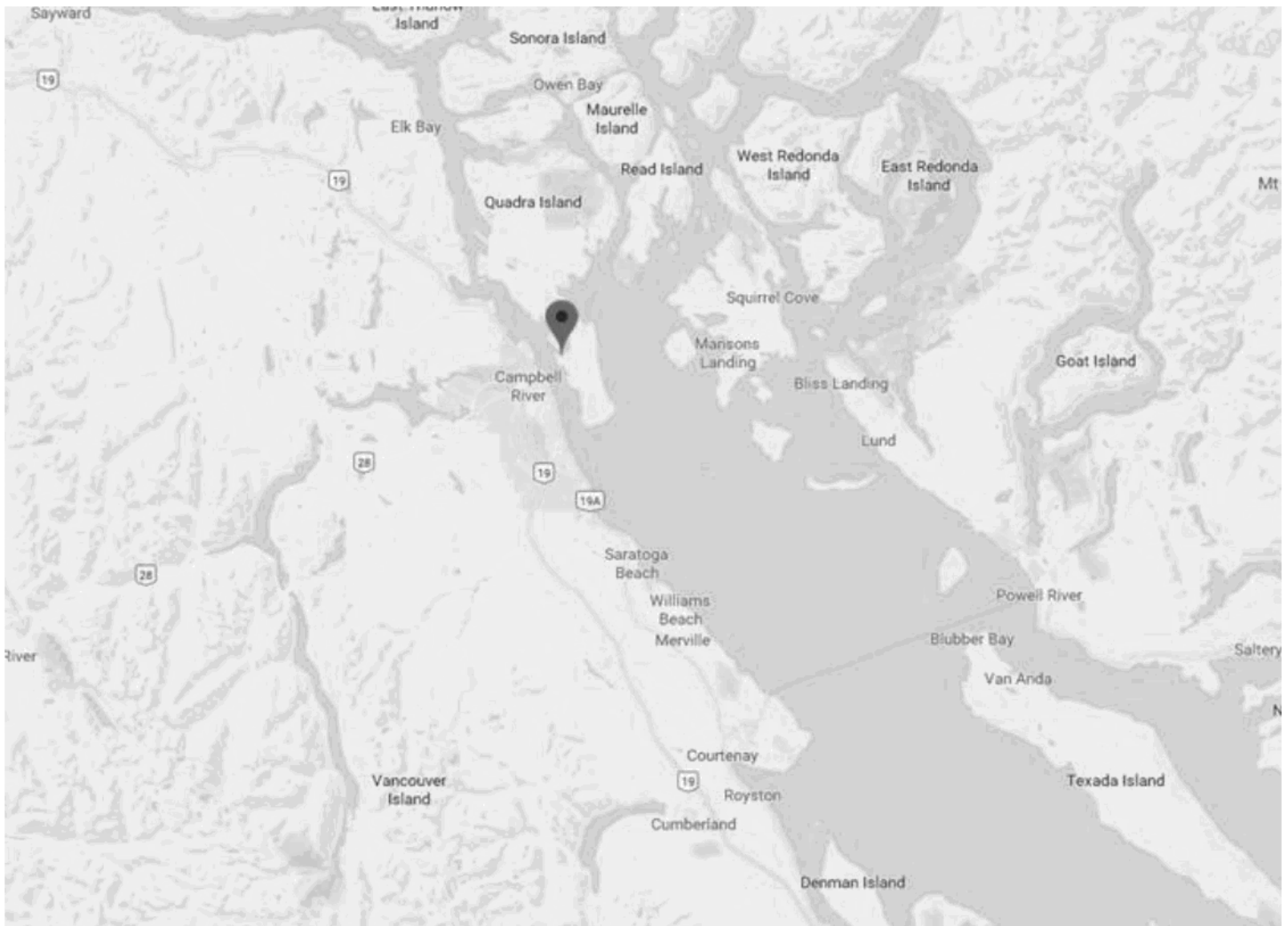

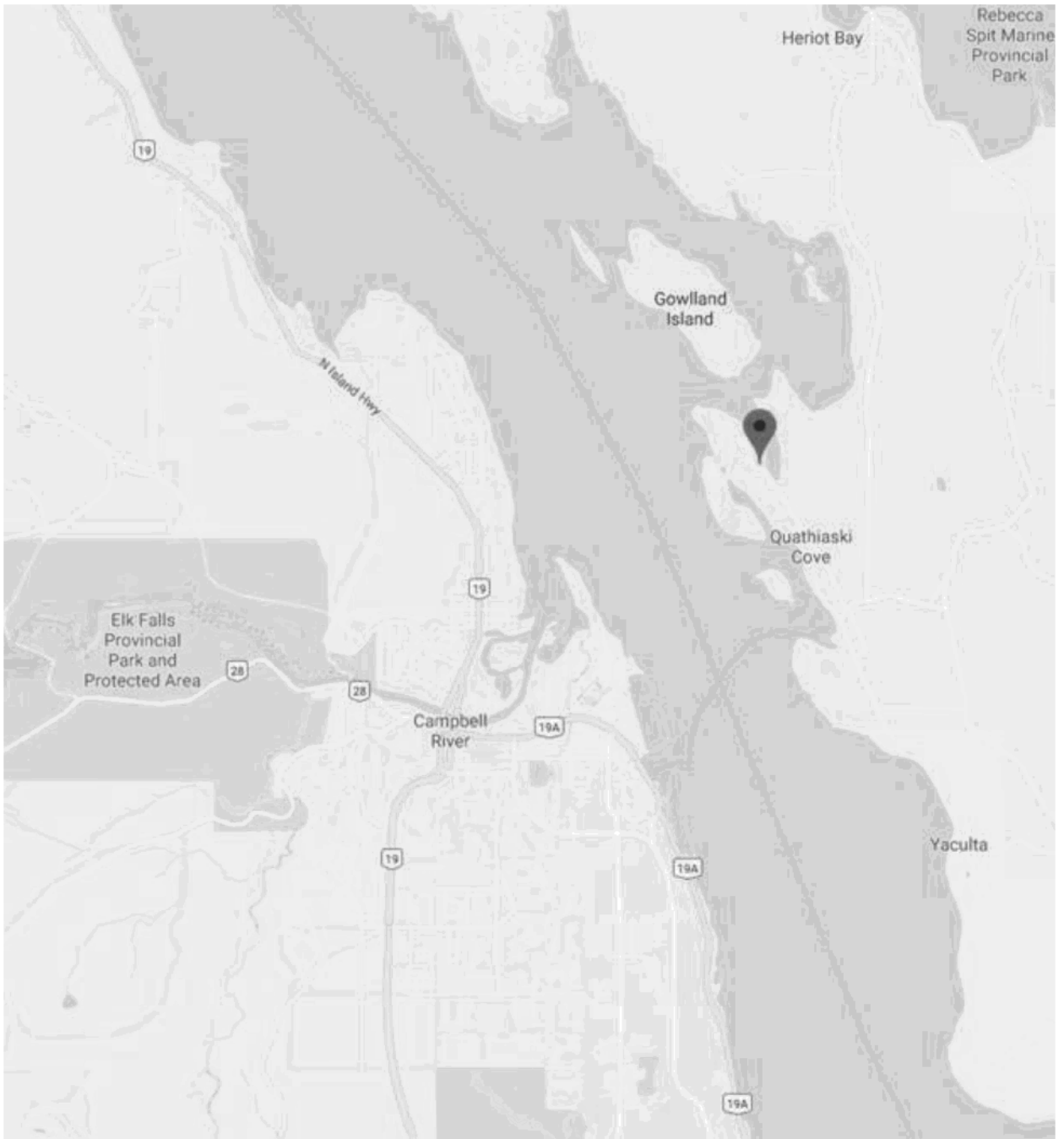

Subject: Avalanche Documentary

Dear Katie,

I'm writing from UK based production company Caravan Media. We have been commissioned by the British Broadcasting Corporation to make an hour-long documentary for the BBC's flagship science series, Horizon. The documentary will also air on PBS/Nova in the US and likely around the world through BBC worldwide distribution. Discussions with potential Canadian broadcasters are on-going. Within the documentary we will be looking at all aspects of avalanche science and we want to do this by working with a team of 5 or 6 scientists and avalanche control experts to trigger an avalanche. We plan to study this avalanche using the latest monitoring techniques (Doppler Radar, Lidar, Thermal Imaging) to reveal what is happening inside the avalanche as it moves. We will be looking at the human aspects how avalanches are triggered, what to do if you're caught in an avalanche and how to survive. We will investigate the latest thinking on avalanche prediction particularly the study of weak layers and how they form.

In addition to the sequences mentioned above we are also hoping to place a car and crash test dummies rigged with accelerometers and pressure sensors in and avalanches path. Across North America the danger posed to motorists is well understood; annually millions of dollars are spent protecting highways and yet there is surprisingly little data on what happens to a vehicle and its occupants when it is hit by an avalanche. One of the key contributors on this project is a chap called Jordy Hendriks (biographical details below). Jordy has previously published several scientific papers on this subject and is aiming to publish further work based on this experiment.

I'm writing to ask whether this is a project the Ministry of Transportation and Infrastructure would be interested in being involved in? We believe it's a great opportunity to draw attention to the hazards of driving in avalanche terrain and the importance of avalanche control work.

Specifically, I would like to explore whether it might be possible to place our car in the path of an avalanche triggered by a team doing avalanche control work to protect the highways? We're keen to

feature the important work these crews do and we believe this could be a great way to showcase this and conduct a valuable scientific experiment.

Given the need for favorable conditions we plan to be on standby to film this avalanche from 19th Feb through to the end of March. Upon a favorable forecast we will mobilize in 1-2 days.

Overall, this project presents a unique opportunity to illustrate the dangers posed by avalanches to an international audience and for the scientists to gather invaluable data. Jordy won't be the only one to incorporate the findings from this experiment into published work - It is anticipated that the information gathered from this experiment will feed directly into the publication of peer reviewed work by all the scientists in the months after filming.

Previously Jordy has published work on avalanche risk equations these require parameterization of the probability of death for occupants of a vehicle hit by an avalanche (Hendrix and Owens, 2008) In these equations this value is typically fixed and is based on historical accidents (eg Margreth et al., 2003. Our experiment will be a continuation of this work and is an opportunity to gather real time data that will be used to validate and update existing risk equations.
