Hi Carlene,

So I made the final call yesterday to confirm timings for the hospital openings. We can't wait any longer – there were some challenges with MLA schedules. But, the scheduling below works around those challenges. So – times are now firm. I have confirmed these with the PO, Min Trevena and MLA Leonard's offices.

- Comox Valley opening is scheduled for 1pm on Tue 14 Nov, with Premier Horgan and not Minister Dix. MC'd by MLA Leonard. Presentation (posthumous) to Gwyn Frayne, CFQHC leader.

In terms of event planning beyond the communications pieces, can you advise who it is in the Ministry who should be involved? Perhaps we should have a phone meeting to look at the list of tasks and determine who takes responsibility for each piece, and liaises with the each of the members' offices, -- a timeline, priorities, etc? Is there an event planning tool/protocol available to guide this process?

Let me know your thoughts re next steps so that we are well-coordinated and not duplicating efforts or overlooking priorities.

RE: Forestry Land use Plan for the Discovery Islands

Dear Sir,

Thank you for accepting the offer to meet with tourism representatives from the Discovery Islands Tourism/Forestry Working Group (as requested by our MLA, Claire Trevena, Minister of Transportation and Infrastructure).

The Working Group was formed with the financial and political support of your predecessors, Liberal FLNRO Minister Steve Thomson, and JTSK Minister Shirley Bond. While in government, the aforesaid Ministers had hoped to create a tourism/forestry working group model which could be applied to other regions of BC where conflict between tourism and forestry exists. The forest industry was instructed to cooperate and work with tourism businesses to decrease the impact of clear cuts in high value scenic corridors within the Discovery Islands. Cooperation on the part of the forest sector was voluntary however, some licencees did not to participate at all.

After 4 years of meetings with the forestry sector, outcomes have fallen well short of our expectations. While there have been some successes, many important viewsheds remain highly vulnerable and will be seriously impacted over the next few years. Despite modest requests from tourism, most forest licencees have not been forthcoming with significant reductions in VQO (Visual Quality Objective) impacts.

The Discovery Islands are British Columbia's second most valuable wilderness tourism destination (after Tofino/Pacific Rim). Tourism revenues in 2017 are expected to exceed sixty million dollars, employing over 1200 people full time or seasonally full time. Resort, lodge, and marina infrastructure is capitalized to about 1/2 billion dollars. In terms of revenue, taxation, and employment, tourism here greatly exceeds that of the forest industry and requires support from your Ministry to ensure sustainability and growth.

Over the last decade we have seen a significant return of Humpback whales making the Discovery Islands a premier whale watching destination. Last summer, more than 50 Humpbacks and two pods of Orcas frequented our waters enabling many operators to guarantee whale sightings on tours. Whale and wildlife watching tours alone contributed about ten million dollars to the local economy. This sector is expected to grow significantly in the coming years, yet the scenery along whale watching corridors is being compromised by logging.

Discovery Islands communities are not forest industry dependent economies. Tourism and retirement are the key economic drivers today. Thirty years ago, provincial tourism revenues were one quarter the size of the forest industry. Today revenues are equal to, or exceed the forest industry at 17 billion dollars. Despite the high contribution of wilderness tourism to the provincial economy, we are still being treated as bystanders when it comes to managing the forests upon which we depend.

We have suggestions to ensure the Discovery Islands Tourism/Forestry Working group is better able to protect high value scenic corridors without excessively impacting the forest industry.

Members of our group are generally available for a meeting throughout the Fall. November 22nd or 23rd are dates when some of us will already be in Victoria if that works for you.

Below is a copy of the letter from Minister Farnworth to our constituent regarding the matter:

"Dear _____

Thank you for your email dated September 23, 2017, in which you share your concerns regarding road safety and raised the topic of enforcement of loud vehicle noise.

I appreciate the concerns raised by communities and individuals around the province about the annoyance caused by excessive noise from motorcycle exhaust pipes. As you are aware, the Province of British Columbia prohibits both loud exhaust noise and modifying exhaust systems under the *Motor Vehicle Act Regulations*.

Under the *Police Act (BC)*, the Minister of Public Safety and Solicitor General must ensure that an adequate and effective level of policing and law enforcement is maintained throughout the province.

As the Minister of Public Safety, I am responsible for setting the objectives, priorities, and goals of the Provincial Police Service however, the day-to-day deployment of policing falls to the police of jurisdiction. Individual investigations and enforcement decisions, such as the ones you describe, occur at arm's length from government and I cannot interfere with or direct police on such matters.

I understand that the Regional District of Central Kootenay (RDCK) wrote to the Province regarding the petition mentioned in your email, and that the Minister of Transportation and Infrastructure at the time advised the RDCK to contact the local police force regarding their concerns. For the reasons outlined above, I can confirm that the most appropriate point of contact to discuss the issue of loud exhaust noise enforcement in the local area is the East Kootenay Traffic Services RCMP. Good Morning Brenda,

I am also getting quite a few inquiries about Kuhushan Road. The resolution to this situation is dependent upon the Strathcona Regional District, they need to decide how they wish to proceed. There are two options:

1. The SRD consult with the Agricultural Land Commission to construct a trail on Kuhushan Road and then apply for a permit through the Ministry of Transportation
2. The SRD work with ^{s.22} and the Ministry of Transportation to close the Crown dedication on Kuhushan Road, thus removing it from the Crown, and undertake a land swap for the land on which the existing historic trail passes through on the ^{s.22} property

It is up to the SRD to determine how they would like to proceed, to date I have not received any indication from the SRD on how they wish to move forward.

Throughout the CVRD and SRD there are land dedications that have not been constructed and never will be constructed as roads - the intent is not to have a constructed road it is to give the public the opportunity to access water (to ensure all the waterfront land is not sold off during development providing no means for citizens to access waterbodies).

The Ministry of Transportation does not construct trails, this is driven by local government - there a lots of examples where the SRD and CVRD have built trails on unopened dedication to provide the public with access to water.

This situation is exacerbated by the fact that Kuhushan Road runs through the middle of an active farm within the ALR which means the ALC must be consulted.

Hi, Anne. I have been getting enquiries regarding public access to Kahushan Road. I believe that you have advised that the Regional District would need to apply to the ALC to get a right-of-way for a trail and then MOTI would need an application to approve the "trail." However, my understanding is that Kahushan Road is not a "trail," it is an already-created public road right-of-way, which I assume was dedicated when sub-division occurred. When sub-division is granted, MOTI demands public road access....However, it now appears that the sub-division occurred, but the road access has not. I don't know how this is rectified....perhaps, consolidation of the main parcel to remove the 11-parcel sub-division?

Also, the actual traditional trail has existed for more than 50 years and I believe that it pre-existed any local government or MOTI existence and should not have to be "re-established" as a

new trail through a myriad of bureaucracy amongst the regional districts, MOTI and the ALC. IT IS AN ESTABLISHED, HISTORIC PUBLIC TRAIL AND HAS EXISTED FOR MORE THAN 50 YEARS.

The public are becoming really angry and will be demanding their rightful/lawful access and this matter will be top of my priority list to discuss with the new Provincial Government once they have been sworn in.

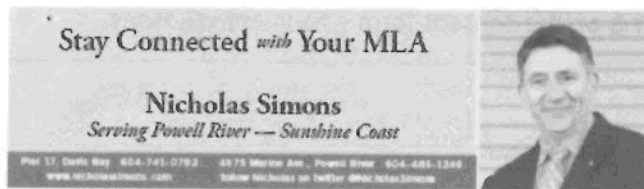

Thanks for your patience, I wanted to touch base with the project's Geotechnical Engineer before responding to your questions.

As part of the Mountain Highway Interchange design, geotechnical investigations were conducted and summarized in the Preliminary Geotechnical Recommendations 2015 (Thurber) and Geotechnical Design Report 2016 (Golder). In general they found that the project site is relatively competent (compact to very dense), and soil deposits exist within close proximity to the ground surface which provide a solid base for construction. The soil conditions are not considered highly susceptible to general construction vibration effects, particularly since the construction activities do not require significant energy input (such as pile driving or ground densification). As such, any construction vibration effects generated were expected to be comparable to other common road improvement projects. Also, significant construction activities were conducted from June to November 2016 with the only access used being adjacent to 8th Street, during this work we did not receive any vibration complaints or concerns from nearby residents. Some vibrations beyond that of a road improvement project typically cannot be avoided and these vibrations do not generally exceed commonly accepted damage thresholds. That being said I should note that we have not received, nor am I aware of, other vibration concerns due to construction by Lafarge from other residents.

Moving forward I propose the following action items:

- First I will remind the contractor of your concerns and request that construction activities adjacent to your residence which may cause excessive vibrations be avoided or relocated where possible.
- Second I will investigate whether a vibration monitoring program can be used to determine whether other factors may be amplifying the vibrations at your residence. Monitoring of your property would require your approval and the results would be shared with you.

WSP works for the Ministry and not the Contractor and any damages caused by construction will ultimately be submitted to the Contractor's insurance provider. The Contractor's responsibility is to minimize construction vibrations where possible and as a homeowner you are to record damage you feel has been caused by construction. Should you choose to submit a claim once construction is complete you can do so at <http://www.th.gov.bc.ca/forms/getForm.aspx?formId=675>. When a claim is submitted the Contractor's insurance adjustor will then contact the claimant to start the review process.

I agree with you that the Pre-Construction Condition Survey heading is misleading and I will request that it be changed. I will also review the survey to ensure it serves as a professional record of observations and facts only. It should not include opinion based comments from either the individual conducting the survey or the homeowner.

I hope these measures will begin to help address some of your concerns and that we are able to take further steps in reducing any potential impacts to your property."

Good Afternoon Lynne,

My name is Scott Maxwell, I am the Northern Regional Director for Highways, Courtney Hayre forwarded me your questions from earlier today that I'm happy to answer for you below.

1. Nass River Bridge on Highway 37N - is it getting improvements or being replaced?
 - Yes., the Nass River Bridge replacement is in development and nearly ready for tender, it will be a modern two-lane structure. We are currently working on the final touches of the contract and we are expecting to tender it early in the new year. It is scheduled to be a two year construction window, completing in 2019.
2. Are there any plans for highway improvements on Highway 37N in the Iskut/Dease Lake area?
 - Yes, we are scheduled to complete about 100km of sealcoating on Highway 37N in 2018 on the following sections:

- H37 Cranberry #1 Bridge to Brown Bear, H37 Good Hope Lake Av. Gate to Boya Lake, and H37 Wheeler Lake to Yukon Border

- This may change slightly as our program evolves over the winter.

3. Are there any plans for Wifi rest stops on Highway 37N in the future?

- We do not have any current plans to add Wifi to our Hwy 37N rest areas. Wifi technology is heavily reliant on cell coverage or land line availability; unfortunately, for significant portions of Highway 37N, we don't have either. However, the technology is improving all the time and we are certainly interested in adding Wifi in areas such as this where the lack of cell coverage increases the value of having Wifi at our rest stops.

If you or the local MLA office have any further questions, or follow up to any of these questions; don't hesitate to get in touch with myself or Carl Lutz, our local District Manager who I've cc'ed on this email.

 - Yes., the Nass River Bridge replacement is in development and nearly ready for tender, it will be a modern two-lane structure. We are currently working on the final touches of the contract and we are expecting to tender it early in the new year. It is scheduled to be a two year construction window, completing in 2019.
2. Are there any plans for highway improvements on Highway 37N in the Iskut/Dease Lake area?
 - Yes, we are scheduled to complete about 100km of sealcoating on Highway 37N in 2018 on the following sections:
 - o H37 Cranberry #1 Bridge to Brown Bear, H37 Good Hope Lake Av. Gate to Boya Lake, and H37 Wheeler Lake to Yukon Border
 - This may change slightly as our program evolves over the winter.
3. Are there any plans for Wifi rest stops on Highway 37N in the future?
 - We do not have any current plans to add Wifi to our Hwy 37N rest areas. Wifi technology is heavily reliant on cell coverage or land line availability; unfortunately, for significant portions of Highway 37N, we don't have either. However, the technology is improving all the time and we are certainly interested in adding Wifi in areas such as this where the lack of cell coverage increases the value of having Wifi at our rest stops.

Here is what I received back to my inquiry. Let me know if you need further – or more specific- information.
Lynne

The MVA does not provide any express guidance on the use of mobility scooters on public streets and sidewalks. Also, the MVA does not provide any guidance on the use of bicycle lanes.

If one assumes that a mobility scooter is a “mechanically propelled invalids chair”, for which there is no definition or rules but which may be reasonable to assume, then we get to s. 119 which provides a definition of “pedestrian”:

“pedestrian” means a person afoot, or an **invalid** or child in a **wheelchair** or carriage

If we equate motorized scooters as pedestrians, we then get to s. 182 which reads:

Pedestrian walking along highway

- 182** (1) If there is a sidewalk that is reasonably passable on either or both sides of a highway, a pedestrian must not walk on a roadway.
- (2) If there is no sidewalk, a pedestrian walking along or on a highway must walk only on the extreme left side of the roadway or the shoulder of the highway, facing traffic approaching from the opposite direction.
- (3) A person must not be on a roadway to solicit a ride, employment or business from an occupant of a vehicle.
- (4) Except for a person who solicits a ride in an emergency situation, a person who contravenes this section commits an offence.

S. 182 contains the rules for pedestrians that go to the heart of the MO’s request.

A bicycle lane is part of the “roadway” (although the MVA does provide any guidance for the use of a bicycle lane), and not for use by pedestrians.

I submit our response should be the following:

“The *Motor Vehicle Act* sets out the rules of the road, including guidance for pedestrians for the use of roadways and sidewalks. The ministry is aware of the growing interest of the public with respect to the use of motorized personal mobility devices and how the Act impairs the use of these devices. We are assessing their operation to consider how we might be able to accommodate their use on roadways, bike paths, bike lanes and sidewalks. As the popularity of these vehicle types increases, safety is the ministry’s primary concern.

For reasons of personal safety, users of mobility scooters should avoid use of the roadway and bicycle lanes where a sidewalk is present.”
