**Request**

We are talking to the mayor of Port McNeill on Monday afternoon about Western Forest Products. s. s.16  
Is the ministry acting on or looking into the concerns Shirley Ackland expressed regarding the increase in logging truck traffic?



The mayor wants the Province to step in and oversee regulation of logging trucks on public highways. Is this something being considered?

### **Background**

Mayor Auckland was on CBC yesterday and there was nothing specific regarding MOTI, just that the top concerns are safety on the highway, and that the Mayor had talked to the Minister.

Previous statement to CBC from December 2017:

"I had a good meeting with Mayor Ackland yesterday where we discussed our shared concern of ensuring safety on Highway 19 with the increase in truck traffic. I am aware that, since last spring, logging truck traffic has increased by roughly 40-60 vehicles per day on Highway 19 and nearby side roads north of Campbell River, and the decision by Western Forest Products to move away from rail and use logging trucks will further increase this traffic. These vehicles add more wear and tear on our roads and on our highways, and I am aware of the concerns being raised in communities along these roads.

"Ministry staff are closely monitoring these routes and are adjusting the maintenance work schedule to address areas that need it the most, including increasing the grading work we do on sections of the gravel side roads. We are also working to identify potential future road and maintenance improvements and working with the industry and companies to identify potential future road improvements over the long term. In addition, we are refocussing our Commercial Vehicle Safety Enforcement resources to monitor and enforce provincial standards and to make sure all commercial trucks operating on these highways and side roads meet all safety requirements.

"We are committed to making British Columbia's highways and roads as safe as possible, and the transportation network on northern Vancouver Island is an important part of connecting North Island communities, moving goods, and providing access for tourists and others who visit this beautiful part of our province."

It was a pleasure hosting you and your colleagues in the NDP Caucus at the annual ARA Caucus luncheon the ARA sponsored on April 18 in Victoria. I want to thank you again for taking time out of your busy schedule to attend and meet our Board members and staff. The ARA always find these events helpful in keeping in contact with our elected officials and we appreciate the opportunity to express the critical issues facing our industry that the government can be instrumental in assisting us to resolve.

While at the luncheon, you spoke with Mitchell Martin (ARA Towing Division Chair and owner of Mitchell's Towing) and Ken Hendricks from my office. They asked about your thoughts on the advocacy briefing we sent you several months ago. In the briefing we are asking for our government's support for an amendment to Division 4:28 Flashing Lamps in the *Motor Vehicle Act Regulations* to allow tow trucks to be equipped with flashing blue and white lights in addition to amber lights. We strongly believe that these lights will assist in keeping tow operators safer on BC roads. Since we sent our briefing several months ago, we have had a report of another incident that nearly caused the death of one of our operators. Other provinces are already taking adopting these changes in their own legislation and it is our sincere hope that the BC government will do the same, potentially saving the lives of hard working BC tow operators.

I would be pleased to provide any further information you may require and to travel to Victoria to meet with you at your convenience if that will assist you and your staff in your review and decision.
